Sub : Status Report on Reconciliation of Departmental figures with those booked in A.G.'s office for the quarter ended 30th June, 2023.

Sir,

In inviting a reference to this Office letter No. TMC/3-3/VERFN/2023-24/425 dated 26/09/2023 on the subject cited above, I am to state that, **out of 58** Chief Controlling Officers (CCOs) **16 (sixteen)** CCOs have carried out reconciliation of expenditure **fully**, **22 (twenty two)** CCOs have carried out reconciliation of expenditure **partially**, **20 (twenty)** CCOs have **not** at all reconciled the departmental expenditure figures and on the **Receipt** side, **6 (six)** CCOs have reconciled the receipt figures **fully** and **3 (three)** CCOs have carried out reconciliation of receipt **partially**, **49 (forty nine)** CCOs have not at all reconciled for the quarter ended 30th June, 2023. A detailed list showing the position of reconciliation is enclosed herewith, in **ANNEXURE-I**, for ready reference.

2. From the position explained above, it may be seen that most of the CCOs have not taken up the issue of reconciliation in full earnest. The Government is, therefore, requested to issue necessary instructions/orders to all the Chief Controlling Officers to carry out the reconciliation work for the next quarter ended September, 2023 (FY 2023-24), to ensure cent percent reconciliation and correctness of the accounts prepared by this office.
