CIRCULAR NO WM-I/03 DATED 03.06.2021

As per Hqrs. Letter No. 143/03-Exam/Exam-I/2021 dated 01.04.2021, Examination-I IE/CPD-2021 is scheduled to be held from 14<sup>th</sup> to 19<sup>th</sup> June-2021. **Applications are invited from eligible candidates for the following examinations.**

**A. SAS Examination-Civil Accounts/Civil Audit stream**

Existing candidates/Fresh candidates who have completed 2 years regular service as Divisional Accountant, Divisional Accounts Officer-II ,who have completed probation as on 1/3/2021 and the mandatory Pre-examination training are eligible to appear in the SAS Examination 2021. The time limit for passing the SAS Examination will be **Eight Years** considering two Examinations in a year (8 year for 12 chances). The six additional chances are not consecutive as earlier.

A maximum number of Six attempts would be available to the candidate (whether departmental or directly recruited) to pass these examinations. As per Hqrs office Circular No. 11 of 2020 issued under letter No. 75/03-Exam/addl. Chance/2016 Vol. I dated 19.10.2020, the candidates who have exhausted six chances in SAS examination and cleared at least five papers will be given additional six chances which is not consecutive. Those who have already exhausted ten chances will be allowed two more chances from next SAS Examination-I and has to avail these two chances within two years i.e. four Examination (counting from Examination-I of 2021).

**B. Incentive Examination**

The Incentive Examination will also be consisting of objective type papers. Divisional Accounts Officer-Grade-I who have put in one year continuous service in the grade as on the 01.03.2021 and all Sr. Divisional Accounts Officers who did not appear in this examination or could not clear the said exam while working as DAO-Gr-I are also eligible to appear/reappear in the examination. *Officials who have already exhausted six chances are allowed two more chances and have to avail the two chances within four examinations counting from Examination I of 2021.*

**C. CPD-I**

All Sr. DAOs are eligible to appear in the Examination-I of CPD-I Exam of 2021, DAO-I would be eligible to appear in the same only after completion of their four years continuous regular service as on 01.03.2021. *Officials who have already exhausted six chances are allowed two more chances and have to avail the two chances within four examinations counting from Examination I of 2021.*

#### **D. CPD-II**

All those candidates who have successfully completed 4 years of regular service as on 01.03.2021 after passing the CPD-II Examination are eligible for the Examination-I of CPD-II Exam of 2021. *Officials who have already exhausted six chances are allowed two more chances and have to avail the two chances within four examinations counting from Examination I of 2021.*

Such of the eligible candidates who intend to appear in the Examination-I of SAS/IE/CPD-I, II & III examination 2021 may submit their duly filled applications in the prescribed proforma (enclosed) and mail the same to [ag-ahmd-guj@nic.in](mailto:ag-ahmd-guj@nic.in) by 04.06.2021. Candidates should clearly mention the medium of examination i.e. Hindi or English in the application proforma. Candidates should clearly mention in the application form whether they intend to appear in Group-I, Group-II or both the group of Examination-I of SAS Examination 2021. Candidates applying for IE and CPD-I/ or CPD-II/ CPD-III Examinations must submit separate application forms and should clearly mention the name of examination in the concerned application form.
