SAS/RA/I/CPD-I, II & III Examination – 2 of 2025 is scheduled to be held from 28th January to 1st February 2026. The online registration for the same shall commence from 22/12/2025 and will end on 02/01/2026. The registration will be opened to the candidates who have been exempted/already qualified the Preliminary Examination and belong to offices where vacancies are available as well as existing departmental candidates & all DRAAOs for SAS Exam-II of 2025 & all candidates (fresh/existing) for RA/Incentive/CPD-I, II & III Exam-II of 2025.

2. First Part of the Registration Form containing basic data i.e. Name, Date of Birth, Category etc. as mentioned in the Service Book in respect of new candidates will be entered by the office. Thereafter, the fresh candidates and the existing candidates will complete second part of the registration form including uploading of Photo and Signature after activation by the office. The eligible candidates may submit their completed applications (in the enclosed format) by 26th December, 2025 (Friday) to the Confidential Cell after verification with Service Book. Incomplete applications and applications received after the last date will not be entertained. The chance of a candidate would be counted once she/he registers and there is no scope for withdrawal. The cut-off date for eligibility for the examination is 1st September, 2025.
3. The officials who are on deputation to other offices within the department may submit their applications directly to this office under intimation to Administration Section of the borrowing offices. Such candidates will make all examination related communication with this office directly for timely completion of registration process/other examination related issues.
4. All intending and eligible candidates are requested to visit the examination circular module available in the CAG website to acquaint themselves with the registration process.
