Office of the Accountant General (Audit-II), Odisha. Bhubaneswar intends to dispose of the office staff car on 'as-is-where-is-Basis'. The details of the vehicle are as below:

- 1.Accordingly, sealed quotations in the prescribed format are invited for the disposal of above vehicle on the terms and conditions mentioned below. The intending purchasers are requested to send their quotations in the enclosed proforma addressed to the Sr. Deputy Accountant General (Admn), O/o the Accountant General (Audit-II), Odisha, Bhubaneswar, in a sealed cover latest by 3:00 PM on 28/10/2022. The cover should be prominently superscribed as 'QUOTATIONS FOR PURCHASE OF CONDEMNED VEHICLES'. The vehicles will be available for inspection on all working days from 17/10/20220to 21/10/2022 between 10:00 AM to 05:00 PM.
- 2. The quotations received in time will be opened at 3:30 PM on 28/10/2022 in the chamber of Sr. Deputy Accountant General (Admn). O/o the Accountant General (Audit-II), Odisha, Bhubaneswar. The tenderers or their representative (not more than one) may be present, if they so desire at the time of opening of quotations.
- 3. The Sale will be governed by the following terms & conditions: i) The tenderer is required to pay Earnest Money of Rs. 10,000/-.
- ii) Earnest Money is payable in the form of Demand Draft/ Bank Guarantee from any Nationalized Bank in favour of Sr. Audit Officer/Cash, O/o the Accountant General (Audit-II). Odisha, Bhubaneswar '. Quotations received without Earnest Money will not be considered and shall not be accepted. The Earnest Money will be returned to unsuccessful tenders at the earliest. The Earnest Money will be returned to successful tenderer, after getting the payment in cash in full from the tenderer and finalization of sale and will not be adjusted against the offered bid value.
- iii) The bidders will not be allowed to withdraw their bids and if they do so their earnest money will be forfeited.

- iv)Payment in full will have to be made by the successful tenderer in eash or in the form of Demand Draft from any Nationalized Bank in favour of "Sr. Audit Officer/Cash, Olo the Accountant General (Audit-II), Odisha, of "Sr. Audit Officer/Cash, Olo the Accountant General (Audit-II), Bhubaneswar" before taking delivery of the vehicles within two working days from the date of acceptance of the offer.
- v)The delivery of the auctioned vehicles will be taken, only after the successful tenderer submits documentary evidence in support of residential status (Aadhar Card/Voter Identity Card/Passport/Driving License or any other valid proof of address in case of individual and Registration Certificate in case of firms etc.).
- vi) The successful tenderer must remove vehicle within two working days from the date of acceptance of the offer by this office, failing which penalty of Rs.200/-(Rupees two hundred only) per day will have to be paid. If the vehicle is not removed within ten days from the date of auction, the earnest money will be forfeited and he will have no claims over the vehicle, whatsoever.
- vii) The successful tenderer will make his own arrangement for transport and he will not be entitled to claim any facilities or assistance for removal or transport of vehicle from this office.
- viii) The vehicle will be sold strictly on 'as is where is basis'. Vehicle is sold on the assumption that tenderer has inspected the vehicle and they know what they are buying, whether they have first inspected them or not. No complaint will be entertained after the sale.
- ix) If this office feels that the highest rates offered by the tenderer are not reasonable, the sale of the vehicle by calling quotations will be treated as cancelled and tenderer will have no right to take this case in any court of India because such cancellation of sale of vehicle will be done at the discretion and in the interest of Government of India.
- x) The successful bidder will be responsible for getting the Registration Certificate of the Vehicle transferred in his name at his own cost expeditiously. The office will not be responsible for any lapse on his part in this regard.
- xi) If the tenderer resiles or fails to observe /comply with any of the above stipulations, the earnest money shall be forfeited by this office.
- xii) This office reserves the right to accept or reject any/ all quotations without assigning any reason.
