GOVERNMENT ORDER NO. FD 11 SRP 2023 (P), BENGALURU, DATED 2nd JUNE 2023

Government are pleased to enhance the rates of Dearness Allowance in respect of Retired State Judicial Officers on 2006 Revised NJPC Pay Scale and retired prior to 01-01-2016 from the existing rate of 212% to 221% of the Basic Pension / Family pension with effect from 1st JANUARY, 2023.

- For the purpose of this order, the term Pension includes only the 'Basic Pension / Family Pension.
- Basic Pension/Family Pension shall not include any other emoluments not classed as Pension.
- The increase in Dearness Allowance admissible under this order is payable in cash until further orders.
- The payment of arrears of Dearness Allowance will be made after the disbursal of the pension for the month of June 2023.

- This order is not applicable to Retired Judicial Officers on 2016 Revised NJPC Pay Scales.
- 7. The payment on account of Dearness Allowance involving fractions of 50 paise and above shall be rounded off to the next rupee and fractions less than 50 paise shall be ignored.
- The Dearness Allowance will be shown as a distinct element of remuneration and will not be treated as pension for any purpose.
