**Subject: Grant of dearness relief to the pensioners of D.A. Getting Institutions with effect from 01.01.2015, and 01.01.2016 who received pay as per ROPA'81/ROPA'90/ROPA'98 pay scale**


In continuation to this Office Circular No. Pen. Co-ordn/111/Vol-VII/211 dated 3/3/2017, it is stated that Govt. of West Bengal, School Education Department, Secondary Branch in their Memo No. 191-ES/O/B/1M-137/2006(Part), dated 18/2/2012 have sanctioned dearness relief @ 173% on basic pension with effect from 01/01/2017 to the both pre'2006 as well as post 2006 pensioners (both teaching and non-teaching employees) of D.A. getting schools who are drawing pension in terms of G.O. No. 1610-Edn(S) dated 18/7/68 read with Memo No. 608-SE(B) dated 7/12/20-07 followed by Memo No. 72-SE(B) dated 19/5/2009 read with Memo No 657-ES/O/B/1M-137/06 dated 11/08/2014 and getting dearness relief under Memo No.148-ES/O/B/IM-137/2006(Part) dated 14/2/2017.

Accordingly, all Pension Disbursing Authorities are requested to make necessary arrangement for payment of dearness relief on pension to the above categories of pensioners @ 173%, on their basic pension with effect from 01.01.2017 after proper adjustments.

In this connection, it is informed that this order is not applicable for the post 2006 pensioners who were in receipt of pay as per West Bengal Non-Govt. Aided Educational Institution ROPA, 2009 and whose P.P.O. were issued by this office with the remarks that "Post 1.1.2006 D.A.Getting School/Pensioner & Pay as per ROPA 2009". The order for these types of pensioners will be issued separately.

Payment of dearness relief on pension/family pension involving a fraction of rupee shall be rounded off to the next higher rupee.

Other provisions relating to grant of dearness relief on pension, as applicable to State Govt. pensioners, will also apply mutatis mutandis.

**Subject: Grant of dearness relief to Post-1/1/2006 pensioners of D.A. Getting Institution who received revised scale of pay as per ROPA 2009**


In continuation to this office circular No. Pen. Co-ordn./111/Vol.VII/210 dated 03/03/2017, it is informed that Govt. of West Bengal in their School Education Department, Secondary Branch Memo.No. 192-ES/O/B/1M-137/2006(Part) dated 18/2/2022 have sanctioned dearness relief, @85% with effect from 01/01/2017 to the pensioners of both teaching and non-teaching employees of D.A. Getting Institutions, who retired on or after 01/01/2006 and whose pension have been regulated/ revised in terms of Memo. No. 72-SE(B) dated 19.05.2009 read with Memo No 657-ES/o/B/1M-137/06 dated 11/8/2014 on the basis of pay as per West Bengal Non-Govt Aided Educational Institution ROPA, 2009 and getting dearness relief under Memo No.147-ES/O/B/IM-137/2006(Part) dated 14/02/2017.

Accordingly, all Pension Disbursing Authorities are requested to make necessary arrangements for payment of dearness relief on pension at the rate as mentioned above to those pensioners after proper adjustment of the amount already paid.

In order to facilitate identification of such category of pensioners, a remarks to the effect that "Post 1.1.2006 D.A.Getting School/Pensioner, Pay as per ROPA 2009" are recorded in the P.P.O./Revised Authority of these pensioners, issued by this office.

Payment of dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee.

Other provisions relating to grant of dearness relief on pension, as applicable to State Govt. pensioners, will also apply mutatis mutandis.

**Subject** implementation of the benefit of Sixth Pay Commission- Regarding para 4.4 & 4.5. of Memo No. 210-Edn(CS) & 214-Edn(CS) both dated 14/02/2020 relating pre-01-01-2016 pensioners/family pensioners in respect of **teaching Staff and non-teaching staff** including Graduate Laboratory Instructors/Instructresses, Librarians, Assistant Librarians, Physical Instructors/Instructresses and equivalent category of employees of State Aided Non-Govt.Colleges including erstwhile Sponsored Colleges.

In continuation of this office circular No.s Pen.Co-ordn/51/Vol-VII/198 and Pen.Co-ordn/204/Vol-II/197 both dated 17/3/2020, it is stated that Govt. of West Bengal, Higher Education Department, C.S. Branch in their Memo No.1224-Edn (CS) dated 17/12/2021 have clarified on certain points as mentioned below of both the Memo No.s 210-Edn (CS) & 214-Edn(CS) dated 14/02/2020 for simplifying the modalities for payment of revised pension/family pension.

2. As per para 4.4. of Memo. No. 210-Edn (CS) & 214-Edn(CS) both dated 14/02/2020, the revised pension of those who retired before 1/1/2016 after completing maximum required qualifying service for full pension(33 years/20 years as the case may be) cannot be less than 50% of the minimum pay of the corresponding pay level in the pay matrix. The pension will be reduced pro-rata where the pensioner had rendered less than the maximum required qualifying service for full pension and in no case it will be less than Rs.8500/-p.m.

3. The higher amount of the pension consolidated as per para 4.1. of the both Memo dated 14/02/2020 *ibid* and the amount calculated in terms of para 4.4 *ibid* in the manner as stated in para 2 above will be regarded as Basic revised Pension. Similarly between the family pension consolidated as per para 4.1 of the both Memo dated 14/02/2020 *ibid* and the amount calculated @30% of the minimum pay of the corresponding pay level in the pay matrix in terms of para 4.4. *ibid*, the higher one will be fixed as basic Family Pension subject to minimum of Rs.8500/-p.m.

4. All concerned Pension Disbursing Officers are, therefore, requested to **start** payment of revised rates of pension/family pension **provisionally** in terms of para 4.4 of Memo dated 14/02/2020, if it is more than the pension/family pension arrived at in terms of para 4.1 of the both Memo, on receipt of the certificate in this regard directly from the Pension.Sanctioning Authority as per Memo No 1224-Edn(CS) dated 17/12/2021 and continue payment of such revised pension/family pension, till receipt of final authority in this regard from this office.

5. On receipt of the final authority for payment of such revised pension/family pension to be issued from this office in each individual case, the provisional revised pension/family pension, thus made may be adjusted against the payment of that authority.

6. In case where the pensioner/family pensioners are drawing pension/family pension in other States, no such provisional payment of revised pension/family pension as mentioned in para 4 above will be made by the Pension Disbursing Authority. In their cases, the concerned Pension Sanctioning Authority will revise pension in terms of para 4.4 of Memo No. 210-Edn (CS) & 214-Edn(CS) both dated 14/02/2020 and send the same to the Accountant General, West Bengal for arranging Special Seal Authority for payment through Treasury/Bank of other States. However, in their cases the revised pension/family pension as determined under para 4.1 of Memo dated 14/02/2020 will continue to be paid by the Pension Disbursing Authorities till receipt of revised authority in each case from the concerned Accountant General.

7. In terms of para 4.5 of the both Memo dated 14/02/2020 *ibid*, the additional quantum of pension/family pension (any fraction will be rounded off to next 1(one) rupee and it would not be rounded off to next higher multiple of Rs.10) would be admissible from the 1<sup>st</sup> day of the month in which his/her date of birth falls, on attaining the age of 80 years or above. It is the responsibility of the Pension Disbursing Officers concerned to make payment of additional pension/family pension to the eligible pensioner/family pensioner after verification of the age from the P.P.O /F.P.P.O. In case date of birth is not available in PPO/F.P.P.O., the Pension Disbursing Authorities will make payment of additional pension/family pension on receipt of intimation regarding the age of the pensioner/family pensioner from the concerned Pension Sanctioning Authority.

8.As regards payment of Dearness Relief and noting of revised basic pension/family pension as well as additional pension/family pension, instruction given in paragraph 7 and 8 of the both circulars dated 17/3/2020 *ibid* may be followed.

9. All Pension Disbursing Authorities are, therefore, requested to display the fact to the notice board so that the pensioners/family pensioners may contact their Pension Sanctioning Authorities for availing the above benefit.

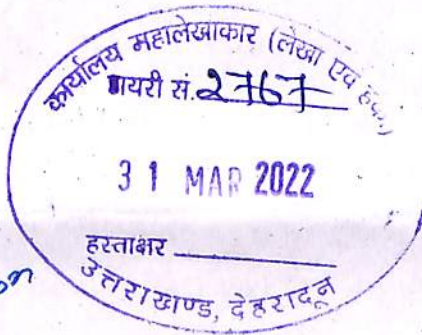

Subject : Enhancement of maximum ceiling on two family pensions admissible to the child/children of deceased Government employees.

Govt. of West Bengal, Finance Department (Pension Branch) in their Memo. No. 665-F (Pen) dated 18/11/2021 (copy enclosed) have decided to raise the existing ceiling on two family pensions to the child/children where both of his/their deceased parents were State Government employees and governed by the WBS (DCRB) Rules, 1971. The existing maximum limit at enhanced rate is raised from ₹ 12,747/- only p.m. to ₹32,760/- only p.m. and maximum limit at the normal rate is raised from ₹6,848/-p.m. to ₹17,600/- only p.m. for such category of family pensioners and both rates shall be deemed to have taken effect from 1/1/2020.

All Pension Disbursing Authorities are, therefore, requested to keep note of the fact while making payment of family pension to the said categories of family pensioners.

MEMORANDUM

Subject : Ceiling on two family pensions admissible to the child / children of deceased Government employee

Consequent upon revision of rate of Family Pension of the State Government in connection with the implementation of the recommendation of 6<sup>th</sup> Pay Commission, the question of revision of the maximum ceiling on two Family Pensions to the child / children where both of his / their deceased parents were State Government employees and governed by the WBS (DCRB) Rules, 1971 has been under consideration of the State Government for sometime past.

After careful consideration of the matter, the Governor has been pleased to revise the existing limits on two family pensions as follows

- (i) The existing maximum limit at the enhanced rate of ₹ 12,747/- per month introduced with effect from 01.04.2008 in terms of Memo No. 391-F (Pen) dated 13.05.2010 be raised to ₹ 32,760/- (Rupees thirty-two thousand seven hundred and sixty) only per month.
- (ii) The existing maximum limit at the normal rate of ₹ 6,848/- per month introduced with effect from 01.04.2008 in terms of Memo No. 391-F (Pen) dated 13.05.2010 be also raised to ₹ 17,600/- (Rupees seventeen thousand and six hundred) only per month.

This shall be deemed to have taken effect from 01.01.2020.
