Subject:- Grant of Ex-gratia payment to the pensioners/family pensioners of Non-Govt. Colleges, Day Students' Home & West Bengal College Service Commission for the year 2019

The Govt. of West Bengal, Department of Higher Education, Science & Technology and Biotechnology, C.S. Branch in their Memo No. 1152-Edn(CS)/1P-20/98(Pt.1) dated 25/7/2019 have sanctioned payment of ex-gratia grant of Rs.2100/- (Rupees two thousand one hundred) only in lump per head to all pensioners / family pensioners of Non-Govt. Colleges, Day Students' Home & West Bengal College Service Commission including the holders of provisional pension who retired prior to 30.09.2018 and also the pensioners who retired or died after 30.09.2018 but prior to 01.09.2019 and are not eligible to receive adhoc bonus.

- 2. The benefit will be admissible only to the pensioners/family pensioners whose basic pension/family pension along with dearness relief as on 31<sup>st</sup> March 2019 did not exceed Rs.26000/-(Rupees twenty six thousand). The benefit is not admissible to those who are entitled to ad-hoc bonus and those who are employed / re-employed under any Public Undertaking / Statutory Bodies under the Government and are in receipt of bonus or exgratia payment in lieu thereof during the current financial year.
- 3. All concerned Pension Disbursing Officers are, therefore, requested to allow exgratia grant @ Rs.2100/- (Rupees Two thousand one hundred) only to the above categories of pensioners / family pensioners before 1<sup>st</sup> of October,2019 keeping in view the instructions as mentioned above.
