It is informed that the Govt. of West Bengal, Finance(Audit) Department, in their Memo no. 1494-F(P2) dated 06/05/2021 (Copy enclosed) have sanctioned Ex-gratia grant of Rs.2500/-(Rupees Two thousand Five hundred only) in lump per head to all State Government pensioners including the holders of provisional pension who retired prior to 30/09/2020 and also the pensioners/family pensioners who retired or died after 30/09/2020 but prior to 01/09/2021 and are not eligible to receive ad-hoc bonus.

2. The Ex-gratia grant sanctioned in the aforesaid Memo will also be admissible to the categories of pensioners mentioned in Para 3 of the enclosed Memo.

The classes of pensioner who will not come within the purview of the Memo have also been clearly indicated in Para 4 & 5 of the Memo dated 06.05/2021.

In this connection, it is informed that the pro-rata pension holders are also entitled to get the benefit of full amount of ex-gratia grant, sanctioned in the above Meme in terms of Govt. of West Bengal. Finance Department ,Pension Branch's clarificatory letter No. 805-F(Peu), dated 10/12/2008 (circulated by this Office circular No Pen. Co-ordn/7 Vol. III/64 Vol. II/191 dated 07/01/2009), subject to fulfillment of the conditions as laid down in the Memo. *ibid*.

- 3. The ex-gratia grant sanctioned in the Means will, however, be admissible to pensioners/family pensioners whose basic pension/family pension along with dearness relief does not exceed Rs.31,000/- as on 31/03/2021 during the ensuing festivals.
- 4. Necessary arrangements for payment of Ex-gratia (a) Rs. 2500/- (Rupees Two thousand and Five Hundred only) to the eligible West Bengal Govt. pensioners/family pensioners may please be made, keeping in view the instructions contained in the enclosed Memo as well as in this circular.

MEMORANDUM

Sub: Grant of ex-gratia payment to the State Government Pensioners for the year 2020-2021.

The undersigned is directed by order of the Governor to say that in order to provide some relief to the State Government Pensioners during the ensuing festivals, the Governor has been pleased to decide that all State Government Pensioners including the holders of provisional pension who retired prior to 30-09-2020 and also the pensioners who retired or died after 30-09-2020 but prior to 01-09-2021 and whose basic pension plus Dearness Relief on pension as on 31st March 2021 did not exceed Rs.31,000/- (Rupees Thirty One Thousand) only and are not eligible for ad-hoc bonus shall be paid an ex-gratia grant of Rs.2,500/- (Rupees Two Thousand Five Hundred) only in lump per head.

- 2. The charge is debitable to the head "2071-Pension and other retirement Benefits-01 Civil-800-other Expenditure-NP-001-fund required for meeting other expenditure-V-04-Pension /Gratuities" during the current financial year.
- 3. The ex-gratia grant sanctioned herein will also be admissible to:
 - i) The holders of family pension, ex-gratia family pension and ad-hoc family pension;
 - ii) Pensioners(including widow pension holders) who draw their pension sanctioned under French Pension Rules;
 - iii) Holders of extra-ordinary pension; and
 - iv) Holders of ex-gratia pension.

The benefit will also be admissible to the pensioners of the undivided Government of Bengal and the pensioners of the erstwhile East Pakistan (now Bangladesh) Government who migrated to West Bengal and are receiving pension under "Provisional Payment of Pension Scheme".

- 4. The Ex-gratia grant sanctioned herein will not be admissible to the special categories of pensioners, such as:
 - i) Pensioners who have migrated from Pakistan;
 - ii) Political Pensioners;
 - iii) Special Pensioners;
 - iv) War Risk Pensioners;
 - v) Pensioners governed by the All India Services Rules.
- 5. The benefit will also not be admissible to those who are entitled to ad-hoc bonus sanctioned by the State Government and those who are employed/re-employed under any Public Undertakings/Statutory Bodies under the Government and are in receipt of bonus or ex-gratia payment in lieu thereof during the current financial year.

- 6. State Government pensioners who draw their pension through Public Sector Banks will get this ex-gratia grant through their respective Bank Account. The Principal Accountant General(A&E), West Bengal will issue an authority for this purpose to all such Banks under the Kolkata Payment Scheme immediately on receipt of this order so that the pensioners may draw the ex-gratia grant immediately to make their commitments for their festival. The Treasury Office will take appropriate steps for issue of cheque to the respective paying branches of the Banks and post Offices, so that the pensioners receiving pension through Banks and Money Order get the payment of ex-gratia immediately to meet their commitments for their festival. No authority of the Principal Accountant General(A&E), West Bengal will be required for this purpose.
- 7. Subject to Para 6 above, this order will also be applicable to those who are eligible to this exgratia grant but whose pension/family pension has not yet been sanctioned. In their cases and in the case of persons who are drawing provisional pension, this amount of ex-gratia will be drawn by the authority competent to draw provisional pension in the same manner as the amount of provisional pension is drawn by him. In their cases, the facts of payment of ex-gratia grant should be intimated to the Principal Accountant General(A&E), West Bengal at the time of forwarding their pension papers for final sanction of pension.

The benefit of ex-gratia grant of Rs.2,500/- per head as has been sanctioned in this memorandum for the State Government Pensioners will also be allowed to the teaching and non-teaching Pensioners of State Aided Non-Government Educational Institutions and Pensioners of Panchayats, the Pensioners of Municipal Corporations/Municipalities/Local Bodies and other Organisations for whom Pension is authorized either by the Accountant General, West Bengal or the DPPG, West Bengal. In such cases the respective Administrative Department may sanction the benefit of ex-gratia payment @ Rs.2,500/- per head this year to the pensioners concerned under their control without making any further reference to Pension Branch of this Department.

The payment of ex-gratia as sanctioned hereinabove should be made before the festival of Id-Ul-Fitre of 2021 for the Muslim Pensioners/Family Pensioners and other than Muslim Pensioners/Family Pensioners the benefits should be disbursed in between 27th September, 2021 to 5th October, 2021.

In continuation to this office circular No. Pen.Co-ordn./55 Vol.VI/142 Vol.III/65 Vol.IV/ 66 Vol.III/107 dated 01/11/2019, it is stated that Government of India, Ministry of Personnel, Public Grievances & Pensions, Department of Pension & Pensioners' Welfare under their O.M. No 42/07/2021-P&PW(D) dated 22/07/2021 have sanctioned Dearness Relief at the rate of 28% with effect from 01/07/2021 in supersession of the existing rate of 17% effective from 01/07/2019 as mentioned in O.M. No F 42/04/2019-P&PW(D) dated 21/10/2019 to (i) Civilian Central Government pensioners/family pensioners including absorbee pensioners in PSU/Autonomous Bodies (ii) The Armed Forces Pensioners, Civilian Pensioners paid out of the Defence Service Estimates, (iii) All India Service Pensioners / family pensioners (iv) Railway Pensioners / family pensioners (v) Pensioners who are in receipt of provisional pension (vi) The Burma Civilian Pensioners / Family Pensioners and (vii) Pensioners/families of displaced Government pensioners from Pakistan. The increased rate of dearness relief subsumes the additional installments arising on 01/01/2020, 01/07/2020 and 01/01/2021. However, the rate remains at 17% of basic pension / family pension for the period from 01/01/2020 to 30/06/2021.

- 3. The retired officers of West Bengal Judicial Service and family pensioners of such category whose pension/family pension has been regulated /revised in terms of Judicial Department Memo No 7012 J and 7014 J both dated 25/10/2010 would not come within the ambit of this circular and a separate circular letter in respect of such category of pensioners / family pensioners will be issued separately on enhancement of such applicable rate.
- 4. In the case of retired Judges of the High Court, separate circular will be issued on receipt of necessary order from the Ministry of Law and Justice.
- 5. Amount of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
- 6. It will be the responsibility of the pension disbursing authorities, including nationalized banks etc. to calculate the quantum of Dearness Relief payable in each individual case.
- 7. All concerned Pension Disbursing Officers are, therefore, requested to make necessary arrangement for payment of Dearness Relief @ 28% to the above eligible categories of pensioners/ family pensioners with effect from 01/07/2021, along with arrear of dearness relief following the above guideline, as applicable, after proper adjustment.
- 8. Charges for payment of above enhanced rate of dearness relief to the pensioners/family pensioners are debitable to the Government of India/Railway/Defence Accounts under the proper head of account as usual.
- 9. Receipt of the circular may please be acknowledged.

The Govt. of West Bengal, Department of Higher Education, Budget Branch in their Memo No. 12-Edn(B)/1M-12/2008 dated 10/05/2021 have sanctioned payment of ex-gratia grant of Rs.2500/- (Rupees two thousand five hundred) only in lump per head to all teaching/non-teaching pensioners / family pensioners of State Aided Colleges including the holders of provisional pension who retired prior to 30.09.2020 and also the pensioners who retired or died after 30.09.2020 but prior to 01.09.2021 and are not eligible to receive ad-hoc bonus.

- 2. The benefit will be admissible only to the pensioners/family pensioners whose basic pension/family pension along with dearness relief as on 31st March 2021 did not exceed Rs.31000/-(Rupees thirty one thousand). The benefit is not admissible to those who are entitled to ad-hoc bonus and those who are employed / re-employed under any Public Undertaking / Statutory Bodies under the Government and are in receipt of bonus or ex-gratia payment in lieu thereof during the current financial year.
- 3. All concerned Pension Disbursing Officers are, therefore, requested to allow ex-gratia grant @ Rs.2500/- (Rupees Two thousand five hundred) only in lump per head.
- 4. The payment of ex-gratia as sanctioned in the Memo may be made to the Muslim Pensioners/family pensioners immediately on receipt of this circular and other than Muslim Pensioners/Family pensioners, the payment in this regard may be made in between 27th September 2021 to 5th October 2021.
