✓ Subject : Extension of benefit of revision of pension/family pension to the pensioner/family pensioners guided by French Pension Rules with effect from 01/01/2020.

Consequent upon revision of pension/family pension of State Govt. employees in terms of Memo No.535-F(Pen) dated 1/10/2019, the Govt. of West Bengal, Finance Department, Pension Branch in their Memo no. 290-F (Pen), dated 21/07/2020 have revised the existing pension/family pension due on 31/12/2019 in respect of the pensioners/family pensioners guided by French Pension Rules by multiplying 2.57, with effect from 01/01/2020. The amount so arrived at shall be rounded off to next 10(ten) rupee, if the said amount is not multiple of 10(ten). If the revised consolidated pension so arrived at is below Rs.8500/-, it shall be fixed at minimum of Rs.8500/-p.m.

All Pension Disbursing Officers, are, therefore, requested to make necessary arrangements for payment of revised rates of consolidated pension minimum Rs.8500/-p.m. with effect from 1/1/2020 in respect of pensioner/family pensioner guided by French Pension Rules after proper adjustment of the pension and dearness relief already paid.
