CIRCULAR

Subject: Furnishing of unconditional undertaking by Divisional Accountant Cadre officials for convening Departmental Promotion Committee (DPC) for the remaining period of Panel Year 2025 and the ensuing Panel Year 2026.

As per the directions received from Headquarters, a proposal is under consideration for convening the **Departmental Promotion Committee (DPC)** in respect of the **Divisional Accountant Cadre** for the remaining period of **Panel Year 2025**, and the ensuing **Panel Year 2026**. It has been intimated that the inter-se-seniority matter is under consideration in AG Prayagraj office and many officials of cadre allocated Uttarakhand upon bifurcation of cadre from AG Prayagraj office. Seeing the delay in inter-se-seniority matter HQ office has decided to process the Departmental Promotion Committee (DPC) only after obtaining an unconditional undertaking from all officials of the Uttarakhand Divisional Accountant Cadre.

Accordingly, all Divisional Accountant Cadre officials borne on the **Uttarakhand Cadre (Format-II)**, including those whose cadre was shifted from **Uttar Pradesh to Uttarakhand (Format-I&II)** pursuant to the bifurcation of the State, are hereby requested to furnish an **unconditional undertaking** in the prescribed format enclosed herewith. Each official of Divisional Accountant cadre must understand that in the event of any future revision of Inter-se seniority the concerned official shall forgo any consequential benefits arising due to the decision of Hon'ble CAT, Allahabad in this regard.

All are requested to ensure compliance up to 10 March 2026.

अतः उत्तराखंड खंडीय लेखाकार/लेखाधिकारी संवर्ग के सभी कार्मिक (Format-II) तथा राज्य पुनर्गठन के फलस्वरूप उत्तर प्रदेश से उत्तराखंड संवर्ग में स्थानांतरित कार्मिक (Format-I एवं Format-II), संलग्न प्रारूप के अनुसार भर इस कार्यालय को प्रस्तुत करना सुनिश्चित करें।
