

Payment of Dearness Relief to State Government pensioners and family pensioners, who are drawing their pension/family pension as per 7th Pay Commission Pension Structure w.e.f. 1st July, 2023.

The Governor of Haryana is pleased to enhance the Dearnéss Relief (DR) payable to State Government pensioners and family pensioners, who are drawing their pension/family pension as per 7th Pay Commission Pension Structure, from existing rate of 42% to 46% of the basic pension/ family pension with effect from 1st July, 2023.

2s Enhanced DR shall be paid with the pension/family pension of October, 2023 and arrear for the months of 1st July, 2023 to 30th September, 2023 shall be paid in the month of December, 2023. The payment on account of Dearness Relief involving fractions of 50 paise and above may be rounded to the next higher rupee and the fractions of less than 50 paise may be ignored.
