In continuation to the Government Order No. 94-F of 2023 dated 04.05.2023, it is hereby ordered that Government pensioners/Family Pensioners shall be paid Dearness Allowance as under:-

- i. The arrears on account of additional installment of Dearness Allowance from July, 2023 to November, 2023 shall be paid in cash in the month of December, 2023. The revised Dearness Allowance shall form part of monthly pension/family pension from December, 2023 onwards.
- ii. The payment of Dearness Allowance involving a fraction of 50 paisa and above shall be rounded to the next higher rupee and the fraction of less than 50 paisa shall be ignored.
- iii. Other provisions governing the grant of Dearness Allowance on pension/family pension such as the regulations of Dearness Allowance during employment/re-employment where more than one pension is drawn etc. and other provisions of the existing rules/orders (as are not in conflict with provisions of this Order), shall continue to remain in force.
