I am to forward herewith the Government of Nagaland Finance Department, O.M. No. FIN/ROP/REL-19/2001 dated 31<sup>st</sup> May, 2023 regarding enhancement of Dearness Relief to Government of Nagaland Pensioners and Family Pensioners from the existing rate of 38% to 42% w.e.f. 01-01-2023.

Apart from these the Government of Nagaland, Department of Finance ROP Cell O.M. Vide.No.FIN/ROP/REL-08/87(Vol-II) dated the 26/10/10, standing order of release of Dearness Relief to the Nagaland State Government Pensioners/Family Pensioners as and when sanctioned by the Government of India without any further order from the State Government or authorization from the Accountant General has been kept in abeyance till further notice(vide Finance Department, Government of Nagaland Vide.No.FIN/ROP/REL-8/87(Vol-II) dated the 26/02/2016. In future, for Revision of Dearness Relief, separate authorization will be issued as and when the same is revised by the State Government of Nagaland.

You are therefore requested to make necessary arrangement to circulate the O.M. to all Treasuries/Sub-Treasuries/Public Sector Banks under your jurisdiction for payment of enhanced rate of Dearness relief.

Sub: Modified Career Progression Scheme (MACPS)-Clarification thereof.

1. Vide P&AR O.M. No. AR/O&M/2/93 dated 6<sup>th</sup> March 1997 and O.M. of even number dated 19<sup>th</sup> January 1998, the post of Sectional Officer Grade-I/Computer Grade-I/Surveyor Grade-I/Assistant Driller/Mines Overman/Assistant Cartographer/ Draughtsman Grade-I as Junior Engineer should be considered as merger of posts upon abolition of the original posts and will not be considered as a financial lift.
2. The department has noticed that a number of MACP cases pertaining to this group of employees are being referred to this Department for clarification.
3. The matter has been examined and it is hereby clarified that the upgrader/re-designation of Sectional Officer Grade-I/Computer Grade-I/Surveyor Grade-I/Assistant Driller/Mines Overman/Assistant Cartographer/ Draughtsman Grade-I as Junior Engineer should be considered as merger of posts upon abolition of the original posts.
4. The date of counting for grant of MACP Scheme will be reckoned from the date of merger of each individual case.


