
Subject: Revision of pension/family pension of pre 01.01.2016 pensioners/family pensioners of Haryana Government (7<sup>th</sup> CPC) w.e.f. **01.01.2016** --- **clarifications thereof.**

I am directed to invite your attention to the Finance Department's Office Memorandum No. 2/23/2016-1Pension dated **10.01.2018** vide which it has been decided by the State Government to revise the pension/family pension in respect of all Haryana Government pensioners/family pensioners, who retired/died **prior to 01.01.2016**, with effect from **1<sup>st</sup> January, 2016** followed by clarification memo of even number dated 30.01.2018/01.02.2018, 11/22.10.2018, 07.12.2018 and 31.01.2019.


A number of references were received from the pre 01.01.2016 retirees of Haryana Government with the request to issue instructions for revision of pension/family pension on the modified Pay Scale/Pay Band/Pay Level as well as in the ACP structure.


Now after due consideration, it has been further decided by State Government **in continuation of** above O.M dated 10.01.2018 that:-

1. the revision of pension/family pension, on the basis of notional pay of the pre-2016 govt. employee, drawing pay in the **ACP scale/Pay band+grade pay**, at the time of retirement/death, may also be revised, w.e.f. 01.01.2016 in the ACP table/structure as prescribed by State Government from time to time.
2. the revision of pension/family pension, on the basis notional pay of the pre-2016 govt. employee, where pay scales have been upgraded/modified by the State Government from time to time, may also be revised w.e.f. 01.01.2016 in the **modified/upgraded** pay scale instead of corresponding pay scale.


