(Civil) No. 643 of 2015. The admissible rates of Fixed Medical Allowance and Domestic Help Allowance are as follows -(a) The Fixed Medical Allowance to the pensioner/family pensioner shall be Rs. 4000/per month with effect from 01/01/2016. (b) The Domestic Help Allowance to the retired Judicial Officers shall be Rs. 9000/- per month and Rs. 7500/- per month for family pensioners with effect from 01/01/2016 provided that such allowance shall stand increased by 30% on completion of five years from 01/01/2016 that is, w.e.f. 01/01/2021 and shall be included in the PPO of the pensioner / family pensioner concerned by the Pension Disbursing Authority. Accordingly, in continuation to this office circular No. Pen. Co-ordn./65 Vol.V/94 dated 27/09/2023, all concerned Pension Disbursing Authorities are requested to make necessary arrangement for payment of Fixed Medical Allowance and Domestic Help Allowance at the rate as stated above to the above category of pensioners / family pensioners with effect from 01/01/2016 after proper adjustments of payment already made. In continuation to this office circular No Pen.Co-ordn./51/Vol-VII/204/Vol-II/4 dated 05/04/2023, it is stated that the Govt. of West Bengal, Higher Education Department in their order no. 28(31)-Edn(U)/HED-12012(21)/2024-UNV SEC-Deptt.vof HE dated 11/1/2024 read with their clarificatory letter No. 280-Edn(CS)/10M-13/2024 dated 9/4/2024 have sanctioned dearness relief @ 10% with effect from 01/01/2024 on the basic pension/family pension, so revised as per Memo No. 210-Edn (CS) dated 14/02/2020 or Memo No. 214-Edn (CS) dated 14/02/2020, circulated under this office circular No. Pen. Co-ordn./204/Vol-II/198 dated 17/03/2020 and Pen. Co-ordn./204/Vol-II/197 dated 17/03/2020 respectively to the pensioners/family pensioners of the teaching and non-teaching staff of the State-Aided Non-Government Colleges in this State.

Besides, the pensioners/family pensioners arising out of teaching/nonteaching employees of State aided Non-Govt. Colleges, who are still drawing pre-revised pension/family pension as per ROPA2009, will get Dearness Relief @151% with effect from 01/01/2024 till their pension/family pension is revised.

All concerned Pension Disbursing Officers are, therefore, requested to allow dearness relief on revised rates of pension/family pension @ 10% and on un-revised rates of pension/family pension @151% with effect from 01/01/2024 to the above categories of pensioners/family pensioners.

Payment of dearness relief on pension/family pension involving a fraction of rupee shall be rounded off to the nearest rupee in each case.

Other provisions governing grant of dearness relief to the pensioners/family pensioners not mentioned in this order, such as regulation of relief during re-employment, regulation of relief where more than one pension is drawn etc., will remain unchanged.

Accountants General of other States are requested to arrange additional copies of the said Govt. order at their end, if necessary, for circulation within their State.
