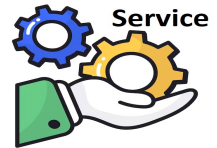

## Initiatives

**Pension Adalat:** An online Pension Adalat was held on 19.05.2026 from 11.30 AM onwards for discussion and settlement of pending pension cases pertaining to Forest Department. The inaugural session was attended by the Pr. Accountant General, Additional Chief Secretary, Forest Department, Principal Chief Conservator of Forests, Chief Conservator of Forests, Group Officers, Branch Officers, Pension Sanctioning Authorities and pensioners. It was followed by a one-to-one discussion on pending cases with the respective PSAs and pensioners.

Out of 75 pending pension cases, 73 were discussed. 10 cases were settled, 02 cases require further reference, 48 cases were advised to be resubmitted and documents in 08 cases were awaited from the PSAs for authorization of benefits. Further, 05 cases were proposed to be struck off from the pending list of the department.
