Trainings in the Second quarter of 2021-22

In the second quarter of 2021-22, RTI conducted, 05 General Courses and 03 EDP course (Annex A). These courses received average grading of 4.62 and 4.70 respectively. Total 114 participants from 19 user offices attended General courses while 63 participants from 18 offices participated in the EDP course.

The training sessions were handled by core faculty of the Institute, senior officers of IA&AD, group officers,

serving / retired Senior Audit Officers and external experts.
