Round up of RTI Activities

Regional Training Institute, Jaipur functions with the aim of upgrading knowledge and skills of its user offices within IA&AD.

In the previous year RTI trained 1117 participants in General Courses and 236 participants in EDP Courses. For both categories of courses the number of persons trained were more than originally planned.

The training calendar of Regional Training Institute, Jaipur for the year 2020-21 was approved by the Regional Advisory Committee on 16th March 2020. The calendar has been drawn up on the basis of training needs projected by user offices and instructions of Headquarters Office received

from time to time. In designing the courses, participants' feedback as well as suggestions of user offices have been kept in view. During 2020-21 the Institute plans to deliver 30 general training programmes and 10 EDP training programmes. Apart from these, slots have also been reserved for Mid-Career Training Programme (MCTP), mandatory training for AAOs due for promotion to the cadre of SAO, RAE-participants and training for direct AAOs.

The challenges due to ongoing pandemic COVID-19 have been met by shifting all training activities online using MS teams. The Institute planned and successfully conducted five online training courses during April to July 2020 imparting training to 105 officials on various topics and skills as given below:

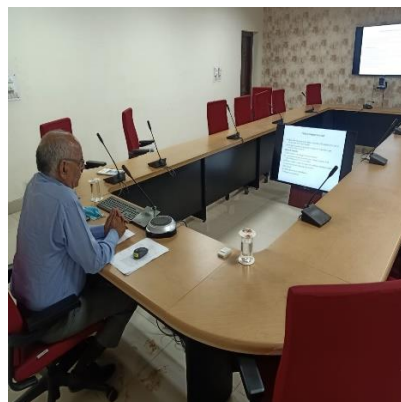
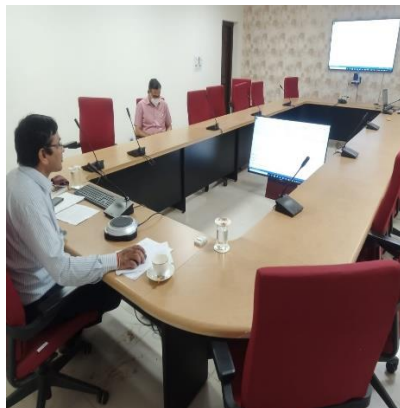
