OFFICE ORDER

In response to O.O. No. WM-I/2021-22/14 dated- 14 /06/2021, options were received in **Form-I and II** under Rule 10 of CCS (Implementation of National Pension System) Rules, 2021 from NPS subscribers of Divisional Accountant cadre. The following instructions are issued in this regard:-

(A) Annexure-A shows the list of subscribers, whose options have been verified and one copy has been returned to them after countersignature. They are requested to **forward their Service Books at the earliest**, for final incorporation of their option in the Central Record Keeping Agency.

(B) Annexure-B shows the list of NPS subscribers, whose options have been received, but **could not be incorporated due to certain discrepancies**. They are directed to contact WM-I section and comply with the objections. Those who have not submitted the Identity and age proof of family members are requested to submit the same (preferably copy of Adhar Card). After compliance of the objections, their Service Books are to be forwarded to this office.

(C) Annexure-C shows the list of NPS subscribers who have not submitted their option in **Form-I and II**. They are directed to submit the details in three copies (along with proof of Identity and date of birth of all the family members- preferably copy of Adhar Card), within two weeks of issue of this order **in the enclosed format, along with Service Books**. They are requested to match all details of family members, for e.g. spelling of name, date of birth, etc., before submission of the form.

(D) All the NPS subscribers are also directed to submit their subscription regularly, on a monthly basis, without fail.

Important

1. The original Form submitted by the Government servant / Subscriber is to be retained. All additions or alterations are to be communicated by the Government servant/retired Government servant / Subscriber along with the supporting documents and the changes shall be recorded in this Form under the signature of Head of Office in Col 7. No new Form will substitute the original Form. However, the retiring Subscriber should submit the details of family afresh at the time of retirement.
2. The details of spouse, all children and parents (whether eligible for family pension or not) and disabled siblings (brothers and sisters) may be given.
3. The Head of Office shall indicate the date of receipt of communication regarding addition or alteration in the family in the 'Remarks' column. The fact regarding disability or change of marital status of a family member should also be indicated in the 'Remarks' column.
4. Wife and husband shall include judicially separated wife and husband.
5. The retired Government servant shall attach the details of change in family structure after retirement in the proforma prescribed under Dept. of P.& P.W., O.M No. 1 (23)-P.&P. W/91-E, dated the 4th November, 1992.
6. Copies of birth certificates to be attached. Copies of any other relevant certificates, if available, should be attached.
