After completion of the training in one office as per programme, Divisional Accountant (Prob.) will be relieved by their Controlling Officer to report for further training to the respective offices and finally they will be relieved by the Branch Officer under whom the training is given in the O/o the Pr.Accountant General (A&E), Jharkhand, Ranchi to report to their respective divisions.
