Lap ka CAG ba khlem pynkhuid ka Tnad Election ïa ki Bill ba kot T. 88 klur

Shillong, Naiwieng 14: Ka Ophis u Comptroller & Auditor General of India, kala lap ba ka Tnad Election jong ka Jylla ka dei kawei ka Tnad kaba jur eh ha ka jingpynsahteng ban siew ïa ki Bill da ka jingshem ba ka khlem lah pyn khuid ïa ki Outstanding abstract (AC) Bill ba kot haduh T. 87.89 klur.

Ka CAG ha ka kaiphod jong ka State Finance Audit Report na ka bynta u snem ba kut ha ka 31 tarik Lber 2019, kala ng ba kat kum ka Finance Account jong u snem 2018-2019 na ka bynta ki AC Bill ba kot haduh T.88.09 klur, ym shym la ïohpdiang satia ki Detailed Countersigned Contingent (DCC) Bill.

"Ka jingpynsahteng kaba bun eh ka dei jong ka

Tnad Election ha kaba ki AC Bill ba kot T. 87.89 klur kila shu sah kut kat haduh u bnai Lber 2019" ong ka kaiphod.

Ka kaiphod ka ong ba ka jingsei lypa ïa ka pisa (advance) bad khlem da buh jingkheiñ, ka plie lynti ïa ka jingpyn syrwa kai, ka jingpyndonkam bakla bad jingpyndonkam bym hok nalor kiwei kiwei.

"Kane ka mut ruh ïa ka jingleh ka bym sngew iahap satia bad namar kata, donkam ban peitngor bha da ki DDO ban pynthikna ba kin pynbeit ha ka por kaba dei" ong ka kaiphod. Ha kajuh ka por, ka CAG kala ai jingmut ba ka Sorkar Jylla ka lah ban mynjur ha kaban tynrong ïa ka jingkitkhlieh ïa ki Ophisar namar ka jingbym lah ban pynkhuid ïa ki AC Bill hapoh ka jingbuhpor ba shibnai.

Translation of newspaper's clipping from Mawphor dated 15 November 2020 CAG's finding of unadjusted Bills to the tune of ₹88 crore of Election Branch

Shillong, November 14: The office of the Comptroller Auditor General of India, found that the Election department of the State was one of the departments which most prolonged non submission of detailed bills with unadjusted Outstanding abstract (AC) Bills amounting to ₹87.89 crore.

The CAG in its State Finance Audit Report for the year ending 31 March 2019, stated that as per the Finance Account of the year 2018-2019 for the AC Bills amounting ₹88.09 crore, no Detailed Countersigned Contingent (DCC) Bills were received.

" Major defaulter in this regard is the Election department, with DCC bills against AC amounting to ₹87. ♣9 crore still pending"

The report stated that advance drawal of money and without accounting, may lead to wasteful expenditure, diversion and mis-utilisation besides others.

"This also means that the accounts cannot be vouched as correct and thus the DDOs should make sure that the detail are furnished on time" stated the report. At the same time CAG recommended that the State Government should fix responsibility on the concerned Officers for non adjustment of AC Bills within a month.
