

**ALLOCATION OF STATE/OFFICE TO THE CANDIDATES NOMINATED FOR APPOINTMENT TO THE POST OF DATA ENTRY OPERATOR THROUGH COMBINED HIGHER SECONDARY LEVEL EXAMINATION - 2016 IN INDIAN AUDIT & ACCOUNTS DEPARTMENT**
