

ALLOCATION OF STATE/OFFICE TO THE CANDIDATES NOMINATED FOR APPOINTMENT TO THE POST OF DIVISIONAL ACCOUNTANT THROUGH COMBINED GRADUATE LEVEL EXAMINATION (CGLE) -2017 IN INDIAN AUDIT & ACCOUNTS DEPARTMENT (IA&AD).

The Staff Selection Commission had nominated 600 (UR-306, OBC-158, SC-94, ST-42) candidates for appointment to the post of Divisional Accountant through Combined Graduate Level Examination-2017.

2. Among the 600 nominated candidates, 580 candidates have submitted the online required details of their Bio-Data, State Preference and Attestation Form.
