

**Allocation of State/office to the candidates nominated for appointment to the post of Assistant Audit Officer through Combined Graduate Level Examination, 2021 (CGLE-2021) in Indian Audit & Accounts Department (IA&AD)**

The Staff Selection Commission had nominated 335 (SC-50, ST-24, OBC-90, EWS-33, UR-138) candidates for appointment to the post of Assistant Audit Officer through Combined Graduate Level Examination, 2021 (CGLE-2021).

2. The allocation of States/Offices to the candidates has been done on the basis of Merit cum State preference submitted by the candidates. The candidates who have not submitted online information have been allocated the States/Offices under the 'General Pool' vacancies.
3. Among the 335 candidates, 327 have submitted the online required details of their Bio-Data, State Preference and Attestation Form.
4. As per available online details submitted by the candidates, 60 (SC-15, ST-01, UR-44) candidates possess the required qualification for being allotted to Commercial Stream. In the cadre of AAO (Commercial), we have 01 ST vacancy. Hence, 01 ST candidate has been allocated to Commercial Stream and 334 (SC-50, ST-23, OBC-90, EWS-33, UR-138) candidates have been allocated to Non-Commercial Stream.
5. Allocation of State/office to the 01 candidate in Commercial Stream and 334 candidates in Non-Commercial Stream, has been done separately. The candidates who have not submitted online information, have been allocated the States/Offices under the 'General Pool' vacancies in Non-Commercial Stream.
6. The allocation of State/office to a candidate is final and no request for change of allocation shall be entertained.
7. The dossiers of the candidates are being sent to the allocated offices for further necessary action.
