- 2. NUMBER OF POSTS, CLASSIFICATION AND SCALE OF PAY

- (a) who has entered into or contracted a marriage with a person having a spouse living, or

shall be eligible for appointment to the said post:

Provided that the Comptroller and Auditor General of India may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

POWER TO RELAX Where the Central Government, on the request of the Comptroller & Auditor General of India is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing, and in consultation with the Union Public Service Commission, relax any of the provisions of these rules with respect of any class or category of persons.
- 6. <u>SAVING</u> Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, Scheduled Tribes, Ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government, in consultation with the Comptroller and Auditor General of India, from time to time, in this regard.
