Certificate of the Comptroller and Auditor General of India

This Compilation containing the Finance Accounts of the Government of Tripura for the year ending 31 March 2019 presents the financial position along with accounts of the receipts and disbursements of the Government for the year. These accounts are presented in two volumes, Volume-I contains the consolidated position of the state of Finances and Volume-II depicts the Accounts in detail. The Appropriation Accounts of the Government for the year for Grants and Charged appropriations are presented in a separate compilation.

The Finance Accounts have been prepared under my supervision in accordance with the requirements of the Comptroller and Auditor General's (Duties, Powers and Conditions of Service) Act, 1971 and have been compiled from the vouchers, challans and initial and subsidiary accounts rendered by the treasuries, offices and departments responsible for the keeping of such accounts functioning under the control of the Government of Tripura and the statements received from the Reserve Bank of India. Statements (8, 9, 10, 19 and 20), explanatory notes to Statements (5 and 20) and appendices (III, IV, VIII, IX, XI and XII) in this compilation have been prepared directly from the information received from the Government of Tripura, which is responsible to ensure the correctness of such information.

The treasuries, offices, and/ or departments functioning under the control of the Government of Tripura are primarily responsible for preparation and correctness of the initial and subsidiary accounts as well as ensuring the regularity of transactions in accordance with the applicable laws, standards, rules and regulations relating to such accounts and transactions. I am responsible for preparation and submission of Annual Accounts to the State Legislature. My responsibility for the preparation of Accounts is discharged through the office of the Accountant General (A&E). The audit of these accounts is independently conducted through the office of the Accountant General (Audit) in accordance with the requirements of Articles 149 and 151 of the Constitution of India and the Comptroller and Auditor General's (Duties, Powers and Conditions of Service) Act, 1971, for expressing an opinion on these accounts based on the results of such audit. These offices are independent organisations with distinct cadres, separate reporting lines and management structure.

The audit was conducted in accordance with the Auditing Standards generally accepted in India. These Standards require that we plan and perform the audit to obtain reasonable assurance that the accounts are free from material misstatement. An audit includes examination, on a test basis, of evidence relevant to the amounts and disclosures in the financial statements.

On the basis of the information and explanations that my officers required and have obtained, and according to the best of my information as a result of test audit of the accounts and on consideration of explanations given, I certify that, to the best of my knowledge and belief, the Finance Accounts read with the explanatory Notes to Accounts give a true and fair view of the financial position, and the receipts and disbursements of the Government of Tripura for the year 2018-19.

Points of interest arising from study of these accounts as well as test audit conducted during the year or earlier years are contained in my Financial, Compliance and Performance Audit Reports on the Government of Tripura being presented separately for the year ended 31 March 2019.

Emphasis of Matter

I want to draw attention to the following significant issues, which are important from the point of view of accuracy, transparency and completeness of these accounts and maintaining legislative financial control over public finances.

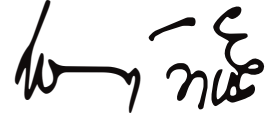
1. Six hundred and forty six Utilisation Certificates (UCs) involving ₹308.93 crore were due for submission by 20 Government Departments as on 31 March 2019. The pace of submission of UCs is not compliant with the conditions governing the grants-in-aid to these Departments. High pendency of UCs is fraught with the risk of misappropriation and fraud, and I am unable to gain assurance that the amounts have been spent for the purpose for which these have been sanctioned/authorised by the Legislature.
2. The State Government permitted all the 1413 Drawing and Disbursing Officers (DDOs) in the State to open bank accounts and in cases where the amount in these accounts crossed ₹five crore, it permitted them to open Personal Ledger (PL) accounts for depositing funds from the Consolidated Fund of the State. During the year 2018-19 the State Government transferred/deposited ₹944 crore into the bank accounts of 970 DDOs and as of

31 March 2019, 311 DDOs had a total closing balance of ₹411.87 crore in their bank accounts. Drawal of money from the Consolidated Fund and keeping in DDOs' bank accounts for further utilization is fraught with the risk of the expenditure moving out of the purview of Legislative oversight, and the funds could also be diverted for other unauthorized purposes.

The audit observations on the above issues have been detailed in the State Finances Audit Report for the year ended March 2019.

Guide to the Finance Accounts

A. Broad overview of the structure of Government accounts

1. The Finance Accounts of the State of Tripura present the accounts of receipts and outgoings of the Government for the year, together with the financial results disclosed by the Revenue and Capital accounts, the accounts of the Public Debt and the liabilities and assets of the State Government as worked out from the balances recorded in the accounts.

2. The Accounts of the Government are kept in three parts:

Part I: The Consolidated Fund comprises two sections: Revenue and Capital (including Public Debt, Loans & Advances). All revenues received by the State Government, all loans raised by the State Government (market loans, bonds, loans from the Central Government, loans from Financial Institutions, Special Securities issued to National Small Savings Fund, *etc.*), Ways and Means advances extended by the Reserve Bank of India and all moneys received by the State Government in repayment of loans. No moneys can be appropriated from this Fund except in accordance with law and for the purposes and in the manner provided by the Constitution of India. Certain categories of expenditure (e.g., salaries of Constitutional authorities, loan repayments, *etc.*), constitute a charge on the Consolidated Fund of the State (Charged expenditure) and are not subject to vote by the Legislature. All other expenditure (Voted expenditure) is voted by the Legislature.

The Consolidated Fund comprises two sections: Revenue and Capital (including Public Debt, Loans & Advances). These are further categorised under 'Receipts' and 'Expenditure'. The Revenue Receipts section is divided into three sectors, *viz.*, 'Tax Revenue', 'Non Tax Revenue' and 'Grants-in-aid and Contributions'. These three sectors are further divided into sub-sectors like 'Taxes on Income and Expenditure', 'Fiscal Services', *etc.* The Capital Receipts section does not contain any sectors or sub-sectors. The Revenue Expenditure section is divided into four sectors, *viz.*, 'General Services', 'Social Services', 'Economic Services' and 'Grants-in-aid and Contributions'. These sectors in the Revenue Expenditure section are further divided into sub-sectors like, 'Organs of State', 'Education, Sports, Art and Culture', *etc.* The Capital Expenditure section is sub-divided into seven sectors, *viz.*, 'General Services', 'Social Services', 'Economic Services', 'Public Debt', 'Loans and Advances', 'Inter-State Settlement' and 'Transfer to Contingency Fund'.

Part II: The Contingency Fund: This Fund is in the nature of an imprest which is established by the State Legislature by law and, is placed at the disposal of the Governor to enable advances to be made for meeting unforeseen expenditure pending authorisation of such expenditure by the State Legislature. The fund is recouped by debiting the expenditure to the concerned functional major head relating to the Consolidated Fund of the State. The Contingency Fund of the Government of Tripura for 2018-19 is ₹ 10.00 crore.

Part III: The Public Account: All other public moneys received by or on behalf of the Government, where the Government acts as a banker or trustee, are credited to the Public Account. The Public Account includes repayables like Small Savings and Provident Funds, Deposits (bearing interest and not bearing interest), Advances, Reserve Funds (bearing interest and not bearing interest), Remittances and Suspense heads (both of which are transitory heads, pending final booking). The net cash balance available with the Government is also included under the Public Account. The Public Account comprises six sectors, *viz.*, ‘Small Savings, Provident Funds, *etc.*’, ‘Reserve Funds’, ‘Deposit and Advances’, ‘Suspense and Miscellaneous’, ‘Remittances’, and ‘Cash Balance’. These sectors are further sub-divided into sub-sectors. The Public Account is not subject to the vote of the Legislature.

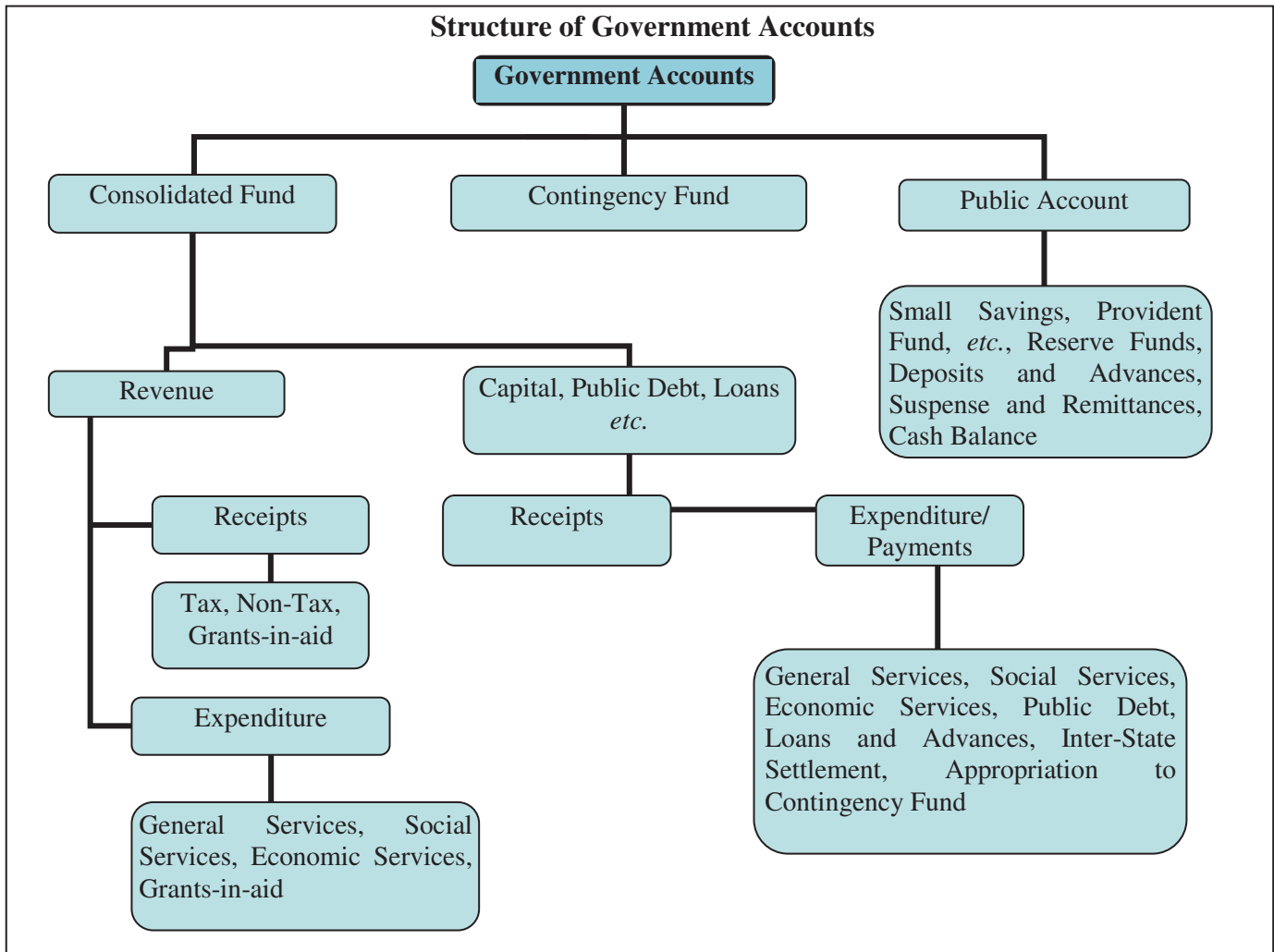
3. Government Accounts are presented under a six tier classification, *viz.*, Major Heads (four digits), Sub-Major Heads (two digits), Minor Heads (three digits), Sub-Heads (two digits), Detailed Heads (two digits), and Object Heads (two digits). Major Heads represent functions of Government, Sub- Major Heads represent sub-functions, Minor Heads represent programmes/activities, Sub-Heads represent schemes, Detailed Heads represent sub-schemes, and Object Heads represent purpose/ object of expenditure.

4. The main unit of classification in accounts is the Major Head which contains the following coding pattern (according to the List of Major and Minor Heads corrected upto 31 March 2019)

0005 to 1606	Revenue Receipts
2011 to 3606	Revenue Expenditure
4000	Capital Receipts
4046 to 7810	Capital Expenditure (including Public Debt, Loans & Advances)
7999	Appropriation to the Contingency Fund
8000	Contingency Fund

5. The Finance Accounts, generally (with some exceptions), depict transactions upto the Minor Head. The figures in the Finance Accounts are depicted at net level, *i.e.*, after accounting for recoveries as reduction of expenditure. This treatment is different from the depiction in the Demands for Grants presented to the Legislature and in the Appropriation Accounts, where, expenditure is depicted at the gross level.

6. A pictorial representation of the structure of accounts is given below:



B. What the Finance Accounts contain

The Finance Accounts are presented in two volumes.

Volume I contains the Certificate of the Comptroller and Auditor General of India, the Guide to the Finance Accounts, thirteen statements which give summarised information on the financial position and transactions of the State Government for the current financial year, Notes to Accounts and eleven annexures to the Notes to Accounts. Details of the **thirteen** statements in Volume I are given below:

1. Statement of Financial Position: This statement depicts the cumulative figures of assets and liabilities of the State Government, as they stand at the end of the year, and as compared to the position at the end of the previous year.

2. Statement of Receipts and Disbursements: This statement depicts all receipts and disbursements of the State Government during the year in all the three parts in which Government accounts are kept, *viz.*, the Consolidated Fund, Contingency Fund and Public Account. In addition, it contains an annexure, showing alternative depiction of Cash Balances (including investments) of the Government. The Annexure also depicts the Ways and Means position of the Government in detail.

3. Statement of Receipts (Consolidated Fund): This statement comprises revenue and capital receipts and borrowings and repayments of the loans given by the State Government. This statement corresponds to detailed statements 14, 17 and 18 in Volume II of the Finance Accounts.

4. Statement of Expenditure (Consolidated Fund): In departure from the general depiction of the Finance Accounts up to the Minor Head level, this statement gives details of expenditure by nature of activity (objects of expenditure) also. This statement corresponds to detailed statement 15, 16, 17, and 18 in Volume II.

5. Statement of Progressive Capital Expenditure: This statement corresponds to the detailed statement 16 in Volume II.

6. Statement of Borrowings and Other Liabilities: Borrowings of the Government comprise market loans raised by it (Internal Debt) and Loans and Advances received from the Government of India. 'Other Liabilities' comprise 'Small Savings, Provident Funds, *etc.*', 'Reserve Funds' and 'Deposits'. The statement also contains a note on service of debt, and corresponds to the detailed Statement 17 in Volume II.

7. Statement of Loans and Advances given by the Government: This statement depicts all loans and advances given by the State Government to various categories of loanees like Statutory Corporations, Government Companies, Autonomous and Other Bodies/ Authorities and recipient individuals (including Government servants). This statement corresponds to the detailed statement 18 in Volume II

8. Statement of Investments of the Government: This statement depicts investments of the State Government in the equity capital of Statutory Corporations, Government Companies, other Joint Stock Companies, Co-operative Institutions and Local Bodies. This statement corresponds to the detailed statement 19 in Volume II

9. Statement of Guarantees given by the Government: This statement summarises the guarantees given by the State Government on repayment of principal and interest on loans raised by Statutory Corporations, Government Companies, Local Bodies and Other institutions. This statement corresponds to the detailed statement 20 in Volume II.

10. Statement of Grants-in-aid given by the Government: This statement depicts all Grants-in-aid given by the State Government to various categories of grantees like Statutory Corporations, Government Companies, Autonomous and Other Bodies/Authorities and individuals. Appendix III provides details of the recipient institutions.

11. Statement of Voted and Charged Expenditure: This statement assists in the agreement of the net figures appearing in the Finance Accounts with the gross figures appearing in the Appropriation Accounts.

12. Statement on Sources and Application of Funds for Expenditure other than on Revenue Account: This statement is based on the principle that revenue expenditure is expected to be defrayed from revenue receipts, while capital expenditure of the year is met from revenue surplus, net credit balances in the public account, cash balance at the beginning of the year, and borrowings.

13. Summary of balances under Consolidated Fund, Contingency Fund and Public Account: This statement assists in proving the accuracy of the accounts. The statement corresponds to the detailed statement 14,15,16,17,18 and 21 in Volume II.

Volume II of the Finance Accounts contains two parts – nine detailed statements in Part – I and twelve Appendices in Part II.

Part I of Volume II

14. Detailed Statement of Revenue and Capital Receipts by Minor Heads: This statement corresponds to the summary statement 3 in Volume I of the Finance Accounts.

15. Detailed Statement of Revenue Expenditure by Minor Heads: This statement, which corresponds to the summary statement 4 in Volume I, depicts the revenue expenditure of the State Government under State Fund Expenditure and Central Assistance (including Centrally Sponsored Schemes and Central Schemes). Charged and Voted expenditure are exhibited distinctly.

16. Detailed Statement of Capital Expenditure by Minor Heads and Sub Heads: This statement, which corresponds to the summary statement 5 in Volume I, depicts the capital expenditure (during the year and cumulatively) of the State Government under State Fund Expenditure and Central Assistance (including Centrally Sponsored Schemes and Central Schemes). Charged and Voted expenditure are exhibited distinctly. In addition to representing details of capital expenditure at Minor Head level, in respect of significant schemes, this statement depicts details at Sub-head levels also.

17. Detailed Statement of Borrowings and Other Liabilities: This statement, which corresponds to the summary statement 6 in Volume I, contains details of all loans raised by the State Government (market loans, bonds, loans from the Central Government, loans from Financial Institutions, Special Securities issued to National Small Savings Fund, *etc.*), and Ways and Means advances extended by the Reserve Bank of India. This statement presents the information on loans under three categories: (a) details of individual loans; (b) maturity profile, *i.e.*, amounts payable in respect of each category of loans in different years; and (c) interest rate profile of outstanding loans and annexure depicting Market Loans.

18. Detailed Statement on Loans and Advances given by the Government: This statement corresponds to the summary Statement 7 in Volume I.

19. Detailed Statement of Investments of the Government: This statement depicts investments entity wise and Major and Minor Head wise details of discrepancies, if any, between Statements 16 and 19. This statement corresponds to Statement 8 in Volume I

20. Detailed Statement of Guarantees given by the Government: This statement depicts entity wise details of government guarantees. This statement corresponds to Statement 9 in Volume I.

21. Detailed Statement on Contingency Fund and Other Public Account transactions: This statement depicts at Minor Head level the details of un-recouped amounts under Contingency Fund, consolidated position of Public Accounts transactions during the year, and outstanding balances at the end of the year.

22. Detailed Statement on Investment of Earmarked Funds: This statement depicts details of investments from the Reserve Funds and Deposit (Public Account).

Part II of Volume II

Part II contains twelve appendices on various items including salaries, subsidies, grants-in-aid, externally aided projects, scheme wise expenditure in respect of major Central Schemes and State Schemes, *etc.* These details are present in the accounts at Sub head level or below (*i.e.* below Minor Head levels) and so are not generally depicted in the Finance accounts. A detailed list of appendices appears at the 'Index' in Table of Contents. The statements read with the appendices give a complete picture of the state of finances of the State Government.

D. Periodical adjustments and Book adjustments:

Certain transactions that appear in the accounts do not involve actual movement of cash at the time of booking. Some of these transactions take place at the level of the account rendering units (e.g. treasuries, divisions, *etc.*) themselves. For instance, transactions involving adjustment of all deductions (GPF, recoveries of advances given, *etc.*) from salaries are recorded by debiting functional major heads (pertaining to the concerned department) by book adjustment to revenue receipt/loans/public account. Similarly 'nil' bills where moneys transferred between the Consolidated Fund and Public Account represent non-cash transactions occurring at the level of the accounts rendering units.

In addition of the above, the Principal Accountant General/Accountant General (A&E) carries out periodical adjustment and book adjustments of the following nature in the accounts of the State Government, details of which appear in Annexure A (Volume I) and footnotes to the relevant statements.

Examples of periodical adjustments and book adjustments are given below:

(1) Creation of funds/ adjustment of contribution to Funds in Public Account by debit to Consolidated Fund e.g., State Disaster Response Fund, Central Road Fund, Sinking Fund, *etc.*

(2) Crediting of deposit heads of accounts in Public Account by debit to Consolidated Fund.

(3) Annual adjustment of interest on General Provident Fund (GPF) and State Government Group Insurance Scheme where interest is adjusted by debiting Major Head 2049-Interest and crediting Major Head 8009-State Provident Fund and Major Head 8011-Insurance and Pension Fund.

(4) Adjustment of Debt waiver under the scheme of Government of India based on the recommendations of Central Finance Commissions. These adjustments (where Central loans are written off by crediting Major Head 0075-Misc. General Services by contra entry in the Major Head 6004-Loans and Advances from the Central Government) impact both Revenue Receipts and Public Debt heads.

E. Rounding:

Difference of ₹0.01 lakh/crore, wherever occurring, is due to rounding.

Explanatory Notes

(a) **Cash and Cash Equivalents:** Cash and cash equivalents consist of cash in treasuries and deposit with Reserve Bank of India (RBI) and other Banks and Remittances in Transit. The balance under the head 'Deposits with Reserve Bank' depicts the combined balance of the Consolidated Fund, Contingency Fund and the Public Account at the end of the year. To arrive at the overall cash position, the cash balances with treasuries, departments and investments out of the cash balances/reserve funds, *etc.* are added to the balance in 'Deposits with RBI'.

(b) **Daily Cash Balance:** Under an agreement with the Reserve Bank of India, the State Government has to maintain a minimum cash balance of ₹0.29 crore with the Bank. If the balance falls below the agreed minimum on any day, the deficiency is made good by taking ordinary and special ways and means advances/overdrafts from time to time.

For arriving at the daily cash balance¹ for the purpose of grant of Ways and Means advances/Overdraft, the RBI evaluates the holdings of the 14 days/91 days treasury bills along with the transactions reported (at RBI counters, Inter-Government transactions and Treasury transactions reported by the agency banks) for the day. To the cash balance so arrived, the maturity of 14 days/91 days Treasury Bills if any, is added and excess balance, if any, after maintaining the minimum cash balance is reinvested in Treasury Bills. **If the net cash balance arrived at results in less than the minimum cash balance** or a credit balance and if there are no 14 days/91 days treasury bills maturing on that day, RBI rediscounts the holdings of the 14 days/91 days Treasury Bills and makes good the shortfall. If there is no holding of 14 days/91 days Treasury Bills on that day the State Government applies for Ways and Means Advances/Special Ways and Means Advances/Over Draft.

Explanatory Notes to Statement 6

1. Amortization arrangements: In accordance with the guidelines issued by the Reserve Bank of India, Government has constituted a fund called “Consolidated Sinking Fund Scheme” of the Government of Tripura. The fund is to be utilized as an Amortization Fund for redemption of the internal debt and public account liabilities of the Government. An amount of ₹32.72 crore as interest earned on Sinking Fund-Investment Account, has been credited to the Fund during the year 2018-19. During the year 2018-19 an amount of ₹1,06.95 crore has been withdrawn by the State Government from the Fund for redemption of internal debt. The total balance of the Fund as on 31 March 2019 stood at ₹2,94.79 crore.

2. Loans from Small Saving Fund: Loans out of the collection in the ‘Small Savings Schemes’ and ‘Public Provident Fund’ in the Post offices are being shared between the State Government and the Central Government in the ratio of 3:1. A separate fund *viz.* ‘National Small Savings Fund’ was created in 1999-2000 for the purpose of release of loans out of Small Savings collections. No loan has been received during the year 2018-19, however an amount of ₹1,15.26 crore was repaid during the year. The balance outstanding at the end of the year was ₹11,93.36 crore which was 13.49 *per cent* of the total Public Debt of the State Government as on 31 March 2019.

3. Loans and Advances from Central Government - Decrease in indebtedness: The balance of Loans and Advances from the Central Government decreased during 2018-19 by ₹18.80 crore. During 2018-19, the State Government received Block Loans amounting to ₹0.30 crore for Externally Aided Project (EAP) and other loans for Urban Development amounting to ₹12.74 crore. The loans from the Central Government as on 31 March 2019 constituted 2.45 *per cent* of the total Public Debt of the State Government as on that date.

4. Market loans bearing interest : These are long term loans (which have a currency of more than 12 months) raised in the open market. During the year ₹15,42.83 crore of loan by way of auctioning Government Stock *i.e.* (i) ₹5,00.00 crore (ii) ₹2,00.00 crore (iii) ₹2,00.00 crore (iv) ₹2,42.83 crore (v) ₹2,00.00 crore and (vi) ₹2,00.00 crore was raised redeemable at par in the year 2028 and 2029 carrying interest rates of 8.20 *per cent*, 8.43 *per cent*, 8.82 *per cent*, 8.09 *per cent*, 8.38 *per cent* and 8.27 *per cent* respectively.

5. Market loans not bearing interest: These are unclaimed balance of matured loans which have been notified for discharge and have ceased to bear interest from the due date of discharge. During the year an amount of ₹30,000 has been written off by the RBI.

6. Service of debt - Interest on debt and other obligations : The outstanding gross debt and other obligations and the total net amount of interest charges met from revenue during 2017-18 and 2018-19 were as shown below:-

B. Government Account :- Under the system of book keeping followed in Government Accounts, the amount booked under revenue, capital and other transactions of Government, the balances which are not carried forward from year to year in the accounts are closed to a single head called "Government Account". The balance under this head represents the cumulative result of all such transactions.

To this, the balances under Public Debt, Loans and Advances, Small Savings, Provident Fund, Reserve Funds, Deposits and Advances, Suspense and Miscellaneous (other than miscellaneous Government Account), Remittances and Contingency Fund etc., are added and the closing cash balance at the end of the year is to be worked out and proved.

The other headings in the summary take into account the balances under all accounts heads in Government books in regard to which Government has a liability to repay the money received or has a claim to recover the amounts paid and also heads of account opened in the books for adjustment of remittance transactions.

It must be understood that these balances can not be regarded as complete record of the financial position of the Government as it does not take into account all the physical assets of the State, such as lands, buildings, communications etc., nor any accrued dues or outstanding liabilities which are not brought to account under cash basis of accounting followed by Government.

Notes to Accounts**1. Summary of Significant Accounting Policies:****(i) Entity and Accounting Period:**

These accounts present the transactions of the Government of Tripura for the period from 1 April 2018 to 31 March 2019 and have been compiled from the initial and subsidiary accounts rendered by nine District Treasuries, one e-Treasury, 53 Public Works Divisions, 39 Forest Divisions/Sub-Divisions and Advices of the Reserve Bank of India. Despite delays in rendition of monthly accounts which ranged from one to 25 days by Treasuries, one to 59 days by Public Works and one to 17 days by Forest Divisions, no accounts have been excluded at the end of the year.

(ii) Basis of Accounting:

With the exception of some book adjustments (**Annexure A**), the accounts represent the actual cash receipts and disbursements during the account period. Physical Assets and Financial Assets such as investments *etc.* are shown at historical cost, *i.e.*, the value at the year of acquisition/purchase. Physical assets are not depreciated or amortized. Losses of physical assets at the end of their life are not expensed or recognized.

The pension liability of the Government, *i.e.*, the liability towards payment of retirement benefits for the past and the present service of its employees is not included in the accounts.

(iii) Currency in which Accounts are kept:

The accounts of Government of Tripura are maintained in Indian Rupees.

(iv) Form of Accounts:

Under Article 150 of the Constitution of India, the accounts of the Union and of the States are kept in such form as the President may, on the advice of the Comptroller and Auditor General of India, prescribe. The word “form” used in Article 150 has a comprehensive meaning so as to include the prescription not only of the broad form in which the accounts are to be kept, but also the basis for selecting appropriate heads under which the transactions are to be classified.

(v) Classification under Revenue and Capital:

Revenue expenditure is recurring in nature and is intended to be met from revenue receipts. Capital expenditure is defined as expenditure incurred with the object of increasing concrete assets of a material and permanent character or of reducing permanent liabilities. Further, as per the Indian Government Accounting Standard (IGAS 2), expenditure on Grants-in-aid is to be classified as Revenue expenditure regardless of end use.

However, the Government of Tripura have incorrectly classified budget provision and incurred expenditure under Grants for creation of Capital Assets (Object Head 57) of ₹661.74 crore within the capital heads of account instead of revenue heads. Details have been provided in **Annexure–B**. Such misclassification violates the Accounting Standards which ultimately resulted Revenue Surplus during 2018-19 and has also impact on other fiscal parameters of the State.

(vi) Compliance of Accounting Standards:

Government of India notified three Accounting Standards (IGAS) which are as follows:

- a. Guarantees given by Governments : Disclosure Requirements (IGAS 1)
- b. Accounting and classification of Grants-in-aid (IGAS 2)
- c. Loans and advances made by Governments (IGAS 3)

These standards are required to be followed in the preparation of Finance Accounts of Government of Tripura.

2. Quality of accounts:

(i) Goods and Services Tax (GST): The total receipts under Goods and Services Tax for the State of Tripura including State share of net proceeds received from Central Government was ₹2,280.48 crore during 2018-19. The total collection of the State Government under State Goods and Services Tax (SGST) was ₹977.44 crore including ₹128.07 crore on account of advance apportionment of IGST from the Government of India. An amount of ₹96.30 crore and ₹1,206.74 crore was assigned to the State Government under Integrated Goods and Services Tax (IGST) and Central Goods and Services Tax (CGST) respectively, on the basis of the recommendations of the Fourteenth Finance Commission. The State Government received Compensation of ₹155.00 crore during 2018-19 on account of loss of revenue arising out of implementation of GST.

(ii) Booking under Minor Head 800-‘Other Receipts’ and ‘Other Expenditure’:

The third tier of classification in Government account is called Minor Head of account and represents programme/activity. Government accounting system has a standardized list of programmes common to both Union and the State Governments. The programmes/activities which are not found in this standardised list are classified under Minor Head 800-Other Receipts/Other Expenditure. Routine operation of Minor Head 800 is to be discouraged, since it renders the accounts opaque.

During the year, the State Government classified receipt of ₹260.96 crore in 41 Major Heads of Accounts, under the Minor head 800-Other Receipts constituting 2.17 *per cent* of the total

Revenue Receipts (₹12,030.89 crore). Similarly, they booked expenditure of ₹229.94 crore in 46 Major Heads of Accounts, under Minor Head 800-Other Expenditure constituting 1.72 per cent of the total Revenue and Capital Expenditure (₹13,370.07 crore). Instances of substantial proportion (more than 10 per cent) of the receipts and expenditure classified under Minor Head 800 - Other Receipts and Other Expenditure are listed in **Annexure C and D** respectively.

(iii) Unadjusted Abstract Contingent (AC) bills:

Financial rules¹ envisage that no moneys should be drawn from government treasury unless it is required for immediate disbursement. In exceptional circumstances, money is drawn through the instrument called Abstract Contingent (AC) bills for which Rule 31(12) of Delegation of Financial Power Rules, 2019 of Government of Tripura, envisage that necessary documentation in form of Detailed Countersigned Contingent (DCC) bills should be submitted within 60 days from the date of the drawl of concerned AC bills, to show actual utilization for the stated purpose of the funds drawn. The subsequent drawal of the money through AC bill is permissible only on submission of previous pending DCC bills. The non-submission of DCC bills for long periods is fraught with the risk of fraud, embezzlement and/or avoidable interest on idle funds outside treasury. The year wise pendency of the DCC bills is being given below in Table 1:-

(iv) Utilization Certificates (UCs):

Rule 238 (1) of General Financial Rules 2017 envisage that in respect of non-recurring Grants to an Institution or Organisation, a certificate of actual utilization of the Grants received for the purpose for which it was sanctioned should be insisted upon in the order sanctioning the Grants-in-aid. The Utilization Certificate (UC) should be submitted within twelve months of the closure of the financial year by the Institution or Organisation concerned unless specified otherwise. The receipt of such certificate shall be scrutinized by the Ministry or Department concerned. The UCs outstanding beyond the specified periods indicates absence of assurance on utilization of the grants for intended purposes.

The status of pending UCs for non-recurring grants-in-aid receivable by the State Government² against its own programme/schemes, were as follows:

In absence of Utilisation Certificates, it could not be assured that the grants given by the Government were utilized for the stated/intended purpose.

(v) Reconciliation of Receipts and Expenditure between Chief Controlling Officers (CCOs) and Accountant General (A&E): Reconciliation is an essential accounting and internal control process to detect misclassification, fraud and error in the Government Accounts. It also ensures effective control on expenditure to keep it within the budget grants and accuracy of accounts. Accordingly, all Chief Controlling Officers (CCOs) are required to reconcile the figures of Receipt and Expenditure of the Government with the figures accounted for by the Accountant General. During the year, all the 63 CCOs of the Government have reconciled hundred *per cent* receipts and expenditure of ₹12,030.89 crore and ₹13,869.24 crore (including expenditure on public debt and loans and advances) respectively.

(vi) Difference in Cash Balance:

As per Annexure A of Statement 2, the State Government has cash balance and investment of cash balance of ₹968.52 crore as on 31 March 2019. There was a net difference of ₹21.10 crore (Credit) between the figures reflected in the accounts of Accountant General (A&E) and that intimated by the Reserve Bank of India as on 31 March 2019. This difference is mainly due to erroneous reporting by the accredited banks to the Reserve Bank of India, Nagpur, which is responsible for maintaining the Cash Balance of the State Government. After reconciliation, the difference still stood at ₹26.75 crore (Net Debit) as on 30 June 2019.

3. Other Items:

i) Major types of Cess levied by the State Government:

(a) Labour Cess : The Tripura Building and Other Construction Workers' Welfare Board collects labour cess in accordance with provisions of the Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Act, 1996 (Central Act) to secure social security benefits to the workers engaged in building and other construction works. The proceeds of labour cess are collected and maintained outside Government Accounts and kept in the bank account of the board. The amount of labour cess collected and spent during the period of last five years, are as follows:

(b) Tripura Road Development Cess: The State Government has passed Tripura Road Development Cess Act, 2018 in the month of August 2018 with the purpose of developing the Roads in the States. The Government has levied Cess on Petrol, Diesel and Natural Gas for the purpose of this fund. The cess collected during the year 2018-19 was ₹27.75 crore and the same amount were transferred to the Government Account under Major Head 0045-112- Receipts from Cesses under other Acts. However, the collected proceeds were not transferred to the Road Development Fund in Public Account and to that extent, the fund has not been created.

(ii) National Pension System (NPS):

Government of Tripura incurred ₹2,036.49 crore (17.13 *per cent* of total revenue expenditure) on pension and other retirement benefits of State Government employees and entitled officials during the reporting year. This included defined pension contribution towards All India Services Officers borne on the Tripura cadre and recruited on or after 01 January 2004. Meanwhile, the State Government has adopted the National Pension System (NPS) for its employees recruited on or after July 2018. In terms of the scheme, the employee contributes 10 *per cent* of basic pay and dearness allowances, an equivalent amount is paid by the Government, and the entire amount is transferred to the designated fund manager through the National Securities Depository Limited (NSDL) / Trustee Bank.

During the year, the Government of Tripura initially deposited ₹0.81 crore (employees' contribution ₹0.41 crore and Government contribution ₹0.40 crore) into the fund created under the Major Head 8342-117- Defined Contributory Pension Scheme and transferred an amount of ₹0.57 crore (including ₹0.02 crore of last year) to NSDL during the year 2018-19. The un-transferred amount of ₹0.26 crore for the year 2018-19 with accrued interest represents outstanding liability of the Government.

(iii) Guarantees:

The State Government extends guarantee on the loans taken from financial institutions by State Government entities like Public Sector undertakings *etc.* Guarantees reported in Statements 9 and 20 are based on information received from the Finance Department, which is the authority for issuing such guarantees. The Tripura Fiscal Responsibility and Budget Management (FRBM) Act, 2005 limits the amount of annual incremental risk weighted guarantees to 1 *per cent* of the Gross State Domestic Product (GSDP) of that year, within which, the

Government may give guarantee on the security of the Consolidated Fund of the State. The manner in which the Government assigns weights to the loans taken by these entities has not been intimated by Government of Tripura.

During 2018-19, the State Government gave guarantees amounting to ₹230.00 crore which was 0.46 *per cent* of the GSDP. The total guarantees (principal plus interest) outstanding as on 31 March 2019 was ₹523.67 crore (1.04 *per cent* of the GSDP). However, the State Government has not furnished any information of the guarantees given in respect of Irrigation, Road and Transport, State Financial Corporation, Urban Development and Housing, Municipalities/University/Local Bodies etc.

(iv) Reserve Funds and Deposits:

Reserve Funds are created for specific purposes out of contribution from the Consolidated Fund. Information on Reserve Funds and deposits ('interest bearing' and 'non-interest bearing') and the investments from the earmarked funds are available in Statements 21 and 22 respectively.

There were four Reserve Funds earmarked for specific purposes, out of which one was inactive. The total accumulated balance at the end of 31 March, 2019 in these funds was ₹544.91 crore (₹540.70 crore in active funds and ₹4.21 crore in inactive fund), out of which ₹299.28 crore (54.92 *per cent*) was invested.

Interest bearing Reserve Funds:

(a) State Disaster Response Fund (SDRF):

The State Government constituted the State Disaster Response Fund (SDRF) on 28 May 2011 in terms of the recommendations of the Thirteenth Finance Commission. As per the Fourteenth Finance Commission recommendations, the corpus of SDRF of Tripura for the year 2018-19 was fixed at ₹36.00 crore. Under the guidelines of the Fund, the Centre and Special Category States like Tripura are required to contribute to the Fund in the proportion of 90:10. As per the guidelines, these contributions are to be transferred to the Public Account under Major Head-8121, by operating the Expenditure Major Head - 2245. Expenditure incurred during the year on disaster response is adjusted by debiting the Public Account with contra deduct debit to the Expenditure Major Head - 2245. Balances outstanding in the Fund, at the end of the year, are to be invested.

Non-interest bearing Reserve Funds:**(b) Consolidated Sinking Fund (CSF):**

Government of Tripura created a Consolidated Sinking Fund (CSF) in 1999-2000 for amortization of Government loans. The fund has been revised as 'Consolidated Sinking Fund Scheme' by the State Government vide Gazette Notification dated 16th January 2018, effective from the financial year 2017-18. According to the Gazette Notification, States may contribute at least 0.5 *per cent* of the outstanding liabilities (public debt plus public account liabilities) as at the end of the previous year.

However, withdrawal of ₹106.95 crore was made during 2018-19 for the purpose of clearing of internal debt. The response of the State Govt. regarding non-contribution is awaited (January 2020).

(c) Guarantee Redemption Fund (GRF):

The State Government constituted a Guarantee Redemption Fund on 12 July 2007. The fund has been revised as 'Guarantee Redemption Fund Scheme' by the State Government vide Gazette Notification dated 29th January 2016, effective from the financial year

2015-16 and subsequent notification dated 16th January 2018 effective from the financial year 2017-18. As per the revised guidelines, the Government shall contribute minimum 0.5 *per cent* of outstanding guarantees every year to achieve a minimum level of 3 *per cent* of outstanding guarantees in next five years and gradually to a desirable level of 5 *per cent*.

The status of the fund as on 31 March 2019 was as follows:

(d) Inoperative Reserve Funds: There is only one inoperative Reserve Fund namely General Reserve Fund of Government Commercial Departments/Undertakings having balance of ₹4.21 crore as on 31 March 2019.

(v) Non-discharge of Interest liabilities:

The interest liabilities in respect of Reserve Funds bearing interest under Sector J of the Public Accounts are annual liabilities that the State Government is required to discharge. During the year the State Government did not invest any money out of available balance of ₹93.79 crore as on 1 April 2018 under Reserve Funds bearing interest. Interest liability accruing on the fund balance of ₹93.79 crore was ₹7.03 crore (calculated at 7.5 *per cent* which is average of Ways and Means Advances interest rate during 2018-19).

(vi) Central Road Fund (CRF):

As per accounting rules, grants received from Government of India towards Central Road Fund (CRF) are initially credited to Major Head 1601- Grants-in-aid from Central Government. Thereafter, the amount so received is to be transferred by the State Government to the Deposit Head (under Major Head 8449-Other Deposits, 103- Subventions from Central Road Fund) through the Revenue Expenditure Major Head '3054-Roads and Bridges'. The expenditure on prescribed road works under CRF will first be accounted for under the relevant Capital or Revenue Expenditure section (Major Heads 5054 or 3054) and reimbursed out of the Public

Account under Major Head 8449 as a deduct expenditure to the concerned Major Head (5054 or 3054 as the case may be).

During the year, the State Government received grants of ₹3.44 crore towards CRF and transferred an amount of ₹3.51 crore (including some balance of last year) to the Deposit Head 8449 through Capital expenditure Head 5054 instead of Revenue expenditure Head 3054 and expended the same amount from the Deposit head leaving the nil balance in the fund.

(vii) Suspense and Remittances:

The Finance Accounts reflect the net balances under Suspense and Remittance Heads. The outstanding balances under these heads are worked out by aggregating the outstanding debit and credit balances separately under various heads. The position of gross balances under major suspense heads for the last three years is given in **Annexure -E**.

(viii) Excess Expenditure and Savings:

During the year, the Government of Tripura had overall saving of ₹2,788.89 crore under 42 grants. However, there was excess expenditure of ₹20.94 crore over the authorization made by the State Legislature under 10 grants during the year 2018-19. This is in violation of Article 204 and 205 of the Constitution which provide that no money shall be withdrawn from the Consolidated Fund of State except under appropriation made by law by the State Legislature. This vitiates the system of budgetary and financial control and encourages financial indiscipline in management of public resources and will need to be regularized under Article 205 of the Constitution.

Moreover, there were significant savings/variations (20 per cent and above in each case) between the total grant or appropriation and expenditure incurred aggregating ₹2,788.89 crore under 42 grants for which appropriate reasons have not been provided by the Controlling Officers.

(ix) Rush of expenditure:

Financial Rules³ envisage that rush of expenditure, particularly in the closing months of the Financial year, shall be regarded as a breach of financial propriety and shall be avoided. During March 2019, however, the State Government incurred expenditure of ₹2,001.44 crore out of which, ₹22.95 crore was incurred on the last working day of March 2019 which constitutes 59.46 *per cent* and 0.68 *per cent* respectively of revenue receipts of ₹3,366.04 crore (including Grants of ₹1555.66 crore received from Central Government) during the month of February 2019 and March 2019.

(x) Grants/Loans given to State Public Sector Undertakings (SPSUs) whose accounts are in arrears:

Out of 14 State PSUs, the accounts of eight SPSUs were in arrear ranging from one year to three years upto the end of 31 March 2019. As per available information, Grants of ₹32.47 crore has been given to SPSUs during the year 2018-19 by the State Government. However, Grants/Loans given to one SPSU in the year 2018-19, whose accounts have not been finalized by the SPSU as per the detail given below:

(xi) Transfer of funds from Capital Head of Account to Deposit Heads:

During the reporting year the State Government transferred ₹2.48 crore from Capital Head of accounts to Deposit Head (MH 8443-00-800-Other Deposits) through book adjustment. **Annexure-G** gives the detailed break up. The reason for transfer of fund from Capital Head of Account to Deposit Head has not been intimated by the State Government.

(xii) Incomplete projects aged five years and more:

There are eight number of incomplete projects (estimate cost of ₹5 crore and above) aged five years and more with total escalation cost of ₹6.28 crore. The details are at **Annexure-H**.

(xiii) Loans and Advances:

Annexure A to Appendix-VII depict details of Loans and Advances as required under the Indian Government Accounting Standards (IGAS 3) notified by the Government of India. The information is incomplete, since detailed information of overdue principal and interest in respect of Loans and Advances where the accounts are maintained by the State Government has not been furnished by the State Government. As on 31 march 2019, the outstanding balance of Loans and Advances is ₹193.51 crore as per accounts maintained by the Accountant General (A&E), including actual figures in respect of individual loanee accounts, but the State Government has not confirmed the balances as on 31 March 2019, though they were asked to do so before closing of annual accounts (January 2020).

(xiv) Investments:

Information on Government investment appearing in Statements 8 and 19 of the Finance Accounts is based on the vouchers received by the Accountant General and confirmed by the State Government. During 2018-19, the Government has invested ₹58.70 crore in 16 entities. The Government also received dividend of ₹1.64 crore from North East Transmission Company Ltd. and ₹0.50 crore from ONGC Tripura Power Company Ltd. However, the detail information of investment in North East Transmission Company Ltd. and ONGC Tripura Power Company Ltd. has not been received from the State Government, the same could not be incorporated in Statement 8 and 19 of the Finance Accounts.

(xv) Notional Expenditure and Balances in Current Deposit and Savings Bank Accounts:

Reserve Bank of India's circular DBOD No.Dir.BC.34/13/3/00/2000-01 dated 17 October 2000 facilitated Government Departments to open savings/current bank accounts to implement various centrally sponsored schemes/State schemes. The Government of India subsequently has decided to transfer funds to implement CSS schemes through State Government (Treasury route) from the financial year 2014-15.

The transfer of moneys out of Consolidated Fund of the State into DDO's bank accounts (outside government accounts) was made possible by the Government of Tripura's order of July 2005. Subsequently, the State Government has issued order in December 2016 and in February 2017 for closure of Current Deposit/Savings Bank Accounts of Drawing and

Disbursing Officers (DDOs) of all Departments by 31 March 2017 and instructed all DDOs to deposit the unspent balance lying in CD/SB accounts into Government account. However, the above said order of the State Government has not fully complied by all the DDOs. Out of 1413 DDOs, 311 DDOs had a closing balance of ₹411.87 crore as of 31 March 2019. Moreover, during the year 2018-19, the Government of Tripura transferred/deposited ₹944 crore into bank accounts of 970 DDOs for disbursement. The actual date of disbursement of above amount to end user/beneficiaries was unascertainable and to that extent the said expenditure was notional.

(xvi) Status of e-payment:

With effect from May 2017, Government of Tripura has started e-payment using RBI's e-Kuber application. All treasury payments except those relating to regular pension are being made through e-payment. The status of e-payment during last two financial years was as follows:

(xvii) Write off of Central Loans:

In furtherance of the recommendations of the Thirteenth Finance Commission, Ministry of Finance, Government of India, in a series of orders, all dated 29 February 2012, wrote off loans advanced to the State Government by various Ministries (except those advanced by the Ministry of Finance itself) as on 31 March 2010 towards Central Plan and Centrally Sponsored Schemes. In respect of Govt. of Tripura, excess payment of ₹6.88 crore was made after effective date. Ministry of Finance permitted the State Government to adjust the excess repayments of principal and interest made from the effective date of the order (31 March 2010) and its implementation against future repayments to the Ministry of Finance. Ministry of Finance has so far adjusted ₹3.90 crore including adjustment of ₹1.34 crore during the year 2018-19 against the outstanding loan of the State Government leaving a balance amount of ₹2.98 crore pending for adjustment in the books of the State Government. This has resulted in overstatement of Public Debt of the State Government to that extent.

(xviii) Operation of Personal Ledger (PL) Accounts:

Personal Ledger (PL) Accounts kept in the Public Account are like banking accounts, facilitating the designated Government Officer to keep the receipts therein and spend them for specific approved purpose. The State Government is authorized to open Personal Ledger (PL) accounts to deposit funds required for specific purpose by transfer of funds from Consolidated Fund or by transfer of funds other than from the Consolidated Fund. During the year 2018-19, the State Government had taken a policy decision to transfer funds from Bank Accounts of DDOs to PL Accounts with the concurrence of the Accountant General (A&E), where Bank balance of a particular DDO exceeds ₹2.00 crore except funds of Central Schemes, where it is mandatorily required to be kept in separate Bank account as per Scheme guidelines. The State Government has opened 102 PL Accounts during the year 2018-19 and the status of such PL Accounts (under MH 8443-106) was as under:

(xix) Direct transfer of Central Scheme Funds to implementing Agencies in the State (Funds routed outside State budget):

From 1 April 2014, as per Government of India's decision, all central assistance relating to the Central Schemes are to be routed through the State Government. However, it has been seen from the position available on the PFMS portal of the Controller General of Accounts (CGA), that Government of India released ₹442.79 crore directly to the implementing agencies instead of routing the State Government. Details are at **Appendix-VI**.

(xx) Disclosures under the Tripura Fiscal Responsibility and Budget Management Rules framed under the Tripura Fiscal Responsibility and Budget Management (FRBM) Act, 2005:
