INTRODUCTORY

This compilation containing the Appropriation Accounts of the Government of Meghalaya for the year 2002-2003 presents the accounts of sums expended in the year ended 31st March, 2003 compared with the sums specified in the Schedules appended to the Appropriation Acts passed under Articles 204 and 205 of the Constitution of India.

Within a grant/appropriation, funds are provided, wherever necessary, separately for 'General' and 'Sixth Schedule (Part II) Areas ', the authorisation of the Legislature is, however, obtained for the total sums required. The distribution of the grants/appropriations and expenditure between 'General' and 'Sixth Schedule (Part II) Areas' has been shown as a note under the concerned Appropriation Accounts.

'O' stands for Original grant or Appropriation

'S' stands for Supplementary grant or Appropriation

`R'

stands for re-appropriations, withdrawals or surrenders sanctioned by a competent authority


