Certificate of the Comptroller and Auditor General of India

This compilation containing the Finance Accounts of the Government of Punjab for the year ending 31 March 2019 presents the financial position along with accounts of the receipts and disbursements of the Government for the year. These accounts are presented in two Volumes, Volume-I contains the consolidated position of the state of finances and Volume-II depicts the accounts in detail. The Appropriation Accounts of the Government for the year for Grants and Charged Appropriations are presented in a separate compilation.

The Finance Accounts have been prepared under my supervision in accordance with the requirements of the Comptroller and Auditor General's (Duties, Powers and Conditions of Service) Act, 1971 and have been compiled from the vouchers, challans and initial and subsidiary accounts rendered by the treasuries, offices and departments responsible for the keeping of such accounts functioning under the control of the Government of Punjab and the statements received from the Reserve Bank of India. Statements (9, 20) and Appendix VIII in this compilation have been prepared directly from the information received from the Government of Punjab who is responsible to ensure the correctness of such information. Appendix V has been prepared from the details collected from the Public Financial Management System portal of the Controller General of Accounts.

The treasuries, offices and departments functioning under the control of the Government of Punjab are primarily responsible for preparation and correctness of the initial and subsidiary accounts as well as ensuring the regularity of transactions in accordance with the applicable laws, standards, rules and regulations relating to such accounts and transactions. I am responsible for preparation and submission of Annual Accounts to the State Legislature. My responsibility for the preparation of Accounts is discharged through the office of the Accountant General (A&E). The audit of these accounts is independently conducted through the office of the Principal Accountant General (Audit) in accordance with the requirements of Articles 149 and 151 of the Constitution of India and the Comptroller and Auditor General's (Duties, Powers and Conditions of Service) Act, 1971, for expressing an opinion on these Accounts based on the results of such audit. These offices are independent organizations with distinct cadres, separate reporting lines and management structure.

The audit was conducted in accordance with the Auditing Standards generally accepted in India. These Standards require that we plan and perform the audit to obtain reasonable assurance that the accounts are free from material misstatement. An audit includes examination, on a test basis, of evidence relevant to the amounts and disclosures in the financial statements.

On the basis of the information and explanations that my officers required and have obtained, and according to the best of my information as a result of test audit of the accounts and on consideration of explanations given, I certify that, to the best of my knowledge and belief, the Finance Accounts read with the explanatory 'Notes to Accounts' give a true and fair view of the financial position, and the receipts and disbursements of the Government of Punjab for the year 2018-19.

Points of interest arising from study of these accounts as well as test audit conducted during the year or earlier years are contained in my Financial, Compliance and Performance Audit Reports on the Government of Punjab being presented separately for the year ended 31 March 2019.

Emphasis of Matter

I want to draw attention to the following significant issues which are important from the point of view of accuracy, transparency and completeness of these accounts and maintaining legislative financial control over public finances:

- 1. With automation of the collection of Goods and Services Tax (GST) having taken place, it is essential for Audit to transition from sample checks to a comprehensive check of all transactions, to fulfill the CAG's Constitutional mandate of certifying the Accounts. The required access to data is yet to be provided. Not having access to the data pertaining to all GST transactions has come in the way of comprehensively auditing the GST receipts. The accounts for the year 2018-19 are, therefore, certified on the basis of test audit, as was done when records were manually maintained, as a one-time exception.
- 2. Twenty two Government Departments did not submit 320 Detailed Contingent (DC) bills amounting to ₹ 1,975.94 crore before closing of the accounts for the financial year 2018-19 and, therefore, there is no assurance that the expenditure of ₹ 1,975.94 crore has actually been incurred during the financial year for the purpose for which it was authorized by the Legislature. In addition to this, 469 AC bills amounting to ₹ 1,107.37 crore drawn upto 2017-18 were also outstanding as on 31 March 2019. Thus, a total of 789 AC bills involving ₹ 3,083.31 crore were outstanding as of March 2019. Advances drawn and not accounted for increased the possibility of wastage/ misappropriation/ malfeasance, etc.
- 3. Under the Defined Contribution Pension Scheme, during 2018-19, against the balance of ₹801.71 crore lying in the Public Account, the State Government transferred only ₹618.34 crore to NSDL/Trustee Bank from fund, leaving a balance of ₹183.37 crore as on 31 March 2019, which could not be transferred to the fund managers for want of complete particulars of the employees. The State Government is liable to pay interest on delayed transfer of NPS balances at the corresponding interest rates applicable to the General Provident Fund subscribers. However, no interest has been paid by the State Government for the period from 2011-12 to 2018-19 on the fund balance which could not be transferred to NSDL/Trustee Bank within the stipulated period. Thus the State Government has created interest liability on the amount not transferred to NSDL; incorrectly used the funds that belong to its employees and created uncertainty in respect of benefits due to the employees affected thus leading to possible failure of the scheme itself

The audit observations on above issues are detailed in the State Finances Audit Report of the Government of Punjab for the year 2018-19.

GUIDE TO THE FINANCE ACCOUNTS

A. Broad Overview of the Structure of Government Accounts

- 1. The Finance Accounts of the State of Punjab present the accounts of receipts and outgoings of the Government for the year, together with the financial results disclosed by the Revenue and Capital accounts, the accounts of the Public Debt and the liabilities and assets of the State Government as worked out from the balances recorded in the accounts.
- **2.** The Accounts of the Government are kept in three parts:

Part I: Consolidated Fund: This Fund comprises all revenues received by the State Government, all loans raised by the State Government (market loans, bonds, loans from the Central Government, loans from Financial Institutions, Special Securities issued to National Small Savings Fund etc.), Ways and Means advances extended by the Reserve Bank of India and all moneys received by the State Government in repayment of loans. No moneys can be appropriated from this Fund except in accordance with law and for the purposes and in the manner provided by the Constitution of India. Certain categories of expenditure (e.g. salaries of Constitutional authorities, loan repayments etc.), constitute a charge on the Consolidated Fund of the State (Charged Expenditure) and are not subject to vote by the Legislature. All other expenditure (Voted Expenditure) is voted by the Legislature.

The Consolidated Fund comprises two sections: Revenue and Capital (including Public Debt, Loans and Advances). These are further categorised under 'Receipts' and 'Expenditure'. The Revenue Receipts section is divided into three sectors, viz., 'Tax Revenue', 'Non Tax Revenue' and 'Grants-in-aid and Contributions'. These three sectors are further divided into sub-sectors like 'Goods and Services Tax', 'Taxes on Income and Expenditure', 'Fiscal Services' etc. The Capital Receipts section does not contain any sectors or sub-sectors. The Revenue Expenditure section is divided into four sectors, viz., 'General Services', 'Social Services', 'Economic Services' and 'Grants-in-aid and Contributions'. These sectors in the Revenue Expenditure section are further divided into sub-sectors like, 'Organs of State', 'Education, Sports, Art and Culture' etc. The Capital Expenditure section is sub-divided into seven sectors, viz., 'General Services', 'Social Services', 'Economic Services', 'Public Debt', 'Loans and Advances', 'Inter-State Settlement' and 'Transfer to Contingency Fund'.

Part II: Contingency Fund: This Fund is in the nature of an imprest which is established by the State Legislature by law, and is placed at the disposal of the Governor to enable advances to be made for meeting unforeseen expenditure pending authorisation of such expenditure by the State Legislature. The fund is recouped by debiting the expenditure to the concerned functional major head relating to the Consolidated Fund of the State. The Contingency Fund of the Government of Punjab for 2018-19 is ₹ 25.00 crore.

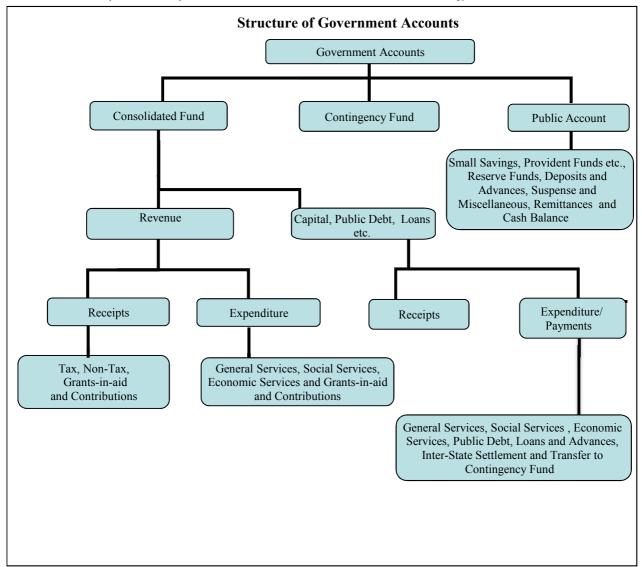
Part III: Public Account: All other public moneys received by or on behalf of the Government, where the Government acts as a banker or trustee, are credited to the Public Account. The Public Account includes repayables like Small Savings and Provident Funds, Deposits (bearing interest and not bearing interest), Advances, Reserve Funds (bearing interest and not bearing interest), Remittances and Suspense heads (both of which are transitory heads, pending final booking). The net cash balance available with the Government is also included under the Public Account. The Public Account comprises six sectors, viz., 'Small Savings, Provident Funds etc.', 'Reserve Funds', 'Deposit and Advances', 'Suspense and Miscellaneous', 'Remittances', and 'Cash Balance'. These sectors are further sub-divided into sub-sectors. The Public Account is not subject to the vote of the Legislature.

- **3.** Government accounts are presented under a six tier classification, viz., Major Heads (four digits), Sub-Major Heads (two digits), Minor Heads (three digits), Sub-Heads (two digits), Detailed Heads (two to three digits) and Object Heads (two or three digits). Major Heads represent functions of Government, Sub-Major Heads represent sub-functions, Minor Heads represent programmes/ activities, Sub-Heads represent schemes, Detailed Heads represent sub-schemes and Object Heads represent purpose/object of expenditure.
- **4.** The main unit of classification in accounts is the Major Head which contains the following coding pattern (according to the List of Major and Minor Heads corrected up to 31 March 2019).

0005 to 1606	Revenue Receipts
2011 to 3606	Revenue Expenditure
4000	Capital Receipts
4046 to 7810 7999	Capital Expenditure (including Public Debt, Loans and Advances) Appropriation to the Contingency Fund

5. The Finance Accounts, generally (with some exceptions), depict transactions up to the Minor Head. The figures in the Finance Accounts are depicted at net level, i.e. after accounting for recoveries as reduction of expenditure. This treatment is different from the depiction in the Demands for Grants presented to the Legislature and in the Appropriation Accounts, where, expenditure is depicted at the gross level.

6. A pictorial representation of the structure of accounts is given below:



B. What the Finance Accounts contain

The Finance Accounts are presented in two volumes.

Volume I contains the Certificate of the Comptroller and Auditor General of India, the Guide to the Finance Accounts, 13 Statements which give summarised information on the financial position and transactions of the State Government for the current financial year, Notes to Accounts and annexure to the Notes to Accounts. Details of the thirteen statements in **Volume I** are given below:

1. Statement of Financial Position: This statement depicts the cumulative figures of assets and liabilities of the State Government, as they stand at the end of the year, and as compared to the position at the end of the previous year.

- **2. Statement of Receipts and Disbursements**: This statement depicts all receipts and disbursements of the State Government during the year in all the three parts in which Government accounts are kept, viz., the Consolidated Fund, Contingency Fund and Public Account. In addition, it contains an annexure, showing alternative depiction of Cash Balances (including investments) of the Government. The Annexure also depicts the Ways and Means position of the Government in detail.
- **3. Statement of Receipts (Consolidated Fund)**: This statement comprises Revenue and Capital Receipts, Borrowings and Repayments of the Loans given by the State Government. This statement corresponds to Detailed Statements 14, 17 and 18 in Volume II of the Finance Accounts.
- **4. Statement of Expenditure (Consolidated Fund)**: In departure from the general depiction of the Finance Accounts up to the Minor Head level, this statement gives details of expenditure by nature of activity (objects of expenditure) also. This statement corresponds to Detailed Statements 15, 16, 17 and 18 in Volume II.
- **5. Statement of Progressive Capital Expenditure**: This statement corresponds to the Detailed Statement 16 in Volume II.
- **6. Statement of Borrowings and Other Liabilities:** Borrowings of the Government comprise Market Loans raised by it (Internal Debt) and Loans and Advances received from the Government of India. 'Other Liabilities' comprise 'Small Savings, Provident Funds etc.', 'Reserve Funds' and 'Deposits'. The statement also contains a note on service of debt, and corresponds to the Detailed Statement 17 in Volume II.
- 7. Statement of Loans and Advances given by the Government: This statement depicts all Loans and Advances given by the State Government to various categories of loanees like Statutory Corporations, Government Companies, Autonomous and Other Bodies/Authorities and recipient individuals (including Government servants). This statement corresponds to the Detailed Statement 18 in Volume II.
- **8. Statement of Investments of the Government**: This statement depicts investments of the State Government in the equity capital of Statutory Corporations, Government Companies, other Joint Stock Companies, Co-operative institution and Local Bodies. This statement corresponds to Detailed Statement 19 in Volume II.
- **9. Statement of Guarantees given by the Government**: This statement summarises the guarantees given by the State Government on repayment of principal and interest on loans raised by Statutory Corporations, Government Companies, Local Bodies and Other institutions. This statement corresponds to Detailed Statement 20 in Volume II.
- **10. Statement of Grants-in-aid given by the Government**: This statement depicts all Grants-in-aid given by the State Government to various categories of grantees like Statutory Corporations, Government Companies, Autonomous and Other Bodies/Authorities and individuals. Appendix III provides details of the recipient institutions.

- 11. Statement of Voted and Charged Expenditure: This statement assists in the agreement of the net figures appearing in the Finance Accounts with the gross figures appearing in the Appropriation Accounts.
- **12. Statement on Sources and Application of Funds for Expenditure other than on Revenue Account**: This statement is based on the principle that Revenue expenditure is expected to be defrayed from Revenue Receipts, while Capital Expenditure of the year is met from Revenue Surplus, net credit balances in the Public Account, Cash Balance at the beginning of the year, and Borrowings.
- **13. Summary of Balances under Consolidated Fund, Contingency Fund and Public Account**: This statement assists in proving the accuracy of the accounts. This statement corresponds to the Detailed Statements 14, 15, 16, 17, 18 and 21 in Volume II.

Volume II of the Finance Accounts contains two parts - nine Detailed Statements in Part I and twelve Appendices in Part II.

Part I of Volume II

- **14. Detailed Statement of Revenue and Capital Receipts by Minor Heads**: This statement corresponds to the Summary Statement 3 in Volume I of the Finance Accounts. In addition to representing details of Revenue Receipts at Minor Head level, this statement depicts details at Sub Head level in respect of Grants-in-aid from Central Government.
- **15. Detailed Statement of Revenue Expenditure by Minor Heads**: This statement, which corresponds to the Summary Statement 4 in Volume I, depicts the Revenue Expenditure of the State Government. Charged and Voted expenditure are exhibited distinctly.
- **16. Detailed Statement of Capital Expenditure**: This statement, which corresponds to the Summary Statement 5 in Volume I, depicts the Capital Expenditure (during the year and cumulatively) of the State Government. Charged and Voted expenditure are exhibited distinctly. In addition to representing details of Capital Expenditure at Minor Head level, in respect of significant schemes, this statement depicts details at Sub Head level also.
- 17. Detailed Statement of Borrowings and Other Liabilities: This statement, which corresponds to the Summary Statement 6 in Volume I, contains details of all loans raised by the State Government (market loans, bonds, loans from the Central Government, loans from Financial Institutions, Special Securities issued to National Small Savings Fund etc.), and Ways and Means advances extended by the Reserve Bank of India. This statement presents the information on loans under three categories: (a) details of individual loans; (b) maturity profile, i.e., amounts payable in respect of each category of loans in different years; (c) interest rate profile of outstanding loans and annexure depicting Market Loans.

- **18. Detailed Statement of Loans and Advances given by the Government**: This statement corresponds to the Summary Statement 7 of Volume I.
- **19. Detailed Statement of Investments of the Government**: This statement depicts details of investments entity wise and Major and Minor Head wise details of discrepancies, if any, between Statement 16 and 19. This statement corresponds to Statement 8 in Volume I.
- **20. Detailed Statement of Guarantees given by the Government**: This statement depicts entity wise details of Government Guarantees. This statement corresponds to Statement 9 in Volume I.
- **21. Detailed Statement on Contingency Fund and Public Account Transactions**: This statement depicts at Minor Head level the details of unrecouped amounts under Contingency Fund, consolidated position of Public Accounts transactions during the year, and outstanding balances at the end of the year.
- **22. Detailed Statement on Investments of Earmarked Balances**: This statement depicts details of Investment from the Reserve Funds and Deposits (Public Account).

Part II of Volume II

Part II contains twelve Appendices on various items including Salaries, Subsidies, Grants-in-aid, Externally Aided Projects etc. These details are presented in the accounts at Sub-Head level or below (i.e. below Minor Head levels) and so are not generally depicted in the Finance Accounts. A detailed list of appendices appears at the 'Table of Contents' in Volume I and II. The statements read with the appendices give a complete picture of the state of finances of the State Government.

D. Periodical adjustments and Book adjustments:

Certain transactions that appear in the accounts do not involve actual movement of cash at the time of booking. Some of these transactions take place at the level of the account rendering units (e.g. treasuries, divisions etc.) themselves. For instance, transactions involving adjustments of all deductions (GPF, recoveries of advances given etc.) from salaries are recorded by debiting functional major heads (pertaining to the concerned department) by book adjustment to Revenue Receipts/Loans/Public Account. Similarly 'nil' bills where moneys transferred between the Consolidated Fund and Public Account represent non-cash transactions occurring at the level of the account rendering units.

In addition of the above, the Principal Accountant General/Accountant General (A&E) carries out periodical adjustments and book adjustments of the following nature in the accounts of the State Government, details of which appear in Annexure to Notes to Accounts in Volume I and footnotes to the relevant statements.

Examples of periodical adjustments and book adjustments are given below:

- 1. Creation of funds/adjustment of contribution to Funds in Public Account by debit to Consolidated Fund e.g. State Disaster Response Fund, Central Road Fund, Reserve Funds and Sinking Fund etc.
- **2.** Crediting of deposit heads of accounts in Public Account by debit to Consolidated Fund.
- **3.** Annual adjustment of interest on General Provident Fund (GPF) and State Government Group Insurance Scheme where interest is adjusted by debiting Major Head 2049-Interest Payments and crediting Major Head 8009-State Provident Fund and Major Head 8011-Insurance and Pension Fund.
- **4.** Adjustment of Debt waiver under the scheme of Government of India based on the recommendations of the Central Finance Commissions. These adjustments (where Central loans are written off by crediting Major Head 0075-Miscellaneous General Services by contra entry in the Major Head 6004-Loans and Advances from the Central Government) impact both Revenue Receipts and Public Debt heads.

E. Rounding:

Difference of ₹0.01 lakh / crore, wherever occurring, is due to rounding.

EXPLANATORY NOTES

- **1 Daily Cash Balance:** Under an agreement with the Reserve Bank of India, the State Government has to maintain a minimum cash balance of ₹ 1.56 crore with the Bank. If the balance falls below the agreed minimum on any day, the deficiency is made good by taking Ordinary and Special Ways and Means Advances / Overdrafts from time to time.
 - For arriving at the daily cash balance ** for the purpose of grant of Ways and Means Advances/ Overdrafts, the Reserve Bank of India evaluates the holdings of the 14 days Treasury Bills along with the transactions reported (at Reserve Bank of India counters, Inter-Government transactions and Treasury transactions reported by the agency banks) for the day. To the cash balance so arrived, the maturity of 14 days Treasury Bills if any, is added and excess balance, if any, after maintaining the minimum cash balance is reinvested in Treasury Bills. **If the net cash balance arrived at results in less than the minimum cash balance** or a credit balance and if there are no 14 days Treasury Bills maturing on that day, Reserve Bank of India rediscounts the holdings of the 14 days Treasury Bills and makes good the shortfall. If there is no holding of 14 days Treasury Bills on that day the State Government applies for Ways and Means Advances/Special Ways and Means Advances/ Overdrafts.
- 2 The limit for Ordinary Ways and Means Advances to the State Government was ₹ 9,25.00 crore during 2018-19. The Bank has also agreed to give Special Ways and Means Advances against the pledge of Government Securities. The limit of Special Ways and Means Advances (Special Drawing Facility) was ₹ 7.34 crore from 1 April 2018 to 31 March 2019.
- * The balance under the head 'Deposits with Reserve Bank' is arrived at after taking into account the Inter-Government Monetary Settlements pertaining to transactions of the financial year 2018-19 advised to the Reserve Bank of India till 10 April 2019.

Note: There was a difference of ₹74.38 crore (Debit) between the figures reflected in the accounts (Debit of ₹36.16 crore) and that intimated by the Reserve Bank of India (Debit of ₹38.22 crore) regarding "Deposits with Reserve Bank" included in the Cash Balance upto 31 March 2019. However, the un-reconciled net difference at the end of June 2019 works out to ₹1,13.56 crore (Debit) which is under reconciliation.

^{**} The cash balance ('Deposits with Reserve Bank of India') given above is the closing cash balance as on 31 March 2019 but worked out by 10 April 2019 and not simply the daily balance on 31 March 2019.

2.2 Arrangements for amortisation- The Government has constituted a Consolidated Sinking Fund on 20 December 2006 with the objective to utilise the fund as amortisation fund for the redemption of the outstanding liabilities of the Government commencing from the financial year 2011-12.

The Government may contribute to the Fund on a modest scale of at least 0.50 per cent of the outstanding liabilities as at the end of the previous year beginning with the financial year 2006-07. The Government shall not fund its contribution to the Fund out of borrowings from

Of these, ₹ 4,36.26 crore were paid in repayment of the outstanding loans during the year, leaving a balance of ₹ 19,85.18 crore. ₹ 1,34.28 crore were paid as interest on these loans. Of these, ₹ 8,75.12 crore were paid in repayment of the outstanding loans during the year, leaving a balance of ₹2,82,35.00 crore. ₹23,64.88 crore were paid as interest on these loans.
- 2.6 Ways and Means Advances from the Reserve Bank of India- Under an agreement with the Reserve Bank of India, the State Government has to maintain with the Bank a minimum balance of ₹ 1.56 crore on all days. If the balance falls below the agreed minimum on a day, the deficiency is made good by taking Ways and Means Advances/ Overdraft from the Reserve Bank.
- At the end of the previous year, an amount of ₹ 7,02.58 crore was outstanding as Ways and Means advances. During 2018-19, Government obtained ₹ 2,32,39.90 crore as Special Drawing Facility and Normal Ways and Means advances on one hundred twenty nine occasions, out of which ₹ 2,39,44.12 crore were repaid during the year leaving a balance of ₹ -1.64 crore. ₹ 23.22 crore were paid as interest on these
- During 2018-19, Government had to avail shortfall of ₹ 28.08 crore on eighteen occasions and overdraft of ₹ 51,87.68 crore on forty occasions. ₹ 52,15.76 crore were repaid during the year leaving nil balance. ₹ 3.32 crore were paid as interest on these shortfalls/overdrafts.
- 2.7 Special Securities issued to National Small Saving Fund of Central Government. ₹ 2,03,36.86 crore were outstanding at the close of previous year. Of these, ₹ 18,01.47 crore were repaid during the year leaving a balance of ₹ 1,85,35.39 crore. ₹ 19,65.08 crore were paid as interest on these securities.
- 3. Loans from the Government of India- The loans from the Central Government as on 31 March 2019 constituted 2.77 per cent of the total Public Debt of the State Government on that date. ₹ 13,17.44 crore were received from the Government of India as loans during the year. Repayment of loans received from the Government of India was made according to the terms and conditions of the loans.

Government Account: Under the system of book-keeping followed in Government accounts, the amount booked under Revenue, Capital and other transactions of Government, the cumulative result of all such transactions. To this the balances under Public Debt, Loans and Advances, Small Savings, Provident Funds, Reserve Funds, Deposits and Advances, Suspense and Miscellaneous (Other than Miscellaneous Government Account), Remittances and Contingency Fund etc. are added and the closing cash balance at the end of the year is to be worked out and proved.

The other headings in the summary take into account the balances under all account heads in Government books in regard to which Government has a liability to repay the money received or has a claim to recover the amounts paid and also heads of account opened in the books for adjustment of remittance transactions.

It must be understood that these balances can not be regarded as a complete record of the financial position of the Government as it does not take into account all the physical assets of the State, such as lands, buildings, communication etc. nor any accrued dues or outstanding liabilities which are not brought to account under the cash basis of accounting followed by Government.

In a number of cases, there are unreconciled differences in the closing balance as reported in the Detailed Statement on Contingency Fund and Public Account Transactions (Statement No. 21 in Volume II) and that shown in separate registers or other record maintained in the Accounts office/ Departmental offices for the purpose. Steps are being taken to settle the discrepancies. Ξ

The balances are communicated to the officers concerned every year for verification and acceptance thereof. In a large number of cases such acceptances have not been received. Ξ

NOTES TO ACCOUNTS

1. Summary of Significant Accounting Policies

(i) Entity and Accounting Period:

These accounts present the transactions of the Government of Punjab for the period 1 April 2018 to 31 March 2019 and have been compiled based on the initial accounts rendered by the 21 District Treasuries, 146 Public Works Divisions (91 Buildings and Roads, 55 Water Supply and Sanitation), 68 Water Resources Divisions, 39 Forest Divisions and Advices of the Reserve Bank of India. While there were delays ranging from 01 day to 18 days in the rendition of monthly accounts by some treasuries and divisions during the year, no account has been excluded at the end of the year.

(ii) Basis of Accounting:

With the exception of some Book and Periodical Adjustments (Annexure A and B), the accounts represent the actual cash receipts and disbursements during the accounting period. Physical Assets and Financial Assets such as investments etc. are valued and shown at historical cost, i.e., the value at the year of acquisition / purchase. Physical assets are not depreciated or amortized. The losses of physical assets at the end of their life are also not expensed or recognized.

Liabilities on retirement benefits disbursed during the accounting period have been reflected in the accounts. Actuarial assessment of the liabilities towards future payments of retirement benefits has not been carried out by the State Government and not included in the accounts.

(iii) Currency in which Accounts are kept:

The accounts of the Government of Punjab are maintained in Indian Rupees.

(iv) Form of Accounts:

Under Article 150 of the Constitution, the accounts of the Union and of the States are kept in such form as the President may, on the advice of the Comptroller and Auditor General, prescribe. The word "form" used in Article 150 has a comprehensive meaning so as to include the prescription not only of the broad form in which the accounts are to be kept but also the basis for selecting appropriate heads under which the transactions are to be classified.

(v) Classification between Revenue and Capital:

Revenue Expenditure is recurring in nature and is intended to be met from Revenue Receipts. Capital Expenditure is defined as expenditure incurred with the object of increasing assets of a material and permanent character or reducing permanent liabilities. Further, as per the Indian Government Accounting Standards (IGAS) 2, expenditure on Grants-in-aid is to be classified

as Revenue Expenditure in the books of the grantor regardless of end utilization and as Revenue Receipts in the books of the recipient.

2. Quality of Accounts:

(i) Goods and Services Tax:

(a) Advance Apportionment and assigning of Un-apportioned Integrated Goods and Services Tax (IGST):

In terms of Section 17 of IGST Act, 2017 and Rule 11(3) of the Goods and Services Tax Settlement of Funds Rules, 2017, the Central Government may, on the recommendations of the Goods and Services Tax Council, provisionally settle any sum of Integrated Goods and Services Tax collected during the financial year, which has not been settled so far, which will be adjusted in the subsequent month(s)/year(s), based on the returns filed by the taxpayers. As per sanction orders issued by the Ministry of Finance, Government of India, an amount of ₹ 2,225.98 crore was received on account of Advance Apportionment of IGST and an amount of ₹ 236.60 crore was assigned to the Government of Punjab on the basis of the recommendations of the Fourteenth Finance Commission.

(ii) Outstanding Detailed Contingent (DC) Bills:

Drawing and Disbursing officers are authorized to draw sums of money by preparing Abstract Contingent (AC) bills by debiting Service Heads. They are required to present Detailed Contingent (DC) bills duly countersigned by the Controlling Officer in all these cases within six months under Rule 274 of Punjab Treasury Rules as amended vide instructions issued by State Government on 11 November and 19 December 2016. Prolonged non-submission of supporting DC bills renders the expenditure under AC Bills opaque.

Out of 789 outstanding DC Bills amounting to ₹ 3,083.31 crore, 574 DC Bills amounting to ₹ 2,961.75 crore (96.06 *per cent*) pertain to eight Departments. These Departments are:

- (i) Agriculture, 130 DC Bills amounting to ₹ 1,789.93 crore (58.05 per cent),
- (ii) Local Government, 52 DC Bills amounting to ₹ 666.80 crore (21.63 per cent),
- (iii) Rural Development and Panchayats, 100 DC Bills amounting to ₹ 171.36 crore (5.56 per cent),
- (iv) Planning, 101 DC Bills amounting to ₹ 112.80 crore (3.66 per cent),
- (v) School Education, 18 DC Bills amounting to ₹81.32 crore (2.64 per cent),
- (vi) Home Affairs and Jails, 28 DC Bills amounting to ₹ 59.15 crore (1.92 per cent),
- (vii) Social Security and Development of Women and Children, 140 DC Bills amounting to ₹ 54.29 crore (1.76 *per cent*),
- (viii) Tourism and Cultural Affairs, 5 DC Bills amounting to ₹ 26.10 crore (0.85 per cent).

Out of 1288 AC bills amounting to ₹ 5,802.09 crore drawn during 2018-19, 296 AC bills amounting to ₹ 213.79 crore (3.68 *per cent*) were drawn in March 2019. Out of these 1288 AC bills, 89 bills amounting to ₹ 4,997.35 crore (86.13 *per cent*) were drawn by Department of Agriculture (39 bills for ₹ 4,240.09 crore), Local Government (31 bills for ₹ 462.35 crore) and Public Works (19 bills for ₹ 294.91 crore).

(iii) Reconciliation of Receipts and Expenditure between Chief Controlling Officers (CCOs) and Accountant General (A&E):

In terms of Para 12.19 of Punjab Budget Manual, the Head of the Department and the Accountant General (A&E) are jointly responsible for reconciling differences and correcting misclassifications. Such reconciliation has been completed by all the 208 and 161 Chief Controlling Officers (CCOs) responsible for Expenditure and Receipt Heads, respectively.

(iv) Reconciliation of Cash Balances:

There was difference of ₹ 74.38 crore (net debit) between the Cash Balance of the State Government as worked out by the Accountant General (A&E) and as reported by the Reserve Bank of India as on 31 March 2019. The difference was mainly due to wrong reporting and non-reconciliation of figures by Agency Banks which is under review. As on 30 June 2019, there was difference of ₹ 113.56 crore (net debit).

(v) Outstanding Utilization Certificates (UCs) against Grants-in-aid sanctioned by the State Government:

Rule 8.14 (b) of the Punjab Financial Rules Volume I prescribes that the Utilization Certificate should be submitted by the sanctioning authority to Accountant General (A&E) not later than eighteen months from the date of sanction of Grants-in-aid.

Utilization Certificates amounting to ₹ 292.42 crore in respect of 13 Departments were outstanding. Major Outstanding Utilization Certificates pertain to the Department of Revenue, Rehabilitation and Disaster Management (11). However, ₹ 235.32 crore i.e. 80.47 per cent of the total outstanding amount of ₹ 292.42 crore pertain to 4 Departments viz. Department of Rural Development and Panchayats (₹ 81.49 crore), Revenue, Rehabilitation and Disaster Management (₹ 53.83 crore), Excise and Taxation (₹ 50.00 crore) and Local Government (₹ 50.00 crore).

Delayed submission and non-submission of UCs impedes the assurance that the funds have been utilized for the intended purposes.

(vi) Transfer of Funds to Personal Deposit Accounts:

Personal Deposit Accounts are governed by provisions contained in Rule 380 (2) and 391 to 396 of Punjab Treasury Rules. The State Government is authorized to sanction opening of Personal Deposit (PD) accounts required for specific purposes by transfer of funds from the Consolidated Fund after consultation with the Accountant General. Transfer of funds to PD accounts is booked as expenditure from the Consolidated Fund under the concerned service Major Heads without any actual cash flow. PD accounts are required to be closed at the end of the financial year, the unspent balances transferred back to the Consolidated Fund and the PD accounts being opened next year again, if necessary. The number of PD accounts opened by transfer from the Consolidated Fund as on 31 March 2019 was 'Nil'.

As per provisions contained in Punjab Treasury Rules, the deposits of Sherrif's Petty Accounts shall be accounted for under Personal Deposits, which shall lapse to Government after expiry of three complete financial years. If a PD account, not being a PD Account created by debit to

the Consolidated Fund, is not operated upon for a period of five complete financial years, the same should be closed and balance lying in such accounts should be credited to Government accounts. These accounts are of following nature:

- (i) LIC policy Premium deducted from the salary of employees for payment to LIC,
- (ii) Security Deposits of newly admitted students to Medical/ Dental Colleges,
- (iii) Security Deposits of library members etc.

An amount of ₹ 0.09 crore was lying unspent in 7 inoperative PD Accounts for more than five years.

3. Other items:

(i) Liabilities towards Pensionary Benefits:

The expenditure during the year on "Pension and other Retirement Benefits" to State Government employees recruited on or before 31 December 2003 was ₹ 9,503.85 crore (including ₹ 556.10 crore on account of leave encashment benefits) which was 12.60 *per cent* of the total Revenue Expenditure of ₹ 75,403.71 crore. State Government employees recruited on or after 1 January 2004 are eligible for the New Pension Scheme.

New Restructured Defined Contribution Pension Scheme is governed by Government of Punjab letter dated 12 December 2006 as amended by letter dated 25 May 2011. In terms of the Scheme, the employee contributes 10 per cent of his monthly salary and dearness allowance which is matched by the State Government as employer share and the entire amount is transferred to designated fund manager through the National Securities Depository Limited (NSDL)/Trustee Bank. The actual amount of employees' and Government's contribution receivable in the Scheme since inception has not been estimated. Therefore, it cannot be verified whether the entire deductions of the employees' contribution have been matched by the employer and transferred to the Public Account and whether the entire amount has been transferred to the National Securities Depository Limited (NSDL)/Trustee Bank. As per provisions of the scheme, during 2018-19, employees' contribution of ₹ 585.78 crore was

Government Employees in Public Account as per prescribed procedure. Government's contribution of ₹ 584.94 crore towards New Pension Scheme was transferred directly to the NSDL/Trustee Bank, debiting Major Head 2071-Pension and Other Retirement Benefits 117-Defined Contributory Pension Scheme. Government's contribution of ₹ 1.64 crore for the legacy period was transferred to NSDL/Trustee Bank, debiting Major Head 8342-Other Deposits 117-Defined Contribution Pension Scheme for Government Employees. During the year, an amount of ₹ 14.70 crore was credited to Major Head 8342-117 towards interest payment at the rate of 8.00 *per cent* as stipulated in the Government Memo dated 12 July 2010 on delayed transfer of NPS balances of legacy period till 31 March 2011. However, State Government is liable to pay interest for the period from 2011-12 to 2018-19 for the fund balance which could not be transferred to NSDL/Trustee Bank within the stipulated period at the corresponding interest rates applicable to the General Provident Fund subscribers.

During the year, against the balance of ₹ 801.71 crore (OB: ₹ 201.23 crore + employees' contribution during the year of ₹ 585.78 crore + interest payment of ₹ 14.70 crore) lying under Major Head 8342-117 in the Public Account, the State Government transferred only ₹ 618.34 crore to NSDL/ Trustee Bank from fund, leaving a balance of ₹ 183.37 crore as on 31 March 2019, which could not be transferred to the fund managers for want of complete particulars of the employees.

Uncollected and untransferred amounts with accrued interest represent outstanding liabilities of the State Government under the Scheme.

(ii) Compliance with Indian Government Accounting Standards (IGASs):

The Indian Government Accounting Standards (IGASs) specify the disclosure requirements in financial statements of the Union and State Governments. Three IGASs have been notified by the Government of India. The status of compliance in respect of these IGASs is as under:

IGAS 1- Guarantees given by Governments: Requirements regarding disclosure in the Finance Accounts have been complied with. Statements 9 and 20 of the Finance Accounts shows the details of Guarantees given by the State Government.

IGAS 2- Accounting and Classification of Grants-in-aid: Requirements regarding Accounting and Classification of Grants-in-aid received or given by the State Government have been met. Statement 10 is prepared as per the requirements of IGAS 2. Disclosure regarding total value of Grants-in-aid in kind and value of Grants-in-aid in kind being Capital Assets in nature could not be made in Statement 10 as this information was not provided by the State Government.

IGAS 3- Loans and Advances made by the Government: Required disclosures are made in the Finance Accounts. Statement 7 and 18 are prepared as per the requirements of IGAS 3. Disclosure regarding rate of interest and moratorium period (if any) in respect of fresh Loans and Advances given during the year, those given to the loanee entities from whom repayments of earlier loans are in arrears and loans sanctioned without specific terms and conditions could not be made in Statement 18 as this information was not provided by the State Government.

(iii) Guarantees:

Statements on Guarantees (Statement 9 and 20) have been compiled as per data furnished by the State Government for guarantees extended by the Government to Statutory Corporations/Boards, Government Companies and Co-operative Societies/Banks etc., for loans raised by them. However, there was variation of ₹856.70 crore in the Outstanding Guarantees at the end of the previous year with reference to the Opening Balance of the year 2018-19.

A Guarantee Act has not been enacted by the State Government. However, under guidelines issued by the Directorate of Disinvestment of Government of Punjab dated 29 March 2010, the State Government is required to levy a Guarantee Fee of 0.50 *per cent* to 2.00 *per cent* of the amount guaranteed, depending on the currency period of the loan.

As intimated by the State Government, ₹ 290.53 crore was receivable as Guarantee Fee in 2018-19 from 7 entities. Against this, 2 entities paid ₹ 41.76 crore as Guarantee Fee. There was a short collection of Guarantee Fee of ₹ 248.77 crore (out of this ₹ 208.92 crore (83.98 per cent) pertains to Punjab Rural Development Board and ₹ 26.63 crore (10.70 per cent) pertains to Punjab State Industrial Development Corporation Limited). Details are given in Statement No. 20.

(iv) Loans and Advances:

Accountant General (A&E) consolidates the data of Loans and Advances on the basis of monthly accounts submitted by the Treasuries. These figures require confirmation from the concerned departments as per Para 12.20 of the Punjab Budget Manual. However, no such confirmation has been received.

Departmental officers responsible for maintaining detailed accounts of loans have not confirmed loan balances. During the year 2018-19, the State Government disbursed ₹ 1,361.05 crore as Loans and Advances. State Government received ₹ 34.95 crore towards repayment of Loans and Advances by Government Servants and ₹ 813.72 crore as repayment of other outstanding loans and advances (₹ 50,159.41 crore as on 31 March 2018) which is 1.69 *per cent* of total outstanding loans and advances i.e. ₹ 50,169.35 crore as on 31 March 2018.

Details are given in Statement No. 7 and 18.

(v) Investments:

Government has its holdings in 9 Statutory Corporations/ Boards, 24 Government Companies, 15 Joint Stock Companies and 7653 Co-operative Banks and Societies. During 2018-19, Government of Punjab has made an additional investment of ₹ 74.00 crore in Central Co-operative Banks which have paid dividend of ₹ 0.04 crore to the State Government from 2014-15 to 2018-19.

Dividend of ₹ 4.24 crore (0.10 *per cent* of invested amount of ₹ 4,263.25 crore) was received during the year 2018-19. ₹ 3.74 crore (88.21 *per cent*) of the total dividend were received from Punjab Small Industries and Export Corporation Limited, Chandigarh (₹ 2.49 crore) and Punjab State Container and Warehousing Corporation Limited, Chandigarh (₹ 1.25 crore).

Details are given in Statement No. 8 and 19. However, investment figures require confirmation from the State Government.

(vi) Reserve Funds:

There are four interest bearing funds and one non-interest bearing fund under Reserve Funds. State Government has not made any investment out of ₹ 5,519.50 crore outstanding in four interest bearing funds as on 31 March 2018. An amount of ₹ 0.68 crore pertaining to one non-interest bearing fund under Major Head 8229 – Development and Welfare Funds has been invested. It is in-operative since 1982-83. Details of Book adjustments carried out by the Accountant General (A&E) on the contributions of the State Government to various Reserve/Deposit Funds and their utilization are indicated in **Annexure A**. Details on Reserve Funds and Investments from the Earmarked Funds are available in Statements 21 and 22 respectively.

(a) Consolidated Sinking Fund:

The Government of Punjab constituted a Consolidated Sinking Fund vide order dated 20 December 2006 with the objective to redeem its outstanding liabilities commencing from the financial year 2011-12. The State Government is to contribute every year minimum 0.50 *per cent* of the outstanding liabilities at the end of the previous financial year. Contribution to this Fund out of borrowings from the Reserve Bank is not permissible. As on 31 March 2018, the outstanding liabilities of the Government of Punjab were ₹ 1,95,152.45 crore. Accordingly, the State Government was required to contribute a minimum of ₹ 975.76 crore (0.50 *per cent*) during 2018-19. However, the State Government has not made the minimum contribution of ₹ 6,300.40 crore to the said Fund since its inception.

(b) Guarantee Redemption Fund (GRF):

In terms of recommendation of the Twelfth Finance Commission, the State Government introduced the 'Guarantee Redemption Fund Scheme' in December 2007 (revised on 8 January 2014 with effect from the financial year 2013-14) with the objective to meet its obligations arising out of the Guarantees extended to State level entities.

As per the guidelines, the Fund shall be set up by the Government with an initial contribution of minimum one *per cent* of outstanding guarantees at the end of the previous year and thereafter minimum 0.50 *per cent* every year to achieve a minimum level of 3.00 *per cent* in next five years. Accordingly, State Government was required to make a minimum contribution of ₹ 1,525.67 crore during the period 2013-14 to 2016-17, but the State Government has not contributed the same to the Fund.

The State Government has further revised the 'Guarantee Redemption Fund Scheme' on 23 October 2017 with effect from the financial year 2017-18. In terms of the Scheme, State Government was required to make a minimum contribution of ₹ 206.77 crore for the year 2017-18 (1.00 per cent of outstanding guarantee of ₹ 20,676.88 crore at the end of the previous year i.e. 2016-17) and ₹ 98.80 crore for the year 2018-19 (0.50 per cent of outstanding guarantee of ₹ 19,760.46 crore at the end of the previous year i.e. 2017-18). However, no contribution has been made to the Fund during 2017-18 and 2018-19. Thus, the State Government has not made the minimum contribution of ₹ 1,831.24 crore to the Fund since its inception.

(c) State Disaster Response Fund (SDRF):

The State Government replaced the Calamity Relief Fund with the State Disaster Response Fund (SDRF) in 2010-11 as per the recommendations of the Thirteenth Finance Commission, which is operated under Major Head 8121-General and Other Reserve Funds 122-State Disaster Response Fund (Reserve Fund bearing Interest). In terms of the guidelines of the Fund, the Centre and State Governments are required to contribute to the Fund in the proportion of 90:10 with effect from 2018-19.

As on 1 April 2018, ₹ 5,382.21 crore was lying in the Fund. During the year 2018-19, ₹ 919.51 crore (₹ 321.99 crore Centre share, ₹ 96.05 crore State share as against share of ₹ 35.77 crore, ₹ 16.64 crore towards refund of previous year's unspent balance lying with the Drawing and Disbursing Officers and ₹ 484.83 crore towards payment of interest by the State Government) were transferred to the Fund. However, there was some delay on the part of State Government in transferring the Grants-in-aid amount to SDRF as under:

An amount of ₹ 119.04 crore was released by the Central Government as remaining balance of second instalment for the year 2017-18 of Grants-in-aid to SDRF on 18 May 2018 whereas State Government issued the sanction on 27 June 2018 after a lapse of 39 days.

First instalment for the year 2018-19 of ₹ 169.13 crore was released by the Central Government on 20 July 2018, whereas State Government issued the sanction on 23 August 2018 after a lapse of 33 days.

An amount of ₹ 33.82 crore was released by the Central Government as arrears of first instalment of Grants-in-aid to SDRF on 10 September 2018, whereas State Government issued the sanction on 25 October 2018 after a lapse of 44 days.

Rule 7 of the Guidelines on Constitution and Administration of the SDRF issued by Government of India, Ministry of Home Affairs office memorandum no. 33-5/2015-NDM-1 dated 30 July 2015 states that the State Government has to transfer the Central share along with its share to the Public Account Head within 15 days of its receipt. Any delay will require the State Government to release the amount, with interest, at Bank Rate of RBI. Accordingly State Government is liable to pay an amount of ₹ 2.49 crore on account of accrued interest.

Expenditure amounting to ₹ 38.22 crore booked under Major Head 2245 - Relief on account of Natural Calamities during the year 2018-19 was recouped from SDRF leaving a balance of ₹ 6,263.50 crore in the Fund as on 31 March 2019.

In terms of guidelines, issued by the Ministry of Home Affairs, Government of India on 28 September 2010 and 30 July 2015, Fund balances are required to be invested as per the recommendations of the State Executive Committee (SEC) constituted for the management of the Fund. State Government has not made any investment, though ₹ 5,382.21 crore were in credit balance on 31 March 2018.

Details of transactions in the SDRF are given in Statements 14, 15, 21 and 22 of the Finance Accounts.

(vii) Suspense and Remittance Balances:

Statement 21 reflects the net balances under Suspense and Remittance Heads. The outstanding balances under these heads are worked out by aggregating the outstanding debit and credit balances separately under various minor heads.

The position of significant Suspense and Remittance balances for the last three years is given in **Annexure-C**.

(viii) Contingency Fund:

The Contingency Fund of the State of Punjab has a corpus of ₹ 25.00 crore. No amount was spent from the Contingency Fund during the year.

(ix) Direct transfer of Central Scheme Funds to Implementing Agencies in the State (Funds routed outside the State Budget):

Notwithstanding Government of India's decision to release all assistance to Centrally Sponsored Schemes (CSSs)/ Additional Central Assistance (ACA) to the State Government and not directly to the implementing agencies with effect from 1 April 2014, substantial funds were transferred directly to implementing agencies during 2018-19 also. As per the Public Financial Management System (PFMS) portal of the Controller General of Accounts (CGA), GOI released ₹ 2,508.36 crore directly to the implementing agencies in Punjab during 2018-19. Thus, direct transfers of funds to implementing agencies have increased by 22.50 *per cent* in 2018-19 as compared to 2017-18. Details are at Appendix-V.

(x) Off-Budget Borrowings:

Government of Punjab permitted Punjab Urban Planning and Development Authority (PUDA) to borrow from the Banks/ Financial Institutions with responsibility of repaying the loans raised by PUDA. PUDA raised a loan of ₹ 2,000.00 crore (₹ 1,000.00 crore in 2012-13 and ₹ 1,000.00 crore in 2013-14) from various banks which was remitted to Government accounts and booked under Major Head 0075 - Miscellaneous General Services in the accounts of the respective years instead of booking the amount under Major Head 6003- Internal Debt of the State Government. The misclassification has resulted in understatement of Liabilities of the Government to that extent.

The liability towards repayment of principal and interest on these loans, however, has been taken by the State Government by way of assistance to PUDA. As per accounting procedure, the repayment of Public Debt needs to be classified under Major Head 6003- Internal Debt of the State Government and interest thereon under Major Head 2049- Interest Payments.

Government of Punjab made budget provision of ₹ 518.07 crore under Major Head 2216-Housing, 02-Urban Housing, 190-Assistance to Public Sector and other Undertakings, 01-Assistance to Punjab Urban Development Authority, 50-Other Charges in Grant No. 35 during 2018-19, against which State Government incurred an expenditure of ₹ 518.00 crore on account of repayment of principal and interest on the loans raised by PUDA. Thus, the Revenue Deficit of the Government has been overstated to that extent and there is understatement of committed expenditure towards payment of interest.

(xi) Cash with Divisional Officers:

As per codal provisions, funds received towards Deposit Works from non-Government Agencies by Public Works Divisions are required to be credited under Minor Head 108-Public Works Deposits below Major Head 8443-Civil Deposits. The expenditure for related Deposit Works are also met from same head of account. In the Monthly Divisional Accounts such deposits are depicted under Major Head 8671-Departmental Balances, 101- Civil, by the PW Divisions, so it has become part of Government Accounts. However, the funds received towards Deposits Works are being kept in the Bank Accounts of Divisional Officers operated by PW Divisions instead of Treasury and thus not forming part of cash balance of the State with Reserve Bank of India.

State Government vide letter No. TA (DDI-Meeting)2015/1761 dated 2 March 2015, directed Public Works Divisions to deposit the funds in the accounts to be opened at the Treasury under head 8443 - Civil Deposits 108 - PW Deposit. However, despite above dated order, the Divisional Officers are still depositing the funds in their Bank Accounts. As on 31 March 2019, an amount of ₹ 835.21 crore was lying in the Bank Accounts of Public Works Divisional Officers. If the funds were deposited in treasury, the net daily Cash Balance would have reduced the interest paid by the State Government on Ways and Means Advances/Overdrafts.

(xii) Adjustment of excess repayment against written off Central Loans:

In furtherance of the recommendations of the Thirteenth Finance Commission, Ministry of Finance, Government of India, in a series of orders, all dated 29 February 2012, wrote off loans advanced to the State Government by various Ministries (except those advanced by the Ministry of Finance itself) as on 31 March 2010 towards Central Plan and Centrally Sponsored Schemes. Ministry of Finance permitted the State Governments to adjust the excess repayments of principal and interest made from the effective date of the order (31 March 2010) and its adjustment against future repayments to the Ministry of Finance.

Government of Punjab made excess repayment of Principal and Interest to the tune of ₹ 19.81 crore in 2010-11 and 2011-12 (Principal ₹ 10.52 crore, Interest ₹ 9.29 crore) out of which an amount of ₹ 3.01 crore (Principal ₹ 2.44 crore, Interest ₹ 0.57 crore) was adjusted against loans given by Ministry of Finance upto 2013-14. An amount of ₹ 0.47 crore advanced by Ministry of Agriculture has been adjusted during 2018-19 against loan given by Ministry of Finance. Adjustments of the balance amount of ₹ 16.33 crore (Principal ₹ 7.61 crore, Interest ₹ 8.72 crore) are still pending.

(xiii) Loans given to Public Sector Undertakings (PSUs):

Loans were given by the State Government to four Public Sector Undertakings (PSUs), out of which accounts of two PSUs have not been finalised for more than one year, which is as under:

(xiv) Interest Adjustments:

Government is liable to pay/adjust Interest in respect of balances under categories - J- Reserve Funds (a) Reserve Funds bearing Interest and K- Deposits and Advances (a) Deposits bearing Interest and specific sub-major heads are provided for this purpose in the List of Major and Minor Heads (e.g. '05 Interest on Reserve Funds' and '60 Interest on Other Obligations' under Major Head 2049 Interest Payments).

Outstanding balances, at the beginning of the year, under J-(a) Reserve Funds bearing interest were ₹ 5,519.50 crore. The State Government had paid interest of ₹ 486.23 crore on all interest bearing Reserve Funds.

Similarly, there was an outstanding balance of ₹825.90 crore under K-(a) Deposits bearing Interest at the beginning of the year. The State Government paid interest of ₹14.70 crore at 8.00 *per cent* only on one Interest bearing Deposit i.e. Defined Contribution Pension Scheme for Government Employees (NPS) for the un-transferred amount of Employees' and Government's contribution towards NPS for the period till 31 March 2011. Total Interest liability from the year 2011-12 to 2016-17 was ₹216.77 crore at prevailing GPF interest rates (ranging from 7.60 *per cent* to 8.80 *per cent*), whereas State Government paid an interest of ₹126.26 crore at the rate of 8.00 *per cent* as stipulated in the Government Memo dated 12 July 2010 on delayed transfer of NPS balances of legacy period till 31 March 2011 only. Thus, there was less payment of interest of ₹90.51 crore.

In addition, ₹ 46.85 crore were also required to be paid as interest (taking Ways and Means Advance average interest rate for the year 2018-19 at 7.50 per cent) on the balance of ₹ 624.69 crore lying under interest bearing deposit heads viz. Minor Head 101-Deposits of Municipal Corporations and 104-Deposits of other Autonomous Bodies below Major Head 8338-Deposits of Local Funds and Minor Head 103-Deposits of Government Companies,

Corporations etc. and Minor Head 120-Miscellaneous Deposits below Major Head 8342-Other Deposits as on 31 March 2018.

(xv) Non-compliance of Recommendations of Fourteenth Finance Commission:

Recommendations made by the Fourteenth Finance Commission warrant amendments to the Fiscal Responsibility and Budget Management (FRBM) Act thereby (i) inserting a new section mandating the establishment of an independent Fiscal Council to undertake ex-ante assessment of the fiscal policy implications of budget proposals and their consistency with fiscal policy and Rules, (ii) to provide for the statutory flexible limits on Fiscal Deficit and (iii) to provide a statutory ceiling on the sanction of new capital works to an appropriate multiple of the annual budget provision.

The Commission also recommended that the State Government should adopt a template for collating, analyzing and annually reporting the total extended public debt in the budget as a supplement to the budget to assess the Government debt of the State in the context of risks arising from guarantees, off-budget borrowings and accumulated losses of financially weak public sector enterprises.

Further, in order to accord greater sanctity and legitimacy to fiscal management legislation, State Government may replace the existing FRBM Act with a Debt Ceiling and Fiscal Responsibility Legislation, specifically invoking Article 293 (1) of Constitution of India "Borrowing by States" which inter-alia states that subject to the provisions of this article, the executive power of a State extends to borrowing within the territory of India upon the security of the Consolidated Fund of the State within such limits, if any, as may from time to time be fixed by the Legislature of such State by law and to the giving of guarantees within such limits, if any, as may be so fixed.

However, the State Government has taken no action on these recommendations.

(xvi) Disclosures under the Punjab Fiscal Responsibility and Budget Management (PFRBM) Act, 2003 and limits fixed by Government of India:

- (a) The State Government has not made the following disclosures as required under the existing PFRBM Act:
- (i) Significant changes in the accounting standards, policies and practices affecting or likely to affect the computation of the prescribed fiscal indicators and (ii) Contingent liabilities created by way of guarantees, all claims and commitments made by the State Government having potential budgetary implications, including revenue demands raised but not realized, tax arrears and liability incurred, but not paid.

(c) On the basis of Fiscal Deficit threshold limit of 3.00 *per cent* of GSDP estimate for 2018-19, net borrowing limit of ₹ 15,200.00 crore was fixed for Government of Punjab vide Government of India, Ministry of Finance letter No. 40(6) PF-S/2017-18 dated 20 March 2018. However, net borrowings were ₹ 14,327.45 crore during 2018-19.
