

**Proceeding of Second Departmental Screening Committee (2<sup>nd</sup> DSC) meeting  
for consideration of cases for Compassionate Appointment for year 2022**

The Second Departmental Screening Committee (2<sup>nd</sup> DSC) consisting of **Shri Sanjeev Kumar**, Sr. Deputy Accountant General (Admn.), O/o the Principal Accountant General (Audit)-I, Uttar Pradesh, Prayagraj, **Shri Rajendra Kumar Khare**, Sr. Deputy Accountant General (Admn.), O/o the Principal Accountant General (A&E)-I, Uttar Pradesh, Prayagraj and **Shri Jay Prakash**, Sr. Deputy Accountant General (A.M.G.-III), O/o the Principal Accountant General (Audit)-II, Uttar Pradesh, Lucknow met on **12.10.2022** to assess the necessity and suitability of the candidates for appointment on compassionate grounds as per the Scheme of Compassionate Appointment.

2. The appointment under the scheme for compassionate appointment is regulated as per instructions issued by Govt. of India, Deptt. of Personnel & Training O.M. F.No.14014/01/2022-Estt.(D) dated 02.08.2022 and Headquarters' circular No.14 issued vide letter संख्या:52-स्टाफ हकदारी (नियम)/ए.आर./02-2021 दिनांक:20.04.2022.
3. The Committee was informed that there is 'NIL' vacancy for the 2<sup>nd</sup> DSC for the year 2022.
4. The Committee was informed that **49** deferred cases of previous DSC and **05** fresh cases received from dependents of deceased employees by 30.06.2022 are to be assessed for suitability of candidates. The List of **total 54** cases is placed as **Annexure 'D'**.
5. On scrutiny of records of candidates, the committee analyzed the necessity and suitability of all the applicants on the basis of information/documents provided by Administration and by the candidates.




6. The Committee, after detailed scrutiny of the cases, recommends **36** candidates 'FIT' for compassionate appointment as per model evaluation scheme and their income & liabilities. The list of FIT candidates is placed as **Annexure 'A'**.

(D/2543) are not willing for appointment. Accordingly, the Committee recommends for closing the said 02 cases. The list of these rejected cases is placed as **Annexure 'B'**
8. The Committee, due to wanting/non-submission of requisite document(s) from candidates, deferred the remaining **16** cases as per **Annexure 'C'** for consideration by the next DSC.




