

MINUTES OF DEPARTMENTAL SCREENING COMMITTEE
(1ST DSC) MEETING FOR CONSIDERATION OF CASES FOR
COMPASSIONATE APPOINTMENT FOR YEAR 2023

The Departmental Screening Committee (1st D.S.C.) of 2023 again held on 17.05.2023 consisting of **Shri Rajendra Kumar Khare**, Sr. Deputy Accountant General (Admn.), office of the Principal Accountant General (A&E)-I, Uttar Pradesh, Prayagraj, **Ms.Dhanlaxmi Chourasia**, Director, office of the DGA, Defence Services, New Delhi, Central Command, CDA(P) Complex, Uttar Pradesh, Prayagraj and **Shri Rajendra Prasad**, Director (Direct Taxes), office of the Principal Director of Audit (Central) Lucknow, Branch Prayagraj, Uttar Pradesh to assess the necessity and suitability of the candidates for appointment on compassionate grounds as per Scheme of Compassionate Appointment.

2. The Departmental Screening Committee (1st D.S.C.) of 2023 was also held on 27.04.2023 to assess the necessity and suitability of the candidates for appointment on compassionate grounds as per Scheme of Compassionate Appointment. The committee noticed the direction of Headquarters' office letter No. 56-स्टाफ हक़.(नियम)/सी.ए./06-2022 (खण्ड.II) dated 25.04.2023 whereby it was directed "*To consider the 09-related cases, as mentioned in your office letter no.81154 dated 22.12.2022, afresh while keeping in view the para-13 (iv) of DoPT OM dated 02.08.2022- The Administration shall satisfy itself regarding the correctness of the details entered in the application form and family income and other details computed for processing the application. During scrutiny, if any additional details or information having a bearing on a case, emerge, the same should be added as supplementary Note on the Application*", and directed to comply with. Accordingly, the same was completed and submitted before the DSC met on 17.05.2023.

3. The Committee was informed that the appointment under the scheme for compassionate appointment is regulated as per instructions issued by Govt. of India, Deptt. of Personnel & Training O.M. F.No.14014/01/2022-Estt.(D) dated 02.08.2022

and Headquarters' circular No.14 issued vide letter संख्या:52-स्टाफ हकदारी (नियम)/ए.आर./02-2021 दिनांक:20.04.2022 and other supplementary instructions issued on the subject by the Headquarters' office from time to time.

4. The Committee was informed that 5% of the vacancies in Group 'C' cadre arising during the year for compassionate appointment for the year 2023 has been earmarked **3.40 (rounded to 3)** as on 02.01.2023 (01 January 2023 being Sunday).

5. The Committee was informed that **50** (FIT and deferred by previous DSC) cases of previous DSC, **05** fresh cases received from dependents of deceased employees by 31.12.2022 and **01** court case considered as afresh case as per order of CAT dated 05.12.2022 are to be assessed for suitability of candidates. As such, **56** cases are to be considered by DSC for compassionate appointment. The List of 56 cases is placed as **Annexure 'A'**.

6. Taking into consideration the objective of the scheme and extant rules relating to appointment on compassionate grounds and after assessing the financial condition of the families, the DSC found that **Smt. Vandana Devi** w/o Late Ajay Kumar, Ex-MTS (G/3537), **Smt. Anupama**, w/o Late Jitendra Pratap Singh, Ex. Clerk (F/3563) have obtained highest marks as per model evaluation system.

7. The DSC found that three (**03**) applicants have obtained equal marks for the third spot as per the model evaluation system laid down by Headquarters' office. The Committee, therefore, considered the present income of family (family pension) of dependents and their liabilities. Accordingly, out of the three (**03**) applicants, committee found the case of **Smt. Monika Sumbrui**, w/o Late Sangam Lal Sumbrui, Ex. Sr. Accountant (D/1677) deserving for compassionate appointment.

8. The Committee, after detailed scrutiny of the cases, found the 50 candidates 'FIT' for appointment on compassionate ground as per model evaluation scheme and their income & liabilities.


