**PROCEEDINGS OF THE DEPARTMENTAL SCREENING COMMITTEE  
FOR APPOINTMENT ON COMPASSIONATE GROUND FOR THE YEAR  
2024.**

The Departmental Screening Committee comprising Ms. Sumedha Amar, Sr. Deputy Accountant General (Administration & AMG-V), O/o the Principal Accountant General (Audit), Haryana, Chandigarh, Shri Sumeet Kumar, Sr. Deputy Accountant General (AMG-II), O/o the Principal Accountant General (Audit), Haryana, Chandigarh and Sh. Gutte Rohit Manikrao, Deputy Accountant General (AMG-III), O/o the Principal Accountant General (Audit), Haryana, Chandigarh held its meeting on 17.10.2024 to consider the following cases for appointment on compassionate ground:-

2. The Committee was informed that Govt. of India, Ministry of Personnel, Public Grievances and Pensions, Department of Personnel and Training, New Delhi vide F.No. 14014/01/2022-Estt. (D) Dated 02.08.2022 has consolidated the earlier instructions on the Scheme for Compassionate Appointment under Central Government by including contents of all the important/relevant O.Ms issued till date.

3. The committee noticed that the basic objective of the scheme is to grant appointments on compassionate grounds to a dependent family member of a Govt. Servant who died in harness or retired on medical grounds thereby leaving his/her family without any means of livelihood and to relieve the family concerned from financial destitution and to help it get over the emergency. Meaning thereby that the basic criteria for the appointment must be to ascertain whether the death or retirement on medical grounds of the Govt. Servant, had left the family in financial destitution and penury without any means of livelihood.

4. The Committee was informed that 03-vacancies (02-in DEO and 01-in MTS cadre) in Group 'C' cadre for compassionate appointment for the remaining part of the year 2024 are available.

5. The committee was apprised that one (01) application has been received for compassionate appointment for the remaining part of the year 2024. The brief of the case is as follows: -

(a) **Smt. Poonam W/o late Shri Amar Singh, MTS**

- (i) Smt. Poonam W/o late Shri Amar Singh, MTS has applied on 29.02.2024 for appointment to herself on compassionate ground. As per report of the Sr. AO Welfare, Late Shri Amar Singh expired on 26.01.2024 leaving behind 03 children (13 years and 11 years old Sons and 09 years old daughter). The Candidate is 8<sup>th</sup> Pass, unemployed and at present residing at House No. 2114, Sector-41/C, Chandigarh.

Further, the family of the deceased have received the total terminal benefits of Rs.54,000/- as under:

- i. DCRG of Rs. 54,000/-,
- ii. Leave encashment – Rs. Nil,
- iii. CGEGIS – Rs. Nil,
- iv. Family pension- Rs. 9000/-+DA per month (enhanced rate up to 26.01.2034) thereafter, at normal rate i.e Rs. 9000/-+DA

As per bank pass book of Smt. Poonam (Account No. 42741492713 of SBI) there was a closing balance of Rs. 1246/- on 17.08.2024, Daughter Satakshi (Account No. 07391000025198 of Punjab & Sind Bank) has a closing balance of Rs. 809.84/-, Son Keshav Singh (Account No. 07391000024354 of Punjab & Sind Bank) has a closing balance of Rs. 2225.12/- and son Chirag (Account No. 07391000024630 of Punjab & Sind Bank) has a closing balance of Rs. 965.12/-. In addition, the family have no parental property in Village- Atali, Post- Budena Kalan, Police Station- Titavi, Distt- Mujaffarnagar, Uttar Pradesh. They have no other moveable or immovable property in Chandigarh or anywhere in India.

As is evident from above that the family of the deceased officials have received a terminal benefit of Rs. 54,000/- and monthly pension of Rs. 9000/ plus DA per month. At the time of death of the official, the remaining service left was 20 years 6 months. Further, the family has no bank balance and has 01 daughter and 02 sons.

Thus it is clear that the family of the deceased has been left in financial destitution and penury without any means of livelihood. Hence, the Committee recommends the case of Smt. Poonam w/o Late Shri Amar Singh, MTS, for appointment under compassionate grounds in office of the Principal Accountant General (Audit) Haryana, Chandigarh.
