Subject: - Filling up the post of DEO Grade 'F' (earlier named as Sr. Data Processor) on deputation basis in O/o the Accountant General (Audit) Jharkhand, Ranchi.

Applications are invited to fill one vacant post of DEO Grade 'F' (earlier named as Sr. Data Processor) in this office on existing terms and conditions stipulated under DoPT OM No. 6/8/2009-Estt. (Pay II) dated 17.06.2010 and as amended from time to time.

The eligibility criteria for deputation are as follows:

DEO Grade 'F' (earlier named as Sr. Data Processor)	01	Level 8 in Pay Matrix of 7 th CPC.	<p>(A) (I) Holding analogous posts on regular basis in the parent cadre or department Or (II) two years' service in the grade rendered after appointment thereto on a regular basis in Level-7 in Pay Matrix (Rs. 44900-142400) or equivalent in the parent cadre/department; and (B) possessing the following educational qualifications and experience: (I) Master's Degree in Computer Applications/ Information Technology/ Computer Science of a recognised University/ Institute. or B.E./B.Tech in Computer Engineering/ Computer Science/ Computer Technology/ Computer Science and Engineering/ Information Technology from a recognized University/ Institute, (II) two years' experience of Programming/ information System in a Government office/Public Sector Undertaking/ autonomous body/statutory body or in any recognised institution.</p>

2. The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation.
3. The period of deputation including the period of deputation in another ex-cadre post immediately preceding this appointment in the same or some other

organization/department of the Central Government shall ordinarily not to exceed three years.

4. The maximum age limit for appointment by deputation shall be not exceeding 56 years as on the date of receipt of applications.

5. The selected official will be entitled for Deputation (Duty) Allowance as per rate as stated in the DoPT OM No. 2/11/2017- Estt. (Pay-II) dated 24.11.2017 & 15.03.2021.

6. Applications of interested officials who fulfill the above criteria, in the prescribed pro-forma (enclosed) must be received in Admn. Section latest by 21.11.2022.
