- 2. The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation.
- 3. The period of deputation including the period of deputation in another ex-cadre post immediately preceding this appointment in the same or some other

organization/department of the Central Government shall ordinarily not to exceed three years.

- 4. The maximum age limit for appointment by deputation shall be not exceeding 56 years as on the date of receipt of applications.
- 5. The selected official will be entitled for Deputation (Duty) Allowance as per rate as stated in the DoPT OM No. 2/11/2017- Estt. (Pay-II) dated 24.11.2017 & 15.03.2021.
