Consequent on bifurcation of cadres between the Offices of the Accountant General (A&E), Telangana and Principal Accountant General (A&E), Andhra Pradesh w.e.f. 01.10.2018, O/o C&AG of India has prescribed Policy for allocation of staff to meet the deficit by deploying the officials on deputation basis to O/o the Pr. AG(A&E) Andhra Pradesh. Accordingly, in compliance with the said Policy and in continuation of the Office Order No.23 dated 19<sup>th</sup> July 2021 of this office, the tentative list of Assistant Supervisors who are to be deployed on deputation basis to O/o the Principal Accountant General (A&E), Andhra Pradesh are listed in the annexure.


