Memorandum of Understanding

Between

Regional Capacity Building & Knowledge Institute, Ranchi Indian Audit and Accounts Department (Government of India)

And

Central Institute of Psychiatry, Ranchi Ministry of Health & Family Welfare, (Government of India)

Regional Capacity Building & Knowledge Institute (RCB&KI), Ranchi, Indian Audit and Accounts Department, (Government of India) First Party Central Institute of Psychiatry, Ranchi the Second Party, both of them hereinafter singularly referred to as "The Party" and collectively referred to as "The Parties";

WHEREAS it is necessary to enhance understanding and relationship by promoting exchange and co-operation in the area of academics and capacity building of the public servants of CIP, Ranchi and those undergoing training at RCB&KI, Ranchi.

AND WHEREAS it is further necessary to strengthen co-operation between the Parties herein through sharing experiences, best practices and knowledge in the area of academics and capacity building of the public servants of CIP, Ranchi and those undergoing training at RCB&KI, Ranchi.

AND WHEREAS it is also necessary to recognize the need to share value of academic cooperation and having agreed to further continue their common interests in promoting the mutual cooperation in the area of academics and capacity building of Public Servants;

AND WHEREAS it is also necessary to collaborate in the academics and capacity building in which gains for both the Institutes shall be several and equal without any financial liability on either of the Institutes;

NOW THEREFORE, the Parties have reached the following Memorandum of Understanding:

Article 1

Objective

The objective of this Memorandum of Understanding, hereinafter referred to as the "MoU", is to establish a healthy framework for co-operative institutional relations to encourage and promote co-operation in the area of the capacity building of the public servants of CIP, Ranchi and those undergoing training at RCB&KI, Ranchi.

Article 2

Area of Co-operation

The Parties herein will endeavor to carry out the following terms and conditions consisting of mutual exchanges and co-operative activities under this MoU which consist of:

Collaboration for capacity building in the areas of Governance, Public Administration, Accounting and Mental Health which may include the following:

Support to be extended by RCB&KI, Ranchi: -

- 1. Extending technical support to CIP in Capacity Building of its administrative staff and officers by means of sharing of knowledge and experience.
- 2. Extending faculty support in the training program organised by the CIP.
- 3. Helping CIP in creating training module on topics related to Administration, Accounting, Finance and Accountability in addition to Procurement, Taxation, Ethics etc.

Support to be extended by CIP Ranchi: -

- 4. Helping RCB&KI Ranchi in creating a training module on Mental Health, Stress Management and Work-Life Balance issues for the officers and staff of Indian Audit & Accounts Department.
- 5. Providing faculty support for organising training on these topics.
- 6. Helping RCB&KI in organising a workshop for RCB&KI faculty members in form of a training of trainers program.

Article 3

Implementation

- 1. The Parties shall hold periodic consultations amongst themselves as deemed necessary for implementing this MoU.
- 2. For the implementation of this MoU, the Parties shall designate one nodal person each within one month of the commencement of this MoU to draw up the procedures, plan and strategy for recommended programmes of cooperation with a view to achieving the objective of the MoU.
- 3. Specific details of procedures and programmes for exchange and co-operative activities will be decided in a manner to be separately agreed upon by the Parties in future.
- 4. This MoU may be amended at any time by written mutual consent of both the parties subsequent to the 15 days' notice.
- 5. This MoU may be terminated by either Party by the provision of written notice of termination not less than one month prior to the termination date.
- 6. The termination of this MoU shall not affect the rights or obligations of either Party regarding any binding offer or firm obligations approved and agreed to either Party prior to the termination date.

Article 4

Settlement of Differences

If any provision of this Memorandum is held by any court or other competent authority to be illegal, void or unenforceable, the remainder of the MoU shall not be affected thereby and shall continue to be valid. Any difference, arising out of the interpretation, application and implementation of this MoU, shall be settled amicably through consultations and negotiations among the Parties themselves.

Article 5

Amendment

This MoU can be reviewed or amended at any time by mutual written consent of both the Parties. Such reviews or amendments shall come into force on such date as may be determined by the Parties and shall form an integral part of this MoU.

Article 6

Entry into Force, Duration and Termination

- This MoU shall come into force on the date of its execution.
- 2. This MoU shall remain into force for a period of 3 (Three) years and will be renewable with the mutual written consent of the Parties thereafter:
- 3. Either Party may terminate this MoU at any time by giving written notice, at least, one month in advance.
