OFFICE ORDER-29

Sub: Preventive measures to contain the spread of COVID -19 – exemption for persons with physical disabilities/officials who are pregnant from attending office – reg.

In terms of office Memorandum No.11013/0/2014-Estt.A-III dt. 19th April 21 Dept of Personnel and Training and other general instructions issued by Headquarters on preventive measures to contain the spread of COVID-19 from time to time such of those officials who are physically challenged are exempted from attending office until further orders.

The Branch officer of controlling section concerned shall exempt those Physically challenged officials who could not commute to office, if any specific request is received from such officials (list enclosed) by issue of necessary Branch orders with the approval of respective Group officers. A copy of such order shall be forwarded to Administration for records.

Women officials who are Pregnant are also exempted from attending office and their names shall not be included in the roster maintained by the Group concerned.

Those officials who are exempted from attending office shall-continue to work from home until further orders. Those exempted officials shall report to duty during the period of exemption only after obtaining prior permission of the competent authority. Further such officials are not eligible to draw Transport Allowance during the period of exemption in terms of extant instructions of Department of Expenditure vide OM No. 21/3/2020- E.II (B) dt. 1.12.20.
