Subject: Submission of Fresh Pension Cases through Online Diary Management System (ODMS) -- **Family ID (Parivar Pehchan Patra).**

Sir/Madam,

Kindly refer to this Department's memo No. 2/2/2019-1Pension (FD) dated 13.06.2022 vide which directions were issued that the **Online Diary Management System** (ODMS) should be integrated with **Parivar Pehchan Patra**.

Later on, directions were also issued vide letter No. 2/2/2019-1Pension (FD) dated 28.12.2022 that the Parivar Pehchan Patra ID (PPP) of the pensioner or Aadhar of the pensioner, in case the pensioner doesn't have Family ID, should be filled in Online Diary Management System (ODMS).

After due consideration, State Government has decided that the pensioner(s) must fill-up Family ID (FID) **in the pension paper(s)** (including online entry of Family ID (FID) while entering pensioner's data) **mandatorily** w.e.f. **01st August, 2023**. Principal Accountant General (A&E), Haryana would also mention the FID in the e-PPO for all fresh Pension cases processed through Online Diary Management System (ODMS).

You are requested to bring the above instructions to the notice of employees (prospective pensioners) working in your Department and ensure compliance.
