

- Dusting and cleaning in respect of the entire pedestal fans will be required to be done
 in each month, whereas overhauling of all fans is required to be done twice in
 March/April and in September/October.
- 5. All breakdown calls in respect of the pedestal fans shall have to be attended within 24 hrs. and restored within 48 hrs of working days except holidays. Any unjustified and unacceptable delay in attending the affected fan/s beyond 24 hrs. shall render the

vendor liable for penalty @ 1% of the contract value per week subject to maximum of 5% of the contract value.

- 6. The rates once furnished and accepted by this office cannot be changed by the firm during the contractual period. Any request in this regard will not be entertained.
- 7. For quoting the rates only the prescribed Bidding Sheet attached to the NIQ will be allowed. No other sheet will be entertained. The rate should be inclusive of GST.
- 8. Necessary arrangement for deployment of at least one service man during the office hours for providing preventive and remedial service maintenance support to the contracted pedestal fans is to be made during the entire contractual period.
- 9. If any pedestal fan happens to become inoperative and requires to be taken to the workshop of the vendor, the vendor will be liable to provide a fan as substitute. In that case no extra cost will be borne by this office.
