
Terms and Conditions of Contract:

Your quotation should also include the price of rodent control/termite to be given every month. The Earnest Mooney Deposit of **Rs 10,000/-** (Rupees Ten Thousand Only) may be enclosed in form of Demand Draft favouring **Sr. Accounts Officer, O/o the Accountant General (A&E)-I, Maharashtra, Mumbai.**

The Security Deposit of **Rs. 15,000/-** (Rupees Fifteen Thousand Only) will have to be rendered by successful bidder in form of Demand Draft favouring **Sr. Accounts Officer, O/o the Accountant General(A&E)-I, Maharashtra, Mumbai,** which will be returned on successful completion of contract.
