#### **NOTICE INVITING TENDER**

The Office of the Principal Accountant General (A&E), Telengana, Hyderabad invites sealed quotations for Comprehensive Annual Maintenance Contract (CAMC) for computers, printers, network connections including hardware components as mentioned in Annexure I of this tender notice along with their peripherals and any OS/App SW etc.

Tender/bid document contains 5 Annexures, Annexure I contains the proforma for technical bid, Annexure II contains the proforma for Financial bid, Annexure III contains self-declaration of Downtime statements, Annexure IV contains details of critical Equipment and Annexure V contains the details of hardware items to be maintained by the contractor. Further the terms and conditions of the contract is also enclosed herewith. Separate technical and Financial Bids in the prescribed format (as annexed) in sealed envelopes super-scribing with "Technical bid", and "financial Bid" should be put in a single cover which should be super-scribed as "tender Documents for AMC of computers, printers, laptops and networking hardware and related accessories" and submit the same personally or through post/courier along with required documents to the Sr. deputy Accountant General (Admin), O/o Principal Accountant General (A&E), Telengana, Hyderabad, Pin-500004, so as to reach this office on or before 09.04.2025 up to 2.30 PM. Technical Bids will be opened at 3.00 PM same day first and after the acceptance of the technical bids by this office, the Financial Bids of the qualified vendors will be opened on 16.04.2025 at 11.00 AM. #### **Terms and Conditions of the Maintenance Contract Service:**

- 1. Maintenance Contract period for all the items is from <u>01-04-2025 to 31-03-2026</u>.
- 2. Maintenance Contract includes repair/ resolution of all hardware related issues raised by the sections from time to time.
- 3. System Engineers must address all computer hardware related issues raised by all the sections of this office.
- 4. Periodical preventive maintenance, surface cleaning of the computer monitor, cabinets, keyboard, printers etc., will include among other things.
- 5. The contractor shall take corrective and remedial maintenance services to set right the malfunctioning of the equipment.
- 6. This Maintenance Contract amount covers the replacement of all the unserviceable parts/spare parts. This office will procure keyboards, mouse for systems, cartridges/toners/ribbons for printers and batteries for UPS.
- 7. The two resident service engineers deputed shall be present in the office on all working days for full time i.e., 9:15 AM to 5:45 PM. Further, at least one service engineer shall be available to attend the emergency rectification works during the holidays in Exigencies. The following will be the duty charter for attending the maintenance works.
  - a) Complaints received up to 3:00 PM shall be attended on the same day and complaints received after 3:00 PM shall be attended to by 11:00 AM the next day.
  - b) The maximum response time to attend to the complaints shall not be more than 24 hours. Liquidated damages shall be charged @ 2% of the contract amount earmarked for the item for delay in execution of work per day. Decision of the Sr.DAG (Admn) is final to determine the circumstances that caused the delay for the reasons beyond the control of the contractor and exempt from payment of liquidated damages.
  - c) Contractor shall be liable to replace the damaged equipments due to mishandling during repairs/maintenance.
  - d) Repairs/rectifications to the hardware items shall be carried out onsite only. In case of the necessity to take the equipment outside, there shall be standby arrangement for uninterrupted service.
  - e) Minimum stock of important spares shall be maintained in the office premises by the contractor.

- f) Complaints about the functioning of servers, switches, routers and the computers in the chambers of the officers shall be attended immediately.
- g) Technical assistance in arranging all Audio/Video conferences in the office shall be extended by the Engineers to the officials of this office.
- h) Necessary Back up shall be taken whenever attending to the repairs and restore the same after completion of the work.
- 8. Service engineers shall have to attend the break-down calls expeditiously and report to the Assistant Accounts Officer, CEDP immediately after attending/closing the complaint.
- 9. Firm should be willing to take-up all the hardware items listed in Annexure 1 under AMC in toto.
- 10. System Engineers shall have to extend technical assistance to CEDP officials in managing (Adding Printers to CISCO network, installing necessary drivers) the Printers taken on rent-basis, if any, by the Office.
- 11. Maintenance Contract amount will be paid in three equal installments i.e., i.e. at the end of each quarter (quarter starting w.e.f. 01-07-2025)
- 12. Payment will be released after deduction of all taxes in extant viz., Income Tax, GST etc.
- 13. This office reserves the right to terminate the contract prior to the expiry of the contract agreement by giving one month's written notice. However, if the performance of the Service Engineer Firm is not satisfactory, the contract will be terminated by giving a notice of one week.
- 14. In case of any dispute or any differences arising between the parties in respect of this agreement, the same shall be resolved by mutual discussion. The agreement is subject to laws of India and Jurisdiction of courts at Hyderabad only in all matters arising out of or connected to this agreement.
- 15. The Maintenance Contract firm must return the organization's assets on termination of agreement.
- 16. Integrity and security of network services and security of IT assets may be maintained.
- 17. Sharing unauthorized access of network resources will be viewed seriously and action will be taken accordingly.
- 18. The staff of Maintenance Contract must abide to the IT security policy of IA&AD i.e. maintaining confidentiality of usernames and passwords of domains, routers, switches, PC's and Laptops.

19. Using organization assets for outside / fraudulent activities will be viewed seriously.

20. Unauthorized disclosure, modification of data, sending messages/mails for fraudulent

activities will be punishable and attract termination of agreement.

21. The AMC can be extended, if so desired by O/o the PAG (A&E), Telangana based on

the performance of the service provider.
