The condition of the items can be inspected physically between 11 AM to 4 PM on any working day between 28.10.2021 to 10.11.2021 at this office at Plot No. 20 Sector 17 E, Chandigarh-(160017).
- 3. An "Earnest Money Deposit (EMD)" to the tune of Rs. 5,000/- (Rupees Five thousand only) in the form of crossed Demand Draft/Pay Order/Banker's Cheque drawn in favour of "PAO, O/o PR.
