### Essential Parameters:

Only those bids as submitted by bidders will be considered for technical evaluation, which has fulfilled the following Criteria:

- i) OEM which have authorised dealer (who have franchise with OEM in past three Financial years i.e. from 01.04.2021) in Tri-city (Chandigarh, Mohali, Panchkula) can participate in this tender. Relevant certificate / document must be submitted by the bidder
- ii) The bidder firm should be registered under the Companies Act, 1956 or as amended from time to time or an LLP firm / Proprietorship firm / Partnership. firm under the Partnership Act, 1932 or amended from time to time. The Company should have existed in India for at least the last 3 years as of the bid submission date.
- iii) The bidder should not be under liquidation, court receivership or similar proceedings, and should not be bankrupt. The bidder will have to submit an undertaking to this effect with the bid.
- iv) OEM and bidder should be in profit for the last 3 financial years. Balance Sheet duly certified by CA should be attached for reference.
- v) Bidder should have ink signed and stamped authorization in original from the OEM (Original Equipment Manufacturer) who should have executed similar work and supporting PO copy, completion certificate to be attached along with technical bid of Furniture Technical Bid.
- vi) Annual turnover of bidder should be minimum Rs 100 Lac or more during last three financial years duly attested by Chartered Accountant should be enclosed. Annual turnover of the OEM should be minimum Rs 800 lacs or more during last three financial years duly attested by Chartered Accountant and OEM/bidder should be in profit for last 3 years.
- vii) The bidder/OEM should have supplied and installation/commissioning of similar product i.e. compactor to Govt. deptt. / Govt. offices during preceding 3 financial years (i.e. current year and three previous Financial Years) as on opening of bid, as per following criteria:
  - Single order of at least 35% of the estimated bid value. or
  - Two orders of at least 20% each of the estimated bid value. or
  - three orders of at least 15% each of the estimated bid value.Satisfactory Performance Work certificate issued by respective Buyer organization for above orders should be uploaded with bid. In case of bunch bids, the Category related to primary product having highest bid value should meet this criterion.
- viii) OEM must have (from NABCB/QCI accredited Labs or from any IAF accreditation bodies which have lab in India and verifiable on website) ISO 9001:2015, ISO 14001:2015, ISO 45001:2018/18001:2007, IAQ Gold certificate / Green Guard by UL / CII Green Pro certificate (valid certificate being issued by valid source should be submitted) for the product in the range storage respectively.
- ix) Following quality assurance tests with test certificates are required. Note: All tests may be verified if representative from this office visit the factory.
  - a. Concentrated functional load Test (for compactor)
  - b. Uniformly Distributed load test (for compactor)
  - c. 1000-hour salt spray test (for metal components)
  - d. DFT test (50 microns minimum) (for metal components)
  - e. Flammability test report
- x) OEM must have In-house manufacturing and In-house testing capability. Bidder must provide notarized certificate of same.

- xi) Bidder must submit a comprehensive list of machinery, with documentary proof in the form of invoices. Machines may be verified if representative from this office visit the factory.
- xii) OEM or bidder must have Minimum 1 years' experience in the field of supplying compactor certified by IAQ Gold certificate / Green Guard by UL / CII Green Pro certificate. Bidder must submit documentary proof of the same.
- xiii) In case of authorised channel dealer, the bidder should be associated with the OEM for at least last three Financial years i.e from 01.04.2021, relevant certificate / document must be submitted by the bidder or material billed from OEM invoices, the document must be signed by the OEM.
- xiv) Product brochures to be submitted along with the bid documents. and the same quoted product/s should be available on OEMs' website.
- xv) Dedicated/Toll free Telephone no. of Bidder/OEM should be provided on OEM/firm letter head. The same may be checked by the office.
- xvi) OEM / Bidder should have authorized service centre in Tricity (Chandigarh, Mohali & Panchkula) with valid toll free number.
- xvii) The cumulative rates quoted shall be inclusive of Supply, Installation, Testing, Commissioning, Training, and all applicable taxes.

Note: Estimated bid value is Rs. 2,14,00,000/-.
