NOTICE INVITING QUOTATIONS FOR DISPOSAL OF UNSERVICEABLE ITEMS/ SCRAP

Sealed quotations are invited from **established scrap dealers** for bidding suitable price in respect of **old unserviceable items/scrap (Approx. weight 2500 kg.) on "as is where is basis"**. The sealed quotations may be submitted to the General Establishment Section, Room No.114 on all working days by 4.00 P.M. **up to 15th Sept 2021**. The quotations will be opened in presence of intending vendors.

Terms & Conditions

(a) Bidders may visit this office for inspection of items from 8th September 2021 to 14th September 2021 between 3.00 to 5.00 PM on all working days (except Saturday, Sunday & holiday), if required and satisfy themselves of the items they are bidding for. No disputes regarding the form, nature or quality of items shall be entertained.

(b) The quotation submitted after the due date and time shall be rejected. Quotation must be clear & legible, duly signed by authorized signatories. Any addition / alteration/ overwriting / correction etc. must be signed by vendor / his authorized signatory.

(c) Rates should quoted per kilogram. **The items will be sold to the highest bidder.**

(d) Intending scrap dealer must attach **EMD of Rs.5,000 /-** payable in favour of Principal Accountant General(A&E), Himachal Pradesh, Shimla along with Bids. EMD shall be enclosed in a separate envelope. Bids received without EMD will be summarily rejected.

(e) The EMD of unsuccessful bidder will be returned within 20 working days, no interest will be paid on it.

(f) The successful bidder has to make full payment in advance in the form of Account Payee Demand Draft within **03 working days** from acceptance of rates in favour of Principal Accountant General(A&E), Shimla.

(g) In case successful bidder fails to deposit the DD against full payment before taking Possession of the scrap, the EMD will be forfeited.

(h) The successful bidder shall be required to lift all the items from disposal sites (i.e. Room No.-03&04 of Garton Castle building) within **3 days after payment** of amount at his own cost. On failure to do so, EMD of the bidder will be forfeited.

(i) Items once disposed off to the successful bidder shall not be taken back by this office under any circumstances whatsoever.

(j) The material will be allowed to be lifted between **10.00 AM to 4.00 PM on working days only** from the office as per our award letter.

(k) The labour, transport and other arrangements will have to be made by the bidder at his risk, cost, and responsibility.

(l) Each page of the quotation will be signed and stamped by the authorized signatories and incomplete and unsigned quotations are liable to be rejected.

(m) **Notwithstanding the above, The Principal Accountant General(A&E), Himachal Pradesh shall reserve exclusive discretion to accept or reject any bid offer without assigning any reasons.**
