2. SCOPE OF WORK:

The selected Agency/ Firm shall be responsible to provide comprehensive annual maintenance of a II AC units. The comprehensive AMC will include:

- Wet Service of all Air Conditioner Units once in quarter
- · Periodical preventive maintenance

- · All repairs (including Compressor)
- All spares (including Compressor and plastic parts)
- \cdot Gas filling in all cases including at the time of replacement of compressor, shifting, of oute r units etc.

3. Validity of the contract:

The Annual Maintenance Contract (AMC) shall commence from the date of award of the maintenan ce contract. The annual maintenance contract shall be valid for a period of one year from the date of award of contract. However, the contract may be extended for a further one year on mutual con sent on at the same rates and same terms and conditions.

DGA (Infrastructure), however, reserves the right to terminate the contract by giving 15 days notic e without assigning any reason thereof.

4. Eligibility conditions:

- a) The agency/firm should have its registered office in Delhi.
- b) The agency/ firm should have experience of at least 3 years in the relevant field and must be do ing such services for various departments of Government of India/State Government/Public Sec tor Undertakings/ statutory bodies/.
- c) The agency/ firm should be registered under GST/PAN/TIN (copy to be attached).
- d) The agency/ firm should have a minimum turnover of Rs. 6.00 lacs per year during the last thre e years (2021-22, 2022-23 & 2023-24).
- e) The details of inputs/ information required to be submitted by the agency are listed in the forma t for Technical Bid (Annexure-J).
- f) The details of current and previous clients are to be submitted by the agency incorporating the f ollowing details:
 - I. Name of Office
 - II. Contact Person (Tel No./ Email ID)
 - III. Period and volume of work with the manpower deployed
- g) The agency/ firm must have workshop/service station for AC maintenance in Delhi/NCR Region. The bidders are required to attach self attested photocopies of GST/PAN card and ITR for last t hree years. Certificate w.r.t. working for at Govt. Departments/ PSU's/ Statutory Body for last t hree years. Failure to submit any of these documents will lead to rejection of bid document.
- h) Since the volume of AC's are of Hitachi & Voltas Make to be covered under the AMC, the bidder who is authorised service provider shall be considered preferably. The bidder shall submit Auth orised Service Centre Certificate from Hitachi/Voltas /its distributed partners.
- i) Preference will be given to the Firm which is ISO 9001 Complaint.

- j) The bidders have to visit he premises and assess the requirement before bidding.
- k) The successful bidder shall have to submit the assessment report of all AC's to be considered under AMC of DGA (Infrastructure).

5. Responsibility of the Firm/ Agency:

- a) The AMC shall be Comprehensive. The maintenance contract shall cover Replacement of parts by genuine/ branded parts (including compressors and plastic parts) by the contractor at its own cos t as and when required.
- b) The quoted amount shall include all repairs and replacement of parts including the Compressor, cooling coils and plastic parts;
- c) All complaints must be attended to within one hour and the machine is made functional immedia tely, within six hours of receipt of calls on all working days. After that period of time, Rs. 300/-pen alty per day will be charged. In case the service provider fails to attend the complaint, due to urg ency, the services of an outside vendor will be availed by the DGA (Infrastructure), Delhi on pay ment basis, and the service provider will be liable to reimburse the amount to DGA (Infrastructur e), Delhi or the amount shall be deducted from the payment due to the service provider.
- d) In case the AC unit is not repairable within the Office, the same shall be carried to agency/firm's workshop at its own expenses with written permission of competent authority; the contractor will provide a <u>Standby AC</u>. DGA (Infrastructure), Delhi will not pay any charges for standby AC and wil I not be responsible for any damage occurred in the standby AC.
- e) The units carried to the workshop shall be repaired/made functional and returned to the office wit hin three days failing which DGA (Infrastructure), Delhi shall be free to impose penalty @ Rs. 300 per day;
- f) It shall be responsibility of the Firm to hand over the AC units (under contract) to this Office or th e agency engaged by this office for the purpose in working condition at the expiry of the Contract
- g) During the validity of the contract, the company will render preventive maintenance services of the equipment at the frequency of at least once in every month. The AC s will be thoroughly cleaned, tested, repaired and kept in good working condition all the time incl uding body repair/ painting whenever required. In case the machine is idle for replacement of the parts, the company will replace the parts in reasonable time which in any case will not be more t han 24 hours from the time of registration of complaint.
- h) Repair of compressor will be undertaken in workshop of original manufacturers of the compressor so as to ensure the originality of the AC's.

- i) The contractor will attend to all the calls from DGA (Infrastructure), Delhi on all working days. The urgent and unavoidable calls are also to be attended before and after the usual office time and also on holidays. However, reasonable time would be allowed for the specific jobs on merits. DGA (Infrastructure), Delhi reserves the rights to decide any job as urgent or unavoidable depending u pon the nature and venue of the job. The Service Provider Firm is liable to attend the maintenanc e job on holidays in case of urgency too.
- j) All maintenance/ repair work has to be attended within 24 hours of the complaint by the authoriz ed person(s).
- k) The noise level of the AC's should be kept/maintained at acceptable standard level/decibels.
- I) Successful firm will be required to start working immediately after award

of the contract.

- m) A schedule for the monthly monitoring visit as part of the preventive maintenance service should be developed at the beginning of the AMC period and it has to be strictly followed.
- n) The service provider will ensure that there is no loose cable, hanging board, naked live cables etc
- o) It shall be responsibility of the Firm to hand over the AC units to DGA (Infrastructure), Delhi under contract in perfect working condition on the expiry of the Contract period.
- p) The number of ACs are liable to increase or decrease during the period of contract due to new Pu rchase or condemnation at any time during the CAMC period. After completion of warranty period , the new AC's would be included in the contract automatically. Payment of CAMC for such cases would be made on proportionate basis.
- q) The vendor services shall include the installation of the New AC's during the contract period if des ired by the DGA (Infrastructure), Delhi. The vendor services shall also include replacement/reloca tion of existing AC's.
- r) The Bidder must have a Dedicated /Toll Free Number for Service Support. The Bidder must provi de a Single Point of Contact during the AMC period as follows:

Name, Address, Phone Number, Email id.

7) Submission of Quotation:

- a) The technical and financial bids must be submitted separately on GeM Portal.
- b) The successful firm will have to execute an agreement with DGA (Infrastructure), Delhi within seven days of issue of work order.
- c) Commercial/Financial bids of only those bidders whose technical bids are

acceptable/ qualified will be opened.

- d) The Tender is not transferable. The Contractor shall not sublet, transfer or assign the contract or any part t hereof.
- e) The firm should deploy the skilled workers for maintenance and repair of the Air Conditioners.
- f) The bidder shall submit all the Annexures for compliance and evaluation of the bids.

8) Payment:

a) Payment to the selected agency shall be released on half yearly basis i.e. 50% after six months f rom the date of taking over the charge of AMC and balance 50% on completion of AMC. The cont ractor will submit the bill to Director (Admin.). Payment will be made on the basis of satisfactory work certificate issued by the section In charge of Admin. The final 50 % payment shall be done after handing over all machines in perfect running condition.

9) Validity of Tender/Quotation:

- a) Rates quoted by the Firm shall remain valid for 120 days from the date of the opening of the ten der.
- b) TDS and any other Government levies as applicable shall be deducted on the bill Amount as per GOI instructions issued from time to time.
- c) DGA (Infrastructure), Delhi reserves the right to accept or reject any or all the Tenders.
- d) DGA (Infrastructure), Delhi reserves the right to cancel the Contract at any time during the curre ncy of the Contract without assigning any reason, whatever, the services provided by the firm ar e found to be unsatisfactory.
