Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.
- 2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्तें</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्तें is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.

TERMS AND CONDITIONS FOR HIRING OF VEHICLE

- 1. Office of the Principal Accountant General (Audit), Nagaland, Kohima, intends to hire 1 (One) SUV/MPV/MUV vehicle for office use w.e.f. 01/08/2023.
- 2. The vehicle is proposed to be hired for an initial period of 8 (Eight) Months (on daily basis) with the option of extending it for a further period of one year at the discretion of the Office of the Principal Accountant General (Audit), Nagaland, Kohima.
- 3. The Vehicle offered should be one of the following:
 - Mahindra Scorpio
 - Toyota Innova
 - Mahindra Bolero

4. Eligibility Criteria

- (i) The applicant Contractor should be owner of at least 2 (Two) vehicles at the time of making application for the contract and should produce evidence to that effect.
- (ii) The contractor should be based in the State of Nagaland and the vehicle registration number should be of the state of Nagaland.
- 5. The vehicle proposed to be hired out to the O/o the Principal Accountant General (Audit), Nagaland by the applicant contractor should not have been manufactured before 1st of January 2022 and further the vehicles should not have run for more than 10,000 kms.
- 6. The rate should be specified (inclusive of Service Tax) for 2,000 kms (reckoned from place of reporting to place of release) & 330 hrs. on monthly basis (reckoned from time of reporting to the time of release) of vehicle. The charges for additional hours after 330 hours and additional distance after 2,000 km. per month should also be specified in the rate. The hourly rates should also be specified in case any vehicle is required on Sunday (Kilometrage on

Saturday/Sunday/Closed and Gazetted Holidays will be included in the monthly limit of 2,000 kms)

- 7. Contractor shall provide dedicated vehicle & driver and any change in vehicle and / or driver should be made only in very exceptional circumstances. Replacement of the vehicle/driver should be provided in the event of a breakdown of vehicle/non availability of driver. The driver should be having Transport Licence, with a minimum experience of 5 years and their antecedents should be duly verified by police authorities, at the instance of the contractor.
- 8 The vehicle shall be deemed to be at the disposal of O/o the PAG (Audit), Nagaland during the period of official use and the billing for kms and hours shall be made from the reporting place to the relieving place. In certain cases, where relieving place is not the ordinary place of reporting, the ordinary place of reporting shall be deemed to be relieving place.
- 9. The liability on account of fuel, driver & all expenses relating to maintenance, insurance, parking, toll etc. of the vehicle would, solely and wholly, be the responsibility of the contractor and O/o the PAG (Audit) Nagaland will not bearany liability apart from the hiring charges.
- 10. The contract between O/o the PAG (Audit) Nagaland and the Contractor can be cancelled with a notice period of one-month form either side, without assigning anyreason.
- 11. The Contractor should be registered with the authority concerned of State or Central Government, and should fulfill the conditions prescribed in Section 66 of Motor Vehicle act, 1988 for hiring of vehicles.
- 12. The Earnest Money Deposit (Refundable, if the bid is not successful) of Rs. 25,000/- (Rupees Twenty-Five Thousand only) in the form of Cash/Demand Draft/Bankers Cheque in favour of DDO O/o the Principal Accountant General (Audit), Nagaland payable at Kohima has to be given.
- 13. The contractor will indemnify for loss/damage of property or life because of negligence of driver or poor maintenance of vehicle or due to an accident.
 - 14. In case of non-compliance of the above terms and conditions of contract,

a penalty may be levied. The penalty for some of the defaults is as under: -

- 15. The drivers employed along with the vehicle should satisfy the following conditions:
 - a) Drivers should have minimum 5 years of experience of driving. They should have vehicle Transport Licensees for driving passenger vehicles on hire.
 - b) Drivers should be decently dressed. Preferably wear light coloredshirt with dark trousers and black/ brown shoes.
 - c) Driver should be well versed with the roads and the places in Kohima City and should have experience in city driving.
 - d) Once the driver has been allotted to a particular vehicle, he should remain with the same vehicle for a period of at least 1 year. Any change in the designated driver should be intimated to the concerned officer 24 hours before such change is affected.
 - e) Driver should be provided with a mobile phone.
 - f) Driver should be decent and well behaved and should not have any criminal cases against him and should not have any past history of accidents.
 - g) Car should be kept clean and odour free, suitable for official use.
- 16. In case of vehicle breakdown, a substitute vehicle shall be provided by the contractor immediately. In case vehicle does not report within the reasonable time or does not report at all, O/o the PAG (Audit) Nagaland would have a right to hire a vehicle from the market and the additional cost incurred by O/o the PAG (Audit) Nagaland will be borne by the Contractor. In case,

neither a substitute vehicle is provided nor a vehicle is hired by O/o the PAG

(Audit) Nagaland, proportionate contract charges are liable to be deducted from

the contract charges payable. This would be in addition to the penalty levied as

indicated in para 14.

17. The bid once submitted shall not be allowed to be withdrawn and the

defaulter after acceptance of the bid shall be deemed to be non-compliance of

terms of contract and would render security deposit liable to forfeiture and

penalty as the case may be.

18. Tenders will be opened on 14/07/2023 at 11:30 AM. in the chamber of

Sr. DAG (Audit), O/o the Principal Accountant General (Audit) Nagaland on

GeM.

19 The successful bidder shall provide details of the vehicle and also present

himself for signing the agreement, as and when called for, and also physically

produce the vehicle for inspection within a reasonable period mutually agreed

upon.

20. The vehicle should report for duty on 01/08/2023. In case the vehicle do not

report for duty on 01/08/2023, the payment shall be made on a pro-rata basis

depending upon the date of reporting of the vehicle.

21. The O/o the Principal Accountant General (Audit) Nagaland, Kohima

reserves the right to accept or reject any part of the tender or whole tender,

without assigning any reason.
