Firms/Persons interested to buy the aforesaid vehicle are required to submit their highest quotations in the enclosed Proforma, addressed to the Principal Accountant General (A&E), Office of the Principal Accountant General (A&E), Nagaland, Kohima or submit the same to the office from 10 A.M to 1 P.M upto 30/06/2021. The quotation received will be opened by the Tender Committee at 11 A.M on the same day i.e., 30/06/2021. The vehicle is available for inspection from 10 A.M to 1 P.M on all working days from 23/06/2021 to 30/06/2021.
3. The interested Bidders may submit their bid application along with an Earnest Money Deposit of Rs. 5,000/- by way of Demand Draft in favour of "Sr. Accounts Officer", Office of the Principal Accountant General (A&E), Nagaland, Kohima.
4. The quotations received in time will be opened in the chamber of the Deputy Accountant General (A&E), Nagaland, Kohima. The Bidders or their representatives (not more than one) may be present, if they so desire, at the time of opening of quotations.
5. The auction will be governed by the following conditions: -
  - i. The successful bidder will be required to deposit the balance bid amount after deducting earnest money of Rs. 5,000/- latest within one week of opening of bids by way of Demand Draft in favour of "Sr. Accounts Officer", Office of the Principal Accountant General (A&E), Nagaland, Kohima.
  - ii. The delivery of the sold vehicle will be given only after the successful bidder submits the documentary evidence in support of residential status (Aadhaar Card / Voter ID in case of individual and Registration Certificates in case of firms etc.,)
  - iii. The sold vehicle shall have to be removed by the successful bidder immediately at his own expenses.
  - iv. The vehicle will be disposed off on "as is where is basis" and no guarantee for its worthiness or quality will be given by the Department.
  - v. The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously. The Department will not be responsible for any lapse on his part in this regard.
  - vi. In this regard the successful bidder will submit an affidavit for taking over the vehicle and must ensure that issues (legal, social and any other) if any arises on use of vehicle with old registration number till transfer of RC, this office will not be responsible for that.
  - vii. The successful bidder shall not be allowed to withdraw his bid, failing which his earnest money will be forfeited.
  - viii. The competent Authority [Principal Accountant General (A&E)] reserves the right to accept or reject any / all of the quotations without assigning any reason.


