Sealed quotations, should be duly superscripted 'Quotation for Supply, Installation and Maintenance of UPS and addressed to the Director/Admin./Eastern Railway, 14, Strand Road, New Koilaghat Building (5th Floor), Kolkata-700001. The quotation may be sent by post/hand so as to reach latest by 16.03.2023 at 15:00 hrs. Quotation received after stipulated date and time shall not be entertained.
- 3. The contract will consist of Supply, Installation and Warranty for three years.
- 4. Conditional quotation will not be accepted. The Purchase Committee reserves the right to negotiate amongst all L-1 bidders, in case of multiple L-1 bidders.
- 5. The quotation should be neatly typed. No erasure or overwriting will be permissible/allowed.
- 6. A copy of terms and conditions duly signed by the tenderer in token of having understood and agreed to the same may be attached along with the tender.
- 7. Rates may also be quoted for released UPS on buy back basis.
- 8. Delivery will be made within seven days from the date of issue of Supply Order.
- 9. Payment will be made on successful commissioning of the UPS.
- 10. No advance payment will be made.
- 11. Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry.
- 12. The Director General of Audit, Eastern Railway, Kolkata reserves the right to cancel the contract without assigning any reason.
