BACKGROUND, SCOPE OF WORK AND INSTRUCTIONS TO BIDDERS

1.1 Introduction

The Principal Accountant General (A&E), Meghalaya, Shillong, plans to select service provider for change management of Voucher Level Computerization (VLC) package in its office. The decision for purchaser shall be final to select service provider for placing the work/purchase order OR not to select any service provider at his/her discretion.

1.2 Background of Existing Project This department has an Application, Voucher Level Computerization (VLC) running in Oracle 11g

with Linux Operating System. The VLC Application is developed using Oracle 11g Application with Oracle 11g database. There are 2 separate Servers fur running this Application i.e. Database server, Application server and Backup Server. The servers are running with Red HAT Linux (Version 5.6) Operating System.

Presently, this department is receiving the following electronic files in .xml format from the IFMS portal. After downloading the files, these are stored in a folder and then transfer to VLC server by using freeware software "TOAD". Initially these data are saved in a temporary files with the help of the TOAD software and then import into actual table of VLC database by using

- 1. A.G. Receipt (salary, Deduction)
- Bill Details (voucher wise detailed information)
- 3. Bills Abstract (Major Head parameter wise consolidated figures) CDA Master (ChequeDrawal Authority master)
- 5. CDA Receipt Abstract
- CDA Receipt Detailed

TOAD import/export utility

- 7. Department cheque Abstract (consolidated cheque payment figure for Works and Forest)
- 8. Department cheque Detailed) 9. PLA (Personal Ledger Account) Master
- 10. PLA Receipt Abstract
- 11. PLA Receipt Detailed 12. Treasury Receipt Detailed
- 13. Cash Account Payment (Treasury wise LOP figure)
- 14. Cash Account Receipt (Treasury wise Cash Account figure)

After completion of importing process, data are made available in the following modules for verification/checking:

Treasury Module

List of Payment and Cash Account (summarized data)

Compilation module

- Voucher compilation
- Schedule maintenance
- Challan compilation

The existing system will continue to function till the proposed change management system is completed in all respect, output verified by the user and accepted. It will also have to be ensured that user interface i.e. look and feel and user operations at front end remain same.

5.	Checking of Performance of the Server and full load and manage performance tuning
6.	Ensure the Printing and all other normal VLC and GPF application is functioning smoothly in production environment with Full load of Users
7.	Configuration of the backup server as per business continuity plan
8.	Any other activity required to run the application in live environment as it being currently run on the existing server
9.	Provision for automatic creation of backup files (oracle dmp files) in external storage media for backup and provision for transfer of backup data to off-site location electronically at pre-determined time intervals through FTP or other suitable methods.
10.	Interface to upload electronic data of Budget in Budget module of the VLC database from electronic data to be received from State Treasuries through IFMS
