TERMS AND CONDITIONS FOR OPEN PUBLIC AUCTION OF UNSERVICEBALE/OBSOLETE COMPUTER HARDWARE ITEMS

- 1. The prospective bidders/firms can inspect the computer articles/items Pr. AG (A&E) Himachal Pradesh, Shimla-3 on any working day between 10:00 to 15:00 hrs except Saturday & Sunday up to 31-12-2020 from the date of publication of the notice of auction on website and CPPP portal.
- 2. Principal Accountant General (A&E) Himachal Pradesh, Shimla or his nominee will reserve the right to place the items either in lot or lots of unit or as a unit.
- 3. All the participating bidders will have to deposit Rs. 3,000/- as security in advance with the committee before the auction.
- 4. Items are strictly to be sold on "As is where is" basis.
- 5. The bidders/firms must satisfy themselves on all the points before bidding. No guarantee can be given. Interested parties can inspect the items. Items will be sold on the assumption that the bidder(s)/firms has/have inspected the same and know what they are buying whether they have first inspected it or not.
- 6. Bidders will have to produce the proof relating to registration as per e-waste rules with the Ministry of Environment and Forest or Central Pollution Control Board or H.P Pollution Control Board.
- 7. The attorneys, brokers and other persons authorized to act as agent to bid, on behalf of their clients or principals, shall be bound to disclose the full name and status of their clients or principals and shall furnish such information and documents as may be required under orders of the Competent Authority.
- 8. All offers will be subject to the approval of the Competent Authority or his nominee and the offer will remain open until they are accepted or rejected.
- 9. The successful bidder will be required to pay 25% amount of the bid value in cash on the spot at the fall off hammer.
- 10. The balance 75% of the purchase money/bid must be paid in Cash or in shape of Cheque/Bank Draft within two (02) days after final acceptance of the bids. Upon receipt of full payment, gate pass to lift the material from office premises will be issued by GE Section.
- 11. If the bid is subsequently not accepted by the Authority, the deposit made by the bidder shall be refunded to him without interest. The decision of the Authority shall be binding and not liable to be challenged.
- 12. In case the successful bidder fails to make payment as specified above within the time laid down for the purpose, or within extended time as may be allowed, the amount of 25% deposited by him at the time of auction will be forfeited.
- 13. All items will lie on the spot entirely at the risk of purchaser from the time they are knocked down and must be removed/cleared within two (2) days after receipt of full payment. Successful bidders will arrange necessary equipment/labour at their own for lifting of the items/materials from office premises.

- 14. Municipal dues, Excise, GST etc. if any, will be required to be paid by the purchaser on the material liable to such charge.
