- **3.** Tenderer should quote rate on **09** items separately in the same quotation. Bid price should be **inclusive of all taxes, levies, delivery charges etc**. No subsequent upward revision in rate(s) shall be accepted by this office. The bid price of each item should be commensurate with the prevailing market rate for such items. Bidders are requested to visit the office to see the installation places on ground floor, 1st floor and 2nd floor of this office and quote the rate required for the items stated in Annexure-II.
